Partnership Between ICANN and NIC.br Grows Stronger

I was honored to be invited by [NIC.br](#) to participate in the [IX Fórum Regional](#) held on 12 July in Goiânia, Brazil. The IX Regional Forum is a platform for dialogue among participants of the Brazilian Internet Exchange Points (IXP). The large infrastructure created by NIC.br is composed of 30 IXP's and was named [IX.br](#). IX.br points are deployed in 30 cities all over Brazil, offering reduced costs to network operators due to traffic rationalization and higher performance for the end user. This initiative is very

important for the Brazilian Internet ecosystem because of the large number of small and medium ISP's present in almost every municipality (figures estimate over 5,000 operators). ICANN's partnership with NIC.br and IX.br is strong and fruitful. Since 2003, 14 L-root instances were installed and hosted in IXP's strategic locations around the country. We would like to highlight our appreciation for the smart investment of funds and competent personnel dedicated by NIC.br on this initiative.

In the new phase of this partnership, we had the opportunity to engage in direct talks with IX.br participants. We engaged in important discussions about the KSK rollover, Universal Acceptance (UA), and participation in the Internet Service Providers and Connectivity Providers Constituency (ISPCP). In the months of June and July, we visited the cities of Teresina, Belo Horizonte, and Goiania. We also reached out to over 300 AS operators and discussed these important ICANN community topics with them.

More than 300 People Come Together to Discuss Regional Internet Governance Priorities

The 11th edition of the Latin America and Caribbean Preparatory Meeting for the Internet Governance Forum (LACIGF) was held from 31 July to 2 August in Buenos Aires, Argentina. The LACIGF is a space for multistakeholder dialogue in which the civil society, technical community, academia, and private and public sectors, present and discuss their perspectives on Internet governance.

The LACIGF agenda, developed by the regional Internet community, was made up of more than 10 sessions that included the following topics: data protection, net neutrality, digital economy, and community networks.

ICANN62 Readout in Montevideo Brings Regional Leaders and Community Together

The ICANN62 Readout was held in Montevideo in July, where LAC regional leaders reviewed policy developments and important topics debated at ICANN62. The readout was livestreamed and connected to different hubs in Latin America and the Caribbean. Participants from Uruguay, Mexico, Brazil and Bolivia, and other countries, engaged in discussions on the impact of the European Union's General Data Protection Regulation (GDPR) on the WHOIS system, the Expedited Policy Development Process (EPDP), and other important policy developments. ICANN Board members Lito Ibarra and León Sanchez participated in these discussions, while a total of 66 people attended the session.

POLICY UPDATE

GNSO Council Launches EPDP on the Temporary Specification for gTLD Registration Data

On 19 July 2018, the Generic Names Supporting

Organization (GNSO) Council commenced the GNSO's first Expedited Policy Development Process (EPDP): the EPDP on the Temporary Specification for gTLD Registration Data. The EPDP must be completed within 12 months of the implementation effective date of the Temporary Specification (25 May 2018), which was an interim measure to bring existing WHOIS obligations in line with the European Union's General Data Protection Regulation (GDPR) requirements. The Council **voted** to pass the EPDP **Initiation Request** and then adopted the EPDP Team **Charter**. The Council also appointed Kurt Pritz as the Chair of the EPDP team, following a unanimous recommendation from the selection panel. While the EPDP team has limited membership composition, the wider ICANN community can closely follow its deliberations and provide input through various channels.

Study Group on the Use of Emoji as Second-Level Domains Begins Work

Following an [ICANN Board Resolution](#), the study group was established by the Country Code Names Supporting Organization (ccNSO) Council to provide the country code top-level domain (ccTLD) community and the Council with:

- A comprehensive overview of the issues associated with the use of emoji as second-level domains.
- Current practices by ccTLD managers who allow emojis as second-level domains.

Although the terms of reference were adopted in February 2016, the study group started its work following ICANN62. Further details about the background and scope of activities of the study group can be found [here](#).

The study group has participants from diverse backgrounds and is made up of members from the broader ccTLD community, the Security and Stability Advisory Committee (SSAC) - who will participate in an individual capacity, and ICANN staff from the Office of the Chief Technology Officer. The study group is expected to present its findings to the broader ccTLD community and ccNSO Council by ICANN64.

IGO-INGO Access to Curative Rights Protection Mechanisms PDP Submits Final Report to GNSO Council

On 9 July 2018, the International Governmental Organization and International Non-Governmental Organization (IGO-INGO) Access to Curative Rights Protection Mechanisms Policy Development Process (PDP) Working Group submitted its **Final Report** to the GNSO Council. The Final Report contains five consensus recommendations. Since October 2012, the Governmental Advisory Committee (GAC) has issued advice on the topic of IGO identifier protections. Several inconsistencies between the GAC advice and PDP consensus recommendations have yet to be reconciled, including on the topic of appropriate protections for IGO acronyms. The Council **determined** to review the PDP Final Report with a view toward facilitating the resolution of the outstanding inconsistencies between existing GAC Advice and prior GNSO policy recommendations on the overall scope of IGO protections. In the meantime, the Council informed the ICANN Board and the GAC that the PDP Working Group has completed its work.



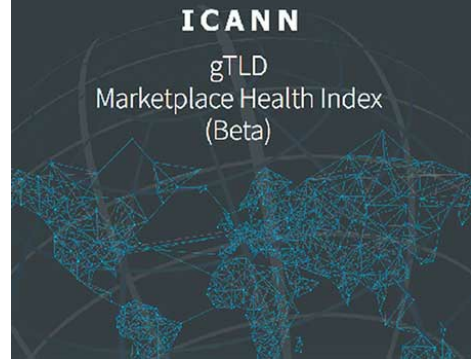

On 20 June, the ICANN org published an update to the gTLD Marketplace Health Index which presents statistics and trends related to generic top-level domains (gTLDs).

The ICANN org plans to publish these statistics twice a year to track progress against its goal of supporting the evolution of the domain name marketplace to be robust, stable, and trusted.

Expanding IDNs in South Asian Scripts

On 10 July, the Neo-Brahmi Generation Panel (NBGP) held a well-attended meeting in Dhaka, Bangladesh in collaboration with the Bangla Academy (the relevant government-run language organization) to discuss the current draft of the Proposal for Bengali Script Root Zone LGR with local stakeholders. This event was the last in a series of workshops and meetings organized by NBGP in Bangladesh, India, Nepal, and Sri-Lanka to finalize the work on relevant Root Zone Label Generation Rules for Bengali, Devanagari, Gujarati, Gurmukhi, Kannada, Malayalam, Oriya, Tamil, and Telugu scripts.

Available for Comments - Recommendations for Managing the Internationalized Domain Name (IDN) Variant Top-Level Domains Report

The ICANN community is encouraged to provide feedback during the public comment period for the Recommendations for Managing Internationalized Domain Name (IDN) Variant Top-Level Domains (TLDs) report that opened on 25 July. This report was developed in addition to the adopted RZ-LGR procedure and presents ICANN's proposed set of recommendations for the variant management mechanisms for TLDs. It will be finalized based on community input and is anticipated to be presented to the ICANN Board in March 2019.
