

# **EDITORIAL**

# ICANN's Five Year LAC Strategy Report Highlights Increased Regional Engagement

The Latin American and Caribbean (LAC) region's participation in ICANN processes grew tremendously in the last five years. What started as a few stakeholder meetings during ICANN Public Meetings, grew into formalized sessions during those meetings, including the LAC Space and the newly formed LAC Session on Policy Development Processes (PDPs). Similarly, the level of awareness about ICANN improved significantly, due to regional events and outreach efforts that encouraged the participation of new voices in the region.

# ICANN at the International Telecommunications Union (ITU) 2018 Plenipotentiary Conference

ICANN President and Chief Executive Officer Göran Marby spoke at the opening of the International Telecommunications Union (ITU) 2018 Plenipotentiary conference (PP-18) in Dubai, United Arab Emirates. Every four years, this conference brings together representative governments and members from telecommunications, information and communication technologies (ICT) and academic institutions from all over the world to decide the ITU's course of action for the next four years. Decisions taken during this meeting have direct effects on how the world of communications will evolve, impacting the way billions of users communicate on a daily basis.



The security, stability, and resiliency of the Internet remain paramount for ICANN's work to ensure a global, interoperable Internet for all. ICANN's engagement with all stakeholders and organizations, including the ITU, is an important part of our commitment to raise awareness and enhance opportunities. ### **ICANN65** Fellowship Round Now Open

The Internet Corporation for Assigned Names and Numbers (ICANN) is now accepting applications for the ICANN65 Fellowship Program. This round is open only to those who have previously completed an ICANN Fellowship because ICANN65 is a Policy Forum. The meeting is from 24-27 June 2019 in Marrakech, Morocco. The deadline to apply is 14 December 2018.

<u>ICANN's Fellowship Program</u> seeks out individuals who are interested in, or already engaged in, the various aspects of ICANN's work in policymaking, the operation of the Domain Name System, and the security and stability of the global

Internet. The goal of the program is to strengthen the diversity of the multistakeholder model by fostering opportunities for individuals from underserved and underrepresented communities to become active participants in the ICANN community.



# LAC ACTIVITIES & HIGHLIGHTS

### **Registry Training in Brazil**

São Paulo hosted the 2nd meeting for LAC Registries on 30 November 2018. Jointly organized by ICANN's Global Domain Division (GDD) and Global Stakeholder

Engagement (GSE) teams, the full day of activities reviewed the most important aspects of registry operations, opportunities for participation in policy development, and a strategy workshop organized by the Brand Registry Group (BRG). ### ICANN's 5th Edition of the LAC DNS FORUM Engages With DNS Industry Stakeholders in São Paulo

The fifth annual Latin American and Caribbean (LAC) DNS Forum was held in São Paulo, Brazil on 29 November with the theme "New Technologies and Digital Security". The LAC DNS Forum brings together industry, Internet policy, and technical professionals interested in discussing DNS-related issues. The forum also provides an opportunity to engage and

network with key players and experts in the field.

It was jointly organized by Abrahosting, the Latin American and Caribbean ccTLDS Organization (LACTLD), the Latin American and Caribbean Address Registry (LACNIC), the Internet Society (ISOC), the Public Interest Registry (PIR), and the Internet Corporation for Assigned Names and Numbers (ICANN).

# First Internet and Entrepreneurship Forum Held in Monterrey, Mexico

ICANN was pleased to work with LACNIC, LACTLD, ISOC, ALAI, NIC Mexico, and Google to organize the first International Internet and Entrepreneurship Forum from 8-9 November 2018 in Monterrey, Mexico. The Forum was part of the Entrepreneurship Festival (INCmty) held each year in Monterrey, Mexico since 2012.

ICANN's regional vice-president, Rodrigo de la Parra, moderated a panel on Internet infrastructure and also spoke on a panel entitled "Digital Transformation of Latin America, Challenges, and Perspectives". ICANN's Cyrus Jamnejad spoke about the domain name ecosystem and the new gTLD program during a panel on the digital presence of brands. The full Forum was video streamed and remote participation was strong.

# **POLICY UPDATE**

# TLD-OPS Disaster Recovery and Business Continuity Planning

Starting in September, the Expedited Policy Development Process (EPDP) Team on the Temporary Community

ICANN | ccNSO

volunteers under auspices of the TLD-OPS Steering Committee are currently drafting a playbook containing basic concepts for disaster recovery and business continuity specific to ccTLDs. During a collaborative session at ICANN63, TLD-OPS organized an in-depth discussion focused on the various aspects of disaster recovery. Participants discussed detection, activation, analysis of incidents, and action and communications planning. One of the takeaways from the workshop is the need to develop a ccTLD playbook to assist ccTLD registry and DNS operations. A draft of the playbook should be presented at ICANN64. #### At-Large Advisory Committee (ALAC)/At-Large Update

The <u>At-Large Review Implementation Working Group (ARIWG)</u> has made significant progress on the first ARIWG Milestone Report, due in December 2018.

The At-Large Advisory Committee confirmed endorsement of candidates and alternates for the 2019 ICANN Academy Leadership Program at ICANN64. The candidates represent a regionally diverse group of leaders interested in developing their knowledge of ICANN and Internet policy.

The <u>At-Large Consolidated Policy Working Group (CPWG)</u> has held weekly calls since ICANN63. Highlights of those discussions include: improvements to the At-Large advice development process; updates about the Expedited Policy Development Process (EPDP) on the Temporary Specification for

gTLD Registration Data, and current ICANN public comment proceedings. Steve DelBianco from the Business Constituency presented on the **Unified Access Model**.

ALAC and At-Large community members took part in the <u>Internet Governance Forum 2018 in Paris</u>, <u>France</u>. <u>The European Regional At-Large Organization also signed a memorandum of understanding</u> with the Council of European National Top-Level Domain Registries (CENTR), agreeing to collaborate on areas of mutual interest.



# EPDP Team Publishes Initial Report for Public Comment

The Expedited Policy Development Process (EPDP) Team on the Temporary Specification for gTLD Registration Data published its Initial Report for <u>public comment</u>. The Initial Report includes the EPDP Team's proposed responses to the charter questions. It also includes their preliminary recommendations and specific questions concerning the purposes of processing registration data, required data processing activities and terms, and updates to other consensus policies. Commenters are strongly encouraged to use the input <u>form</u> to provide feedback. The public comment period is scheduled to close on 21 December 2018.

#### **GNSO Council Update**

The Generic Names Supporting Organization (GNSO) Council reconfirmed one of its original candidates and nominated two additional primary candidates as the GNSO representatives for

the third Accountability and Transparency Review (ATRT3). These three candidates are: Wolfgang Kleinwächter (reconfirmed), Patrick Kane, and Osvaldo Novoa. The GNSO Council also named four additional nominees to be considered should additional places be available.
