

New ICANN Learn Course: Constructive Dialogue

ICANN is built on a foundation of conversation and respect. Fundamental to those qualities is the ability to engage in constructive dialogue. It is not merely about speaking or listening; it's about engaging in dialogue that enlightens, expands, and advances a goal.



The new Constructive Dialogue course explores interpersonal communication techniques so that learners develop constructive dialogue skills.

In this course, learners explore foundational concepts, work through examples, and have access to quick reference guides to put tools into action. Participants gain insight into ensuring all persons in the ICANN community feel heard, narrowing relevant issues, and facilitating

productive conversations.

LAC ACTIVITIES & HIGHLIGHTS

Technical Engagement Grows in the LAC region

In July 2020, the ICANN LAC team completed 18 virtual sessions with major Internet associations in the region. Four different programs were deployed with the Mexican National Association of Universities and Higher Education Institutions (ANUIES), Brazilian Association of Internet and Telecommunications Providers (ABRINT), Paraguayan Internet Service Providers Association (ASISPY), and the Bolivian Traffic Exchange Point (PIT Bolivia). During these sessions, ICANN covered topics such as Domain Name System (DNS) fundamentals, DNS abuse, Domain Name System Security Extensions (DNSSEC), and participation in ICANN processes. These sessions are expected to run on a biweekly basis until the end of 2020. In August, the .br Information and Coordination center (NIC.br) will be added to the group of coorganizers with two sessions on DNS infrastructure. We would like to thank all of our partner organizations for inviting their members to participate in the sessions. The Internet and COVID-19: A Caribbean Focus

Caribbean Internet organizations have been active in developing capacity during the COVID-19 pandemic.

Here is a recap of the latest work done by Caribbean organizations to spark conversations on how the pandemic is impacting the Internet:

- The American Registry for Internet Numbers (ARIN) worked in partnership with The
 Caribbean Network Operators Group (CaribNOG) on a weekly webinar series, "COVID-19
 and the Caribbean Internet," which explored the evolving impact of the COVID-19
 pandemic on a broad range of topics in the Caribbean focused on infrastructure, security,
 access policy, and best practices.
- The Caribbean Telecommunications Union (CTU) and ARIN's webinar series titled
 "<u>Accelerating 21st Century Government in the Caribbean</u>" examined how information
 and communications technologies like the Internet can be used to accelerate the
 deployment of e-government projects in order to improve the efficiency of services for
 Caribbean citizens.

Universal Acceptance, A Work in Progress

Universal Acceptance aims to improve the Internet user's experience by allowing navigation in local languages and by enabling the creation of new affordable domains in the Domain Name System (DNS) market.

In this spirit, the Brazilian Association of Software Companies (<u>ABES</u>), a pioneer in Latin America in addressing Universal Acceptance (UA), is working in partnership with Mark Datysgeld, a local member of the Business Constituency.

ABES' first venture into the topic was the 2018 study "Universal Acceptance in Brazil: Proof of

Concept" which demonstrated that Brazil had very similar levels to the rest of the world for accepting e-mails with non-ASCII characters on their largest websites.

Given the success of the first publication and the community's wide acceptance of our methodology, we were invited by ICANN to do a test at a global scale in 2019. This improved methodology ended up enabling another series of local studies, making a meaningful contribution to the understanding of Universal Acceptance today.

In 2020, we look forward to working on a project analyzing open source software and the evolution of HTML5 standards.

GETTING TO KNOW YOUR ICANN COMMUNITY



María del Carmen Denis Polanco (Mexico) IXP Project Director Yucatan, Mexico Co-founder and Coordinator of the Center for Women in Technology, Mexico

Carmen has a degree in computer science and 26 years of experience in network interconnection technologies, IT

infrastructure, and the Internet. She is currently the project director of the IXP Yucatan, and coordinator of the Center for Women in Technology in Mexico. In 2020, Carmen has actively collaborated with ICANN's regional team by supporting and coordinating events, including two workshops at Internet Development Week in Yucatan in March and the planning of seven monthly ICANN webinars with the Universities and Higher Education Institutions (ANUIES). ICANN67 was her first ICANN meeting.

Her work with the Internet started in 1994 as a Fellow at the Autonomous University of Yucatan (UADY), where she worked until April 2019. Currently, she works on Internet development topics such as IPv6, Internet Exchange Points (IXPs), Resource Public Key Infrastructure (RPKI), and DNSSEC with associations from Mexico, the Latin American, and Caribbean communities, such as the Internet Society, the Latin American and Caribbean Internet Address Registry (LACNIC), NIC Mexico (NICMX), Group of Network Operators in Mexico (MEXNOG), and the University Corporation for Internet Development (CUDI).



POLICY UPDATE

The EPDP Phase 2 Final Report is Now Available

The Expedited Policy Development Process on the Temporary Specification for gTLD Registration Data Team (EPDP Team) finalized and submitted its **Phase 2 Final Report** to the Generic Names Supporting Organization (GNSO) Council on Friday 31 July 2020. The



Phase 2 Final Report focuses on the deliberation of the creation of a system for Standardized

Access/Disclosure (SSAD) to nonpublic registration data; issues noted in the Annex to the Temporary Specification for gTLD Registration Data ("Important Issues for Further Community Action"); and, issues deferred from Phase 1 (also referred to as Priority 2 items), such as redaction of city field, etc. Following delivery of the Final Report to the GNSO Council, the GNSO Council is expected to consider it for adoption at its September meeting.

ccPDP4 Begins

The Country Code Names Supporting Organization (ccNSO) working group to develop policy recommendations for the deselection of Internationalized Domain Name (IDN) ccTLD strings (ccPDP4) will kick off its work at the start of September. The results of ccPDP4 will replace the IDN country code top-level domain (ccTLD) Fast Track Process, which has guided the selection process of IDN ccTLD strings since 2009. The At-Large Unaffiliated Individual Mobilization Working Party has launched with the goal of reviewing At-Large unaffiliated individual membership criteria and participation. This group will guide At-Large leadership in how best to engage these members.

GNSO Council Holds an Extraordinary Meeting about Work Prioritization

On 16 July 2020, the GNSO Council held an extraordinary meeting to discuss its new method of work prioritization based on specific programs and timeframes. The Program Management tool and Action Decision Radar (ADR) aim to assist the GNSO Council in managing a multitude of projects, as well as prioritizing actions based on their importance and urgency. LACRALO Statement on Latin America (LAC) Regional Strategic Plan for FY2021-2025

On 17 July 2020, the At-Large Advisory Committee (ALAC) endorsed the Latin American and Caribbean Islands Regional At-Large Organization (LACRALO) **statement** on the Latin America (LAC) Regional Strategic Plan for FY2021-2025. LACRALO agreed that the LAC regional strategy is consistent with end user challenges in the region. The statement included specific comments on the following four subtopics: security of the Domain Name System, the ICANN

multistakeholder model, unique identifier systems, and regional geopolitics.

UASG Welcomes Six New UA Ambassadors

The Universal Acceptance Steering Group (UASG) has welcomed six new individuals into the UASG Ambassador Program for FY21 (July 2020-June 2021). These new ambassadors have a wide range of expertise and experience in the domain name industry, IT, engineering, software development, and technical research, and will help support UA efforts in Benin, India, Nigeria, South Africa, and Turkey. The UA Ambassador Program now has a total of 13 ambassadors from nine different countries representing the



Asia Pacific (APAC), Europe, Middle East, and Africa (EMEA), Latin America and the Caribbean (LAC), and North America (NA) regions.

Have you Experimented with ICANN's Lookup Tool That Leverages RDAP?

Since last year, the Registration Data Access Protocol (RDAP), developed by the technical community in the Internet Engineering Task Force (IETF) as a replacement for the WHOIS protocol, has been delivering domain

name and Internet identifier registration data in a secure and structured manner.
