## EDITORIAL



The Latin American Telecommunications Congress (CLT) is the most important forum for public policy and information and communications technology in our region. The fourth [CLT16](#) assembled political authorities, senior executives, members of the technical community and academia, and international experts from the digital ecosystem.

CLT16 has provided a forum for debating the most important issues in the industry and for building a common agenda. It's clear that we require new regulatory framework for the digital ecosystem. We need more investment in telecommunications networks, more

spectrum, more commercial flexibility, better quality of service

and user protections, more infrastructure competition, lower tax burdens, more public-private partnership. We live in an era of convergence, which forces us to rethink our policies and regulatory frameworks. We must establish new rules if we want to maximize the potential benefits for consumers and if we want all players to be able to compete on equal terms.

**Latin America has undergone a digital revolution and faces both challenges and opportunities in closing the digital divide and moving from Internet consumption to Internet production.**

Networks and telecommunications services are the most advanced infrastructure in the Latin American and Caribbean (LAC) region. We can move toward the information society if governments, regulators, companies and international organizations have a shared agenda and work hand in hand.

We have the talent, creativity and entrepreneurial spirit to build a single digital networked economy. In this economy, we can implement public policies that encourage the development of Internet content, applications and services - from the region, for the region and for the world.

## IANA STEWARDSHIP NEWS

### NTIA Report Update

In last month's [IANA Stewardship Transition Proposal Assessment Report](#), NTIA evaluated the transition proposals against the COSO internal control framework. The COSO framework aligned with the U.S. Government Accountability Office's recommendation for how NTIA could enhance its review.

NTIA's [COSO Assessment](#) was favorable. Of the 70 areas assessed, only 11 received a yellow rating (partial compliance), and there were no red ratings (noncompliance).

## Preserving the Security, Stability and Resiliency of the Internet

ICANN and Verisign have completed discussions and negotiations for the Root Zone Maintainer Services Agreement (RZMA).

The RZMA is intended to maintain stable, secure and reliable operations of the root zone for direct root zone management service customers (registry operators, registrars and root server operators). The security and stability of the Internet's domain name system is also maintained, due to an extension of the .com Registry Agreement that coincided with the term of the new RZMA.

Over 70 individuals met in Helsinki for a full-day meeting of the Cross Community Working Group on Enhancing ICANN Accountability (CCWG-Accountability) to begin introductory discussions on Work Stream 2. Joined by many other participants via Adobe Connect, the group started conversations on each of the nine [Work Stream 2 topics](#), ranging from diversity across ICANN to the role and function of the Ombudsman. Many participants presented their views on specific topics of their choosing by hosting five-minute "lightning talks," which sparked many healthy debates throughout the day. Co-Chair Thomas Rickert concluded the meeting by praising the group's accomplishments and recognizing that it had a clearer path to developing its Work Stream 2 Report.

## LAC ACTIVITIES & HIGHLIGHTS

### **Webinar: Mitigation Plan for LAC Region**

Earlier this year, ICANN decided to move ICANN56 from Panama City, Panama, to Helsinki, Finland, and ICANN57 from San Juan, Puerto Rico, to Hyderabad, India. ICANN's Global Stakeholder Engagement team drafted a mitigation plan to alleviate the negative repercussions from the decisions. On 16 June, the team hosted a webinar and outlined the plan.

Areas of focus include:

- **Local events.** Identify key events in the region and provide additional engagement opportunities for our LAC community.
- **Regional and global events.\*** Provide additional support for people in the LAC region to attend: LACNIC-LACNOG, LACTLD Workshop, LAC DNS Forum, LACIGF, Caribbean IGF and Global IGF.
- **Remote hubs.** Organize strategic remote hubs in the region for ICANN56 and ICANN57.
- **Webinars and read-out sessions.** Coordinate webinars leading up to ICANN56 and ICANN57 and read-out sessions afterward to debrief the community on highlights of the meetings.
- **Leadership presence.** Identify events in the LAC region where the presence of the ICANN leadership (CEO, Executive Team) and other experts would benefit the region (e.g., LAC DNS Forum in August 2016).

From 21-23 June, the Organisation for Economic Co-operation and Development (OECD) held its Ministerial on the Digital Economy in Cancún, Mexico. This year's Ministerial focused on the effect information and communications technologies have on economic and social structures, and the role an open Internet plays in generating growth and innovation. ICANN's CEO Göran Marby participated in the panel "Economic and Social Benefits of Internet Openness." He spoke about the importance of safeguarding the Internet for everyone, the need for global diversity in Internet policymaking and the unique nature of the multistakeholder approach.

Over the past 20 years, the OECD, with 34 member countries, has built a reputation for intelligent and authoritative discourse on the digital economy and the Internet. The OECD held the first Ministerial on the Information Society in 1998 in Ottawa, Canada. At the second Ministerial in 2008 in Seoul, Korea, the group agreed on high-level principles for the Internet. At this event, the technical community was formally recognized as a stakeholder, and took a seat at the table with business, trade unions and civil society.

### Now Available! New Findings About the gTLD Market

A global study has found that awareness and trust of generic top-level domains (gTLDs) continue to increase. Wave 2 of the Global Consumer Research Study measured current consumer attitudes towards the gTLD landscape and the Domain Name System (DNS). The study also assessed changes in consumer attitudes from the first wave of the study in 2015. Nielson conducted the research for ICANN. ### DNSSEC Validation: What's It All About?

When you've ever used the Internet to look up something up, you've relied on the Domain Name System, or DNS, to provide give you with the information you requested. Domain Name System Security Extensions (DNSSEC) is a security technology called Domain Name System Security Extensions (DNSSEC) developed to protect Internet users against attacks that can result in forged DNS responses. DNSSEC validation ensures that DNS information hasn't been modified during transit.
