Dear Friends,

A year full of challenges has started - requiring more and more of our commitment and participation. We are fortunate to be an active region and to have many opportunities to participate. LACTLD is pleased to be part of the council of ICANN's Latin America and Caribbean Strategic Plan.

In the country code top-level domain (ccTLD) community we have a busy agenda. There will be two ICANN meetings in our region, both in countries with members of our organization. We took advantage of this situation and decided to accompany them with two of our three workshops. One of our goals is to strengthen and facilitate the participation of our ccTLDs, particularly in the processes of the Country Code Names Supporting Organization (ccNSO).

We will hold our Commercial Workshop alongside the ICANN meeting in Puerto Rico, and our Policy and Legal Workshop alongside the Panama meeting. We will also have our Technical Workshop in September, together with the meeting of the Latin America and Caribbean Network Information Centre (LACNIC).

In support of these efforts, ICANN has granted our organization three scholarships for the Panama meeting. These scholarships will allow three of our members to participate as Fellows, something for which we are grateful.

We have several projects underway this year together with ICANN. The Internship Program, enables our region's ccTLDs that have fewer resources to be trained with the help of other ccTLDs that are in stages of greater maturity. Another important project that we will continue to support is the Domain Name System (DNS) Observatory, a project initiated by ICANN and NIC Chile.

From LACTLD we wish you a great year and we hope to find you actively participating in the activities that bring us together.

Prepare for ICANN61!

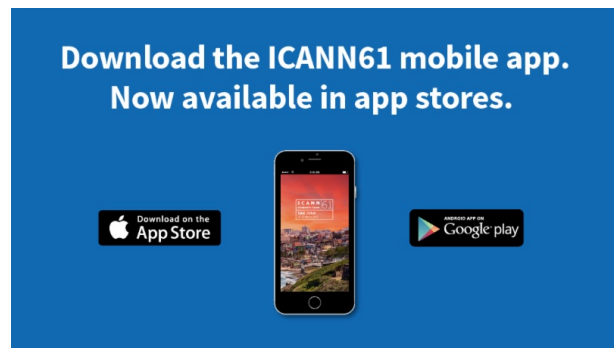
San Juan, Puerto Rico, 10-15 March 2018

ICANN61 kicks off in just five days. The meeting website is now available in both English and Spanish, and features the final schedule, mobile phone app, and pre-meeting reports.

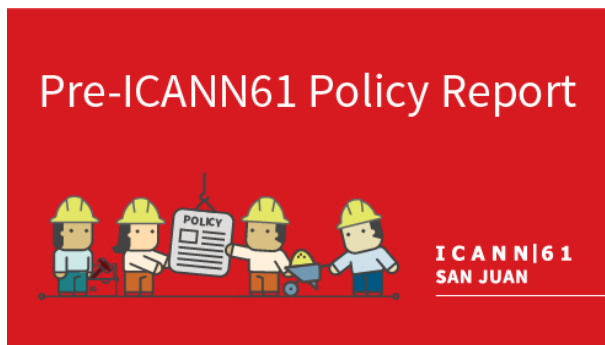

Montevideo Regional Office Holds First All-Hands Meeting in Saint Lucia

Did you know that the Montevideo office is one of ICANN's regional offices? Ten members of the ICANN organization are attached to this office, working in Uruguay or remotely in Argentina, Bolivia, Brazil, Costa Rica, Mexico, Nicaragua, Peru, and Saint Lucia. Their roles are diverse - they come from Global Stakeholder Engagement, Policy Development Support, Communications, and Language Services.

This all-hands meeting was the first of its kind with the participation of all 10 people (attending in person and remotely). The meeting was held in Saint Lucia on 15-16 February 2018.

Call for Experts - Study the Application of Root Zone Label Generation Rules

ICANN is forming a technical group to study how to apply the Root Zone Label Generation Rules (RZ-LGR) for Internationalized Domain Name (IDN) country code top-level domains (ccTLDs) and IDN generic top-level domains (gTLDs). The study group will be composed of technical subject matter experts from various groups, organizations and committees. [See announcement for details.](#)



Universal Acceptance

Universal Acceptance Steering Group (UASG) - Microsoft Announces New Expanded Support

Universal Acceptance (UA) is a foundational requirement for a truly multilingual Internet. Email Address Internationalization (EAI), which allows email addresses to use local scripts, is an important part of this process and a core component of the UASG's work. The UASG created resources, including the [Quick Guide to EAI](#), to help companies with EAI efforts. Recently, UASG member company [Microsoft](#) made another step forward in EAI when it announced support for email addresses in 15 Indian

languages across its email apps and services, including Office 365, Outlook 2016, Outlook.com, Exchange Online and Exchange Online Protection (EOP).

GNSO Council Decision Underscores Commitment to Empowered Community

The Generic Names Supporting Organization (GNSO) Council recently adopted modifications to the GNSO Operating

Procedures that add GNSO voting thresholds for certain Empowered Community-related decisions. The changes are effective immediately, and aim to ensure the GNSO can fulfill its roles and responsibilities as a Decisional Participant in the Empowered Community. In a related action, the GNSO Council proposed changes to the ICANN Bylaws, which are currently under ICANN Board consideration. [Read more...](#)

GAC Highlights at ICANN61

The Governmental Advisory Committee (GAC) will start ICANN61 with a capacity-building workshop on Domain Name System (DNS) resiliency and recovery in the context of natural disasters.

During the meeting, the GAC will review topics such as:

- Two-character and country and territory codes at the second level
- Protections for international governmental organizations
- Independent Review Process Panel
- Policy development process and cross-community working groups
- General Data Protection Regulation
- New generic top-level domain subsequent procedures

The GAC will meet with the Generic Names Supporting Organization, At-Large Advisory Committee, Country Code Names Supporting Organization, and the ICANN Board.

At-Large News

Proposed Changes to ICANN Meetings

The At-Large Advisory Committee (ALAC) ratified a policy advice statement on the **Proposed Incremental Changes to the ICANN Meetings Strategy** that recommends:

- Community Forum: no changes
- Policy Forum: at least five days for outreach
- Annual General Meeting: six days plus an additional day for wrap-up activities

At-Large Review

The leadership of the At-Large Review Working Party continues to prepare the response to the ICANN Board Organizational Effectiveness Committee mapping exercise of the At-Large Review. Next steps will be determined at ICANN61.

NARALO at ICANN61

The North American Regional At-Large Organization (NARALO) will celebrate its 10-year anniversary at ICANN61 in San Juan, Puerto Rico. Immediately before the meeting, NARALO will hold the first North American School of Internet Governance (NASIG). [Learn more about NASIG.](#)
