Global Forum for Cyber Expertise Workshop Underlines Need for DNSSEC

Background: On 5 August, LAC Internet stakeholders gathered in La Paz, Bolivia, for a capacity building workshop aimed at creating a more trusted Internet experience in the region. The Global Forum for Cyber Expertise (GFCE) is a global platform where countries, international organizations, and private companies can exchange best practices and expertise on cyber capacity building. The aim of the GFCE Triple-I event is to identify successful policies, practices, and ideas to improve Internet Infrastructure.

ICANN Board member Lito Ibarra and I hosted a workshop in La Paz, Bolivia during the Latin American and Caribbean Internet Governance Forum (LACIGF) in August. Bolivian Vice-Minister for Telecom Iván Zambrana opened the event, explaining that Bolivia has a large territory with a relatively low population facing problems like access to quality healthcare, education, and other basic challenges. He sees the Internet as a good tool to help address these challenges. He confirmed that for the Bolivian people to take full advantage of the Internet, enhancing security is a very important factor. He welcomed the work by GFCE on security as "right on target".

The workshop highlighted the importance of Internet infrastructure standards including Domain Name System Security Extensions (DNSSEC), Transport Layer Security (TLS), DNS-Based Authentication of Named Entities (DANE), Resource Public Key Infrastructure (RPKI), Route Origin Authorization (ROA). E-mail standards like Domain-based Message Authentication, Reporting & Conformance (DMARC), DomainKeys Identified Mail (DKIM), and Sender Policy Framework (SPF) were also discussed. Global and regional experiences with anti-abuse strategies, including the Computer Security Incident Response Team (CSIRT) collaboration, were exchanged. Participants were eager to discuss further implementation of standards and practices.

The workshop was supported by ICANN, Internet Society (ISOC), Latin American and Caribbean Country Code Top-Level Domain Organization (LACTLD), Latin American and Caribbean Regional Internet Registry (LACNIC), Comitê Gestor da Internet no Brasil (CGI), and the Dutch Ministry of Economic Affairs and Climate Policy.

Highlights from DNS Week and LAC DNS FORUM in Puerto Rico

Finding a way to collaborate across barriers was a key theme during **DNS Week** and the sixth **LAC DNS Forum** during the week of 20-23 August. The events were hosted in Puerto Rico and featured a 30th anniversary celebration of the .PR top-level domain.



The DNS Week, hosted by Latin American and Caribbean Country Code Top-Level Domains Organization (LACTLD) and .PR, focused on engagement with Caribbean ccTLDs and announced Guadalupe's the new membership. The week featured innovative events like a "Speed Dating" session to promote participation in ICANN processes and update information from ccTLD operators in IANA systems.

The LAC DNS Forum, hosted by ICANN, explored the importance DNSSEC adoption with the help of our partners. The community discussed new technology trends like DNS-over-HTTPS (DoH) and DNS-over-TLS (DoT), and market trends were presented by two active contracted parties in ICANN processes, Afiliis and Blacknight. ICANN is grateful to the presenters, participants, and partners for this successful event.

ICANN engages with Bolivian Internet Community at LACIGF12

ISOC Bolivia hosted the 12th Latin American and the Caribbean Internet Governance Forum (LACIGF), which took place 6-8 August in La Paz, Bolivia.

The LACIGF12 agenda included topics like freedom of expression on the Internet, Internet access challenges, artificial intelligence, and cybersecurity. More than 300 people attended LACIGF12 in person, more than 1,300 joined remotely, and participants represented 25 countries. Gender diversity was a priority too: women made up 56% of the panelists and speakers and 43% of the on-site participants.

As a main highlight of the event, Raúl Echeberría presented the results of his study: **Review of the Latin America and Caribbean Internet Governance Forum, LACIGF**. The purpose of the study was to gather suggestions from the community to improve the relevance and continuity of the Forum to aid policy development at the regional level.

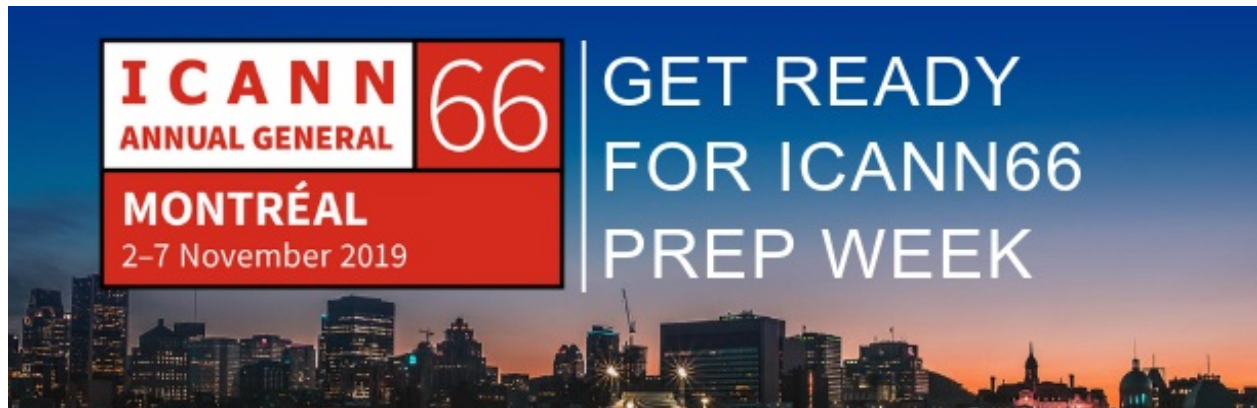

GAC Welcomes Two New Observers

The Governmental Advisory Committee (GAC) recently welcomed two new observers: the Caribbean Community (CARICOM); and the Council of Regional Organisations of the Pacific (CROP) Information, Communication, and Technology (ICT) Working Group.

GAC Focal Group on New gTLDs Subsequent Procedure

Following ICANN64, the GAC launched a focal group to coordinate the GAC's timely input into the final deliberations of the New Generic Top-Level Domains (gTLD) Subsequent Procedures Policy Development Process (PDP) Working Group. This includes recommendations on the Competition, Consumer Trust, and Consumer Choice Review. The GAC's main topics of interest cover areas such as the new gTLDs application process, requirements, evaluation, objections, and string contention.

The focal group met for the first time during ICANN65 and started work on building the capacity of GAC members to navigate the interrelated policy development and implementation discussions on future rounds of new gTLDs. The focal group will meet regularly until ICANN66, when it will brief the GAC on its discussions.

Policy Development for IDNs: ccNSO Next Steps

Country Code Names Supporting Organization (ccNSO) Council Chair Katrina Sasaki sent a [letter](#) to ICANN Board Chair Cherine Chalaby about policies related to the Internationalized Domain Names (IDN) country code top-level domain (ccTLD) Fast Track Process.

In the letter, Sasaki requested the ICANN Board agree to mark a formal end to the second ccNSO Policy Development Process (ccNSO PDP2) on the selection of IDN ccTLD strings and inclusion of IDN ccTLDs in the ccNSO. The ccNSO Council also repeated its request for the ICANN Board to take no further steps to change the current IDN ccTLD Fast Track Process. In the absence of a formal policy, the current process enables countries and territories to request strings for IDN ccTLDs

representing their respective country or territory names in scripts other than Latin. It is the ccNSO Council's firm belief that until a ccNSO policy replaces the IDN ccTLD Fast Track Process, the current process should remain in place.

Once the ICANN Board responds to the recommendations of ccNSO PDP2, the ccNSO Council will launch the fourth ccNSO PDP. The fourth ccNSO PDP will address issues identified by the ccNSO IDN Preliminary Review Team (PRT). This includes outlining the differences between the similarity review and IDN Variant TLD Implementation and streamlining the selection process of IDN ccTLD strings. The ccNSO Council is also preparing a request for changes to Article 10 of the ICANN Bylaws after consultation with the ccTLD community. The changes cover two aspects: an updated definition of ccNSO membership and enabling IDN ccTLDs to become members of the ccNSO.

EPDP Update

Since its meetings at ICANN65, the Expedited Policy Development Process (EPDP) on the Temporary Specification for gTLD Registration Data Phase 2 Team has been reviewing use cases for requestors of nonpublic gTLD registration data. The EPDP Team looked at commonalities among these use cases, to help inform the first iteration of draft policy principles. From 9-11 September, the EPDP Team met in Los Angeles at the ICANN headquarters to deliberate on this first iteration. [Learn More.](#)

GNSO Council Update

Policy Development Process 3.0 (PDP 3.0) is a GNSO Council initiative aimed to enhance the efficiency and effectiveness of the GNSO PDP. Since April 2019, a small team of GNSO councilors has been meeting regularly to develop implementation details for [14 PDP 3.0 improvements](#) that were adopted previously by the GNSO Council. During the 22 August GNSO Council meeting, the team presented its proposed final documents for four completed PDP 3.0 improvements as its first deliverable. Those documents are related to the expectations, requirements, and participation methods for PDP working group members and leaders. The team aims to finalize documents for the remaining improvements by ICANN66. [Learn More.](#)

Besides managing GNSO PDPs, the GNSO Council has been engaged in a variety of projects and activities, including scoping policy work related to Internationalized Domain Name variant TLD management, reviewing Competition, Consumer Trust, and Consumer Choice Review Team recommendations, and responding to the ICANN org request for clarification on data accuracy. At-Large Work Ahead of ICANN66

At-Large is planning a series of activities in support of recent policy statements in preparation for ICANN66. Recently, **ALAC has submitted five policy statements**, including statements on **evolving the governance of the Root Server System** and **Name Collisions**. Also, a geographic names survey is being developed for the At-Large community to identify priorities and potential for consensus on the topic. Other ongoing activities include planning for the third At-Large Summit (ATLAS III) which will be held during ICANN66, continuing the election process for ICANN Board Seat 15, and promoting Universal Acceptance within At-Large, in coordination with the Universal Acceptance Steering Group (UASG).



GDD UPDATE

Start Using the Updated Lookup Tool

ICANN recently launched an updated version of its **lookup tool**. It makes use of the Registration Data Access Protocol - known as RDAP - to query, parse, and display domain name registration data in a human-friendly format. The ability to look up publicly available contact and other information related to a domain name has been provided as a free public service by ICANN since 2013.

RDAP was developed by the technical community in the Internet Engineering Task Force (IETF) as an eventual replacement for the WHOIS protocol. ICANN accredited registrars and registry operators are now required to provide registration data directory services through RDAP in addition to the WHOIS services.

Myanmar Community Tackles LGR Proposal and Outreach

The Myanmar Generation Panel organized a local public consultation on the **Myanmar script Label Generation Rules (LGR) proposal** last month. The event in Yangon, Myanmar, focused on receiving important feedback from the larger community that includes the multiple languages covered by the proposal: Burmese, Karen Sgaw, Mon, Pa'O, Rakhine, and Shan. Attendees included the Myanmar Computer Federation (MCF), Myanmar Computer Industry Association (MCIA), Myanmar Unicode Area, Post and Telecommunications Department (PTD), and UMG Idealab. The Myanmar Generation Panel plans to submit the LGR proposal for Public Comment by October 2019. More information on the proposal can be found [here](#).

Students, along with technical and legal community members, discussed a wide range of topics including Universal Acceptance (UA) of top-level domains (TLDs), the New gTLD Program,



Next Generation of Developers Work Towards a Multilingual Internet

In June, a group of 24 developers with a unique role to play in ensuring the successful expansion of the Internet to non-English speakers, took part in a coding event in Raipur, India. Participants were asked to create a website, web application, or web service that would work with all domain names and email IDs written in languages based on Devanagari scripts (which include languages and dialects spoken by 18 million people in the Indian state of Chhattisgarh). The goal was to address challenges related to Universal Acceptance (UA). The event was hosted by the Internet and Mobile Association of India (IAMAI), with support from the Ministry of Electronics and Information

Technology (MeitY) and the government of India.

Lilian's call to action is for all former Latin American and Caribbean fellows to remain engaged with ICANN's work in order to strengthen the multistakeholder model in the region.
