

Policy Priorities at CIGF-15

The Caribbean Telecommunications Union (CTU) hosted the 15th edition of the Caribbean Internet Governance Forum in Trinidad and Tobago on April 2 and 3. The Prime Minister of Grenada, Ministers from various Caribbean territories, industry, academia, and other diverse regional stakeholders discussed collaboration between Caribbean countries in the information and communication technologies (ICT) sector.

Participants received updates from the IGFs in Barbados, St. Vincent & the Grenadines, and Trinidad and Tobago. Topics debated included affordable Internet access, managing and regulating social media, and data protection and privacy. The CIGF15 also included a workshop on the Caribbean Internet Governance Policy Framework.

Looking to the Future at FutureScape

To promote the vision of a single regional market for ICT in the region, the CTU sponsored the Caribbean FutureScape. The interactive experience was designed to demonstrate the potential a Caribbean single ICT market and encourage Caribbean Prime Ministers to commit to national and regional digital transformation. During the Caribbean Telecommunications Union 30th anniversary celebration, Dev Anand Telucksingh (Trinidad & Tobago), Carlton Samuels (Jamaica), Jacqueline Morris (Trinidad & Tobago), Lance Hinds (Guyana), Bevil Wooding and Nigel Cassimirre (Trinidad & Tobago) were honored for their substantial contribution to Caribbean regional ICT development and representing the region in global forums like ICANN. These Caribbean stakeholders are very active in the ICANN ecosystem, and were recognized for their participation in ICANN's At-Large community.

IX Regional Forum in Curitiba

The Brazilian city of Curitiba hosted the IX Regional Forum on May 31, where Internet Service Providers (ISP), network operators, and other participants discussed regional interconnectivity and development. The ICANN team gave details about the importance of implementing Domain Name System Security Extensions (DNSSEC) and promoted participation in the Internet Service Providers and Connectivity Providers (ISPCP) community. This year, participants were encouraged to follow ICANN Learn courses to better participate during the presentations. ICANN is grateful to our colleagues in Curitiba and INIC.br for the opportunity to participate.

Evolving the Root Server System Governance

In June 2018, the Root Server System Advisory Committee (RSSAC) presented to the ICANN Board and community "RSSAC037: A Proposed Governance Model for the DNS Root

Server System" (RSSAC037). As part of the Board's consideration of RSSAC037, ICANN org prepared a concept paper outlining a community-driven process led by the Root Server System Governance Working Group (GWG) to develop a final cooperation and governance model for the RSS. ICANN org developed a draft charter, operating procedures, and draft work plan for the GWG. RSSAC037, the concept paper, draft charter, operating procedures, and draft work plan for the GWG are available for <u>Public Comment</u>. Provide your input today.

ICANN Board Reviews EPDP Recommendations

On 15 May 2019, the ICANN Board adopted 27 of the 29 Phase 1 policy recommendations from the Expedited Policy Development Process (EPDP) on the Temporary Specification for gTLD Registration Data. The Board did not adopt two of the recommendations in full, where they identified portions of those recommendations that they believe are not in the best interests of the ICANN Community. The Board has initiated the consultation process with the Generic Names Supporting Organization (GNSO) Council. For a number of other recommendations, the ICANN Board noted specific issues that

it expects to be addressed during implementation of the EPDP Phase 1 recommendations or considered during Phase 2. Learn more **here**.



ALAC-GAC Collaboration and ICANN65 Planning

- The At-Large Advisory Committee (ALAC) and the Governmental Advisory Committee (GAC) are
 collaborating on a variety of topics including the Expedited Policy Development Process (EPDP)
 and the submission of joint statements to the ICANN Board. Most recently, this included a joint
 statement on the EPDP. A new focus group, led by Yrjö Lansipuro (ALAC Liaison) and Ana
 Neves (GAC point of contact), will develop capacity building initiatives for both groups.
- For ICANN65, the At-Large Consolidated Policy Working Group (CPWG) is developing talking points and a policy workshop for At-Large members. A pilot on Universal Acceptance is also being developed by ALAC Vice Chair John Laprise for discussion at ICANN65. African Regional At-Large Organization (AFRALO) leaders and At-Large support staff are organizing multiple events for ICANN65, including an AFRALO-AfrICANN meeting, the AFRALO Hot Topics session, and an AFRALO-At-Large networking event. The groups are also working to promote the participation of Rabat University students at ICANN65.

GNSO Update

- Submitted to the ICANN Board a <u>Recommendations</u>
 <u>Report</u> from the GNSO PDP Working Group on the International Governmental Organizations
 (IGO) and International Non-Governmental Organizations (INGO) Access to Curative Rights
 Protection Mechanisms. The Recommendations Report addresses Recommendations 1-4 in the
 PDP Final Report approved by the GNSO Council last month.
- Confirmed Julf Helsingius to serve as a GNSO representative to the Cross-Community Working Group on New gTLD Auction Proceeds, replacing Stephanie Perrin.

<u>Committee</u> (IGLC) to increase participation by country code

WHAT'S NEW IN REVIEWS



Opportunities to Participate: ICANN Reviews and Evolving ICANN's Multistakeholder Model

The Internet Corporation for Assigned Names and Numbers (ICANN) has several opportunities for community input and participation.

Specific Reviews are led by teams of community volunteers to assess the performance of the ICANN organization and make recommendations for improvement.

- Observe the SSR2 and ATRT3 Review Team face-to-face meetings at ICANN65. The second Security, Stability, and Resiliency Review Team (SSR2)is finalizing draft findings and recommendations. The third Accountability and Transparency Review Team (ATRT3) is in the research and analysis phase of the review.

Organizational Reviews are led by independent examiners who assess the extent to which ICANN's Supporting Organizations (SOs), Advisory Committees (ACs), and the Nominating Committee (NomCom) fulfill their purpose, are accountable to their stakeholders, and whether any changes in structure or operations are needed.
