## What's New at ICANN?

One of the most relevant ICANN milestones in the first months of the year was the announcement that the new generic Top Level Domains (gTLDs) delegated into the Internet's root zone topped one hundred. "There are now almost five times more generic Top-Level Domains than there were only a few months ago and that translates to greater consumer choice," said Akram Atallah, President of ICANN's Global Domains Division. In 2013, ICANN launched its Strategy Panels to provide input that will inform ICANN's New Overarching Vision and Five-Year Strategic Plan. The result of the panels' work will be posted and available for Public Comment through April 30, 2014, and will be debated by the community during ICANN 49 in Singapore next March. We would like to underscore the publication of a new report by Boston Consulting Group: Greasing the Wheels of the Internet Economy, which takes a look at Internet access and use around the world, and the economic importance of an open single Internet. ## LAC Strategy Plan Update

We continue advancing the implementation of our Regional Strategic Plan. On this occasion, we want to focus on several ongoing activities within the framework of Project 2 - Communications Plan.

- Fatima Cambrero and Natalia Enciso are helping us with an inventory of ICANN materials on several topics focused on different stakeholders. The idea is to identify those materials that need to be translated into the languages of our region, as well as determine what materials need to be developed from the very beginning. - Dev Anand Teelucksingh and Miguel Ignacio Estrada are helping us develop a website for our region. While Dev is focused on populating the different website sections with content, Miguel and his NIC.ar team are working on the website development and design. Additionally, we keep working in order to increase announcements, blog posts and content developed by ICANN in the languages of our region. We also endeavored to obtain relevant coverage in our regional media (see Regional Media Coverage Highlights below) and continued focusing on social media (our Twitter accounts in Spanish and Portuguese now have 1655 and 67 followers respectively).

## What is Going On in Our Region?

In 2013, work in our region concluded with the signing of a significant agreement in the Caribbean. In the context of the Caribbean ICT Week held in Jamaica, Fadi Chehadé, ICANN President and CEO, and Ms. Bernadette Lewis, Secretary General of the Caribbean Telecommunications Union, signed a Memorandum of Understanding to increase cooperation and coordination among both organizations. The first two months in 2014 were very intense in terms of activities in our region.

Also in connection with the Caribbean, we are pleased to hear that St. Lucia is planning to become the next Caribbean country to launch an Internet Exchange Point (IXP). At ICANN, we have initiated the process to deploy an L-root server copy in this new IXP.

Another highlight in the Caribbean is our participation in the Sixth Regular Meeting of the Assembly of the Inter-American Telecommunications Commission (CITEL), held in Santo Domingo, Dominican Republic, on February 10-13, 2014. Rodrigo de la Parra, our regional VP, joined a panel on Improving Engagement in Multistakeholder Models, together with the governments of Brazil, Mexico and the United States, Google and ISOC, addressing innovation of multistakeholder models, with a special focus on the [Strategy Panel on ICANN Multistakeholder Innovation](#). The Panel's Report is available [here](#).

On February 18 -19, LACTLD hosted a [Marketing Workshop](#) in La Antigua, Guatemala, where Rodrigo de la Parra spoke about ICANN's Communication and Engagement Strategy in our region. The workshop featured the interests of the ccTLD community in relation to marketing topics, and was very well attended by Registries from Argentina, Brazil, Chile, Colombia, Costa Rica, El Salvador, Guatemala, Honduras, Panama and Peru. The agenda included presentations by international Registries, and the experience of a ccTLD as a new gTLD applicant.

Finally, another important development in our region is the organization of the Global Multistakeholder Meeting on the Future of Internet Governance (NETmundial). Earlier this year, the event organizers launched the meeting [website](#) in the six official UN languages and Portuguese, the [expression of interest form](#) to attend the meeting, and the [content contribution](#) section to contribute content on the two topics of the meeting (the Set of Internet Governance Principles and the Roadmap for the Further Evolution of the Internet Governance Ecosystem).
