
SERGIO SALINAS PORTO: I will now initiate today's call. This is our call on March the 13th. Our exact starting time is 23:00 UTC. I will ask Gisella to kindly proceed with the roll call for today's call so that we can then get started with our work for today's meeting.

Gisella, you have the floor. Go ahead, please.

GISELLA GRUBER: Thank you, Sergio. I'd like to welcome everyone on today's LACRALO ccTLD Working Group call on Thursday the 13th of March at 23:00 UTC.

On today's call, we have Sergio Salinas Porto, Aida Noblia, and Aislan Basillo on the Spanish channel.

On the English channel, we have Jacqueline Morris.

We apologies noted from José Arce and Dev Anand Teelucksingh.

From staff, we have Silvia Vivanco and myself, Gisella Gruber.

If I could also please remind everyone to state their names when speaking, not only for transcript purposes, but also to allow the interpreter to identify us on the other channel. Our interpreter this evening is Sabrina. Welcome, Sabrina.

Thank you, and over to you, Sergio.

SERGIO SALINAS PORTO: Thank you, Gisella. I am the chair, in a way, of this Working Group. I hope that we will get to decide who will be chairing and co-chairing this working group, so that we can finalize that formal procedure that we have been postponing. My role, in this case, as a chair, is only for the purposes of putting the working group tasks in order.

With that said, I would like to welcome you all. I would like to welcome Jacqueline on the English channel, and Aida and Aislan on the Spanish channel.

The first item on our agenda following the roll call is to define our task. What is our task? That has to do with what we have been discussing for several meetings now. That is, the objective of this working group.

I took the liberty in February to post something on the wiki. I posted a proposal with objectives, and if I remember rightly, nobody posted anything against that proposal or made any comments.

However, in principle or initially, I will post this in the chat room. My apologies, Jacqueline, because this is in Spanish. However, if you have a browser with automatic translation tools, you will be able to read it. I am posting the link in the AC chat room right now. You will find the objective of this working group, and I am submitting that objective to your consideration so that you can decide whether you agree or not with that objective. I am giving you some time so you can click on the link. I will read it aloud, so that the interpreter can interpret that for Jacqueline.

“LACRALO must have a collective view on the issue of the ccTLDs.” In brackets, as Aida very well said, “A strategic vision on ccTLDs from

LACRALO.” This will not only strengthen the region but also the position of users against the other interested parties or stakeholders.

After that, there are some points in which we establish that we need to do some follow-up with the ccNSO or at least give our opinion of what is said in the ccNSO. Then, we need to prepare a map with the ccTLDs. We have to define our Latin American and Caribbean view regarding ccTLD policy in different countries that have a direct relation with topics that can be debated within ICANN.

We need to pay attention to comments that focus on the regional ccTLDs within ICANN. We have to review any other document or comment within ICANN that focuses on ccTLDs in general.

Generate education and discussion spaces for ccTLDs within LACRALO, create educational spaces for ccTLDs in all the countries in the region. Interact with any and all ccTLDs in the region.

Basically, this is the basic objective of this working group. I will now open the floor to questions and comments, so that you can express your views on this. I don't know if anyone would like to take the floor at this point.

Aida, is that you?

AIDA NOBLIA:

Yes. I was just taking a look at the text. I believe the objective is interesting, but also is quite wide in its scope.

I think it's interesting to include a strategic and regional view, because the strategic component of the view is important to be taken into account, in line with ICANN's strategy, especially.

Regarding the policy, well, we have to relate that to the policy, taking into account that we are dealing with a ccTLD. That is, what is the impact of that? Hence, this component of this strategic view.

I believe that this objective is very wide in terms of its scope. Maybe later on we can narrow it down a little bit. I believe that we have to focus on how to organize our topic as a working group.

This is very well. This text is okay, but it encompasses plenty of things. It's like super-broad. The product of our work will be a follow-up. That is, debate document, pay attention, review document, prepare that map.

Now, when in terms of generating discussion and educational spaces for ccTLDs in LACRALO and that question of interaction, well, we are not going to reach conclusions. If I speak about the strategic component of this vision, it is precisely in order to be able to reach conclusions. That would enable us to analyze existing policies.

This is like a revision of existing documents. It leads to the generation of these educational and discussion spaces. In short, I'm trying to understand the depth of this topic. We have to review documents and we have to study these documents.

Now, if we relate that to a strategic view, then that document that we will be reading and the follow-up of those documents, well, we have to

come up with a strategic view at the end of the day. If not, we might think that we need to determine a strategy and an overarching vision in terms of how to handle ccTLDs in relation to Internet governance. That is, what can be the policy and the strategic view within that regional strategy? That is, what is the role of the ccTLDs in that regional strategy? Maybe it's a little bit different from what you proposed.

SERGIO SALINAS PORTO: I would like to say something in relation to Aida's comment. I will try to explain the objective posted in the AC chat room.

I agree with the fact that we need a collective vision of a regional ccTLD strategy within LACRALO, and I had included that in brackets, because I remember there had been some kind of issue in terms of the strategic vision with Dev. I thought about putting that text in brackets, so as to bring it to a close, because that was an outstanding issue and we hadn't been able to close it.

However, I agree in that this vision has to be a collective or shared vision that is the foundation of a regional ccTLD strategy within LACRALO.

In terms of the rest of the objective, I detailed the aspects that this working group might be able to tackle. On the one hand, they have to deal with in-reach within the region; and outreach, on the other hand. That is, to spread information about ccTLDs from the Internet user perspective in different environments.

On the one hand, we will be studying documents progressively within ICANN, or within another organization related to ccTLDs within our region. On the other hand, at some point in time, we will be able to engage in outreach to build the capacities of others users within our region, in terms of topics related to ccTLDs. That would be the region's objective.

Maybe I enlarged a bit too much upon this and it is very detailed, but that was for the purposes of explaining the idea, or a better understanding of the idea. However, in principle, this is the objective I am proposing for the group.

I don't know if Aislan would like to take the floor. Aislan?

AISLAN BASILLO:

Thank you, Sergio. Just two comments. First of all, I want to say something about Aida's comment. I fully agree with her comment. Sergio, I think your description is really great in that, initially, we didn't have anything about this group. We didn't know our starting point, and now we have our starting point – where we are and where we are heading. I clearly see your perspective, because now we know where we are. We have our starting point. As from this description, we can start.

Sergio, you spoke about in-reach and outreach, in terms of ccTLDs. That input is very valuable for members of our group and our region who struggle to understand that this group could work in terms of capacity-building for users – not only for users, but also for the members within the region. I believe that is very important for this group.

This is a very important starting point for us to help Internet end-users better understand ICANN's mission and goals in the light of ccTLDs. Clearly, we couldn't do what ICANN is doing or developing. I echo Aida's comment.

SABRINA: The interpreter apologizes, but Aislan's audio is not clear to be interpreted at times.

AISLAN BASILLO: Now we know where we are, we know what our starting point is, and now we need to develop this content to know where we're heading. That is, to develop the mission of this working group. We have the broad topics, so we have to focus on the first topics to be developed.

Aida said that, initially, we couldn't tackle the topics that ICANN is tackling. We need a regional vision and we need to spread this knowledge for the sake of our region. Clearly, ccTLDs are related to Internet, to ICANN.

SABRINA: The interpreter apologizes, but Aislan's audio is challenging to interpret.

AISLAN BASILLO: I apologize for my lengthy comment. Thank you, Sergio.

SERGIO SALINAS PORTO: Thank you, Aislan, for your comment. Part of what you said will be tackled when we address item three on our agenda.

There are certain ccTLD-related topics that have been debated within ICANN in the past days and that will come in handy when we tackle item three on the agenda, especially given the forthcoming ICANN meeting in Singapore in the following days.

Jacqueline, I don't know if you want to take the floor at this point in time. I see that you dropped. I hope you have [inaudible]

JACQUELINE MORRIS: [inaudible]

SERGIO SALINAS PORTO: I would like to know if you have any comment at this point in time. Maybe you haven't been able to hear or receive that. I will gladly read what I read out again. Please, go ahead, Jacqueline. You have the floor.

JACQUELINE MORRIS: Okay. You can hear me, right? [inaudible] Are we going to [inaudible]

SERGIO SALINAS PORTO: Jacqueline, we have some issue receiving your audio.

JACQUELINE MORRIS: [inaudible]

SERGIO SALINAS PORTO: Very well. While Jacqueline is typing, I am going to take the floor. Okay, Jacqueline.

We are within a process in this working group. That is, we are defining our objective in order to start working and to avoid later difficulties regarding the objective of this working group.

After this process – and about a month ago, there was a draft objective posted on the wiki for us to discuss. We are meeting today in order to agree on whether we are going to modify that objective. On the other hand, we need to organize our working group in order to start working.

Given your question, that is, that we can take two different directions. That is, one would be to liaise with the ICANN and their ccTLDs and give our input as LAC At-Large – please confirm if this is correct.

This is my answer. This working group has a primary objective. That is, to define a strategy as ccTLD users within the region, but also to discuss the hot topics related to ccTLDs within ICANN. This implies not only our region but the five regions within the parent organization that is ICANN.

What I'm trying to explain is that we will be focusing on both directions. No doubt, one of them will take substantial time, that is, focusing on what is going on in the region. Then, we will have to focus on what is happening at ccTLD-levels in general within ICANN.

I see that you're volunteering, and I thank you, really, because you're volunteering to take care of that part of the work within the group. That would help us tremendously.

If your question has been replied, then I would like to ask you the following. Do you agree with the group's objective, so that we can bring this part of the agenda to a close and proceed with the other items on our agenda?

Okay, you would rather focus on one of them. Okay. Jacqueline, we have an issue there, in my view. Before focusing on general issues, at least we have to know what it is that we want to achieve at a particular level. I don't know if somebody wanted to take the floor.

AIDA NOBLIA: If I may, I would like to take the floor.

SERGIO SALINAS PORTO: Yes, go ahead, Aida.

AIDA NOBLIA: I have so many browsers open that I cannot find what I really want to look at.

You pointed out action items within one overall or global objective. I think that is in line with what we are working on. That encompasses different actions within one topic.

What we see in that text is a sort of detail of actions, so as to focus our objective. That is, what is it that we will be doing? There are certain actions that are geared toward the main topic. That is, what are the ccTLDs? What is the strategy?

I remember there is a document including five ccTLDs. The document was meant to be submitted to the IGF. They are speaking about the responsibilities of the ccTLDs within their local or regional communities. We need to bring to the floor the main role, especially within the DNS.

Here, in this document, they are focusing on the importance of the ccTLDs and the inclusion or integration of the local community, even within Internet governance. All those factors are included.

These actions that you have included in your text will enable us to obtain information data on the document and what is the focus of the document, and how we can handle that or to include it in our regional strategy. I don't know if I have made myself clear.

SERGIO SALINAS PORTO: Yes, of course, Aida. Your point is very clear. No doubt, the regional strategy is very important on our agenda.

However, I believe it would be necessary to consider or take into account how we're going to work regarding the points that we have included.

Please, Jacqueline, indicate if I am understanding you correctly. I understand that Jacqueline's view is that we are having two objectives in our working group and it would not be compatible to focus on Latin America and, at the same time, what is happening within ICANN.

I don't think that is incompatible. I think one of those aspects is included within the other. You say very well that these are two action items. The

points enumerated make up a set of actions that make up a framework of something that we can do within the region. This is the starting point.

The idea was to somehow put forth a set of issues that are related to this topic. On the one hand, an objective, that is to study ccTLDs within ICANN and then have a regional perspective for Latin America. On the other hand, actions that we can take in view of the issues that are cropping up constantly within ICANN in terms of ccTLDs.

The first step for us, no doubt, is to define a strategy for our region. What is our vision? What is the map of the ccTLDs? This does not mean including .co for Colombia or .ar for Argentina. This means a social map, and define how our ccTLDs are working within each of our countries and strive to get to know this operation, especially because not all the members in this group have the same track record experience, if you will. Some of the members of this group are new, and they will have to learn. That is something very good. I don't know, Jacqueline, if I have made myself clear now.

I'm reading Jacqueline's comments. She says that the mission of the LACRALO Working Group on ccTLDs is to define and promote the LAC At-Large perspective at the ICANN ccTLD process. Yes, that will be Jacqueline.

There's a document that has been circulated. Jacqueline, have you been able to have a look at the document?

JACQUELINE MORRIS: [inaudible]

SERGIO SALINAS PORTO: Okay, Jacqueline, what changes would you make to that document?

Jacqueline, would you kindly send us or type it in the chat room a draft text of the objective? That would help a lot for us to bring this point to a close. Then we can proceed with the other items on the agenda. It would be great if you could do that.

Do you all agree with that definition that Jacqueline has posted? Do you all agree with that? Aislan, Aida?

AIDA NOBLIA: Yes.

SERGIO SALINAS PORTO: Go ahead, Aida, please.

AIDA NOBLIA: Yes, I think that is a good definition, because the points are actions points that flow from an objective. Jacqueline is setting the objective when she says, “ccTLDs to define and promote.” In that part, she’s setting the objective.

First of all, we need to analyze this. We need to analyze document. I have different URLs to access documents. This will enable us to have a vision in order to attain our objective. I believe we can leave the objective. I don’t know if you agree with that.

SERGIO SALINAS PORTO: Yes. Aislan agrees, I agree with that. Yes, of course, go ahead then. Let us move forward on the basis of that.

Then, this means that we have finalized this item. We have brought this item to a closed. Let us proceed, because we still have three more items to address. We have just 30 minutes left before we reach the top of the hour, so it would be positive if we could move forward. Thank you, Jacqueline, because you took us out of this point of stagnation, if you will. Thank you very much for your contribution.

The third item on our agenda is election of authorities. Unfortunately, Diego, José, and Dev are not here. That means we do not have all the members of the working group present. However, I would like to resolve this issue, because I don't like to take a position for which I have not been elected. If I am going to take on a responsibility, I would rather accept that responsibility according to the procedures.

Let us define who will be the authority of this group, so that we can start organizing the group.

Regarding Aislan's comment, yes, I agree. We have to post the mission statement on the wiki. Maybe, the prior text can remain as action items to be developed at a later state by the working group. So let us focus on the election of authorities. What shall we do about it?

Jacqueline, your point is very well-taken. I would like to ask staff if we are [inaudible] in order to proceed with the election of the authorities.

SILVIA VIVANCO: Sergio, this is a working group, so this depends on your own mechanisms. It is up to you. If you consider that you have enough people present to make a decision. If not, we should need seven or five people, we should need a majority. But this is a working group, so the decision is up to you.

SERGIO SALINAS PORTO: Silvia, please help me. We have seven members. Diego Acosta Bastida, Aida, José, Dev, Aislan, and myself. That is six members. Oh, and Jacqueline – oh, I'm sorry, seven. Seven members. Is that correct?

AIDA NOBLIA: What about Silvia?

SERGIO SALINAS PORTO: Silvia is not a member of the group. She's an observer. I believe José is also an observer. She's not a member of the working group.

AIDA NOBLIA: Yes, he said he was here as an observer. He's not a member of the group.

SERGIO SALINAS PORTO: Yes. Dev and Diego are members of the group. We are missing two people out of six. What shall we do? Shall we wait for Dev or Diego to join us? I believe that if we have four out of six members present, that is okay.

AIDA NOBLIA: This is a very delicate topic. Sergio, Dev and you were the candidates or the people proposed as authorities. Dev said he was able to perform this function. Dev said he would be able to be elected as an authority. The thing is – or the problem is – that he is not present right now. Your name was also mentioned in prior meetings and you accepted. However, the issue is that Dev is not present. He has said that he would be able to accept his designation.

SERGIO SALINAS PORTO: If you agree, we can solve this in the following way. Dev had already accepted. He had said, “Yes.” The thing is that we were lacking our objective, and we couldn’t proceed with the election of authorities.

Now we have our objective and Dev had initially said yes, so we could resolve this now, and then in our next meeting, Dev can confirm or modify this decision. If he decides not to be the chair, then we can choose another person to fulfill this role, the co-chair’s role. If you agree – Jacqueline says that she agrees, Aislan and Aida are also in agreement.

It is so decided. I am the chair, and Dev will be the co-chair. He will have to confirm this in our next meeting. Are we all in agreement about this?

AIDA NOBLIA: Yes.

SERGIO SALINAS PORTO: Okay, let us proceed with our action items. We have to organize the group. We have to define our work and responsibilities.

This implies being able to work on several topics that are being debated within ICANN. We should start reading about these topics as part of a learning process within our working group, and also, as we had said, we have to focus on issues related to our local ccTLDs.

I insist there are certain topics currently under discussion within ICANN. There was a meeting on March 25, 2014 – oh, excuse me, there will be a meeting, I meant to say. The ccNSO meeting will be held in Singapore. There are certain topics that will be debated on Tuesday. On Wednesday, they will be holding meetings. Some of the topics are posted on the website. I'm going to post their agenda – their schedule – because I believe it's interesting to have a look at these topics that will be...

Excuse me, Jacqueline has posted something in the AC chat room, let me see. Two main things, okay. Oh, Jacqueline, impressive job! You've been doing your homework. Okay, very well, then. Jacqueline is making a proposal, that is, to divide the main topic, important tasks. One, that has to do with documentation and capacity-building, and the other one, putting our perspective, and divide the action points into these two areas. This is what she's proposing. Silvia, please correct me if I am making any mistake, because my English is not very good.

Does anyone hold a different point of view, different from Jacqueline's? I agree with Jacqueline's proposal.

AIDA NOBLIA: Yes, I agree, as well.

SERGIO SALINAS PORTO: Aislan, do you agree with this proposal? That is, to have two types of tasks – one focused on documentation and capacity-building, and the other focused on perspective?

Is Aislan on the call or has he dropped? Oh, I see you now, okay.

Okay. We should adopt this. This is taken from the initial text.

AIDA NOBLIA: Yes, the action points posted by Sergio.

SERGIO SALINAS PORTO: Yes, exactly. My proposal is the following. Let us work on these two aspects or areas. That is, some of us should volunteer to focus on documentation and capacity-building, and some others should focus on topics related to the perspective in Latin America.

However, in turn, we should have some metrics so that this work does not become eternal. Here's my proposal. Does anyone want to be in charge or chair any of these subgroups? Jacqueline, would you like to be in charge of one of these two subgroups?

JACQUELINE MORRIS: [inaudible]

AIDA NOBLIA: Excuse me. I don't know if I may take the floor.

SERGIO SALINAS PORTO: Yes, of course. Go ahead, Aida.

AIDA NOBLIA: I agree with this division, but I think this group is very small. We can focus on these topics in a consecutive order – one first and then the other – at least, initially. I am thinking about this as an initial solution. I have some documents.

SERGIO SALINAS PORTO: Jacqueline says that she would like to work on documentation and capacity-building. I, myself, would like to focus on regional perspective and draft a regional map, and focus our work on – I'm thinking out loud. This was also on the wiki. We could work on – oh, let me see what Jacqueline has typed.

None of us will be going to Singapore except for Dev. He will be there representing us in LACRALO. None of us will be there. I would like to be there but maybe Aislan would like to start focusing on the regional topic. He could chair that subgroup and be in charge of that, accept that responsibility and initially we could have three members in one subgroup and three members in another subgroup. That would enable us to have smaller groups that would resolve more things.

Jacqueline's proposal entails working on these two areas simultaneously, at the same time. That is what I understood.

If Aislan joins me, and Aida, maybe you would like to focus on documentation and capacity-building, maybe we can start by having four members working instead of six.

AIDA NOBLIA:

Okay. I agree, because these are possibilities for the time being. Then, we will be in touch and we can make our contributions to the other subgroup, if we have something to contribute. Yes, we can agree on this division of tasks.

SERGIO SALINAS PORTO:

Okay, Jacqueline. We would have two subgroups. One with you and Aida as members focusing on documentation and capacity-building, and another subgroup focusing on regional perspective in which Aislan Vargas Basillo and myself, Sergio Salinas, would be the members. Do you agree?

Jacqueline said, "Yes." Oh, great! We are making plenty of progress.

Okay, we are just some minutes away from the top of the hour. Please correct me if I am wrong.

SILVIA VIVANCO:

You are correct.

SERGIO SALINAS PORTO:

Okay. We have organized the group. We have defined our work and responsibilities. Now, we will address the topic of temporary metrics.

Yes, Jacqueline, metrics, because this is a new stage within LACRALO. We are trying to avoid a situation in which we fall asleep while things take place or happen. We are trying to set deadlines to submit deliverables with short-term objective instead of eternal objectives, so that we have a minimum of results. We would like to measure that. I don't know if you got the gist of my message, of my explanation.

Okay, Jacqueline is typing. Here's my proposal. Each subgroup should take some time to study what they will be working on. We still haven't focused on concrete aspects of the work of each of the subgroups. Each subgroup will have to prepare or draft a work plan. The work plan will need to have a quantifiable metrics. That is, "We will interview that many people." "We will draft a document on this topic within the next two months," etc.

The idea is to attain objectives related to our work. In my mind, the objectives do not need to be huge but small objectives, attainable objectives. This will enable us to progress.

Therefore, the first stage of our work will be for each subgroup to define what they will be doing. Do you agree with this?

AIDA NOBLIA: Yes.

SERGIO SALINAS PORTO: Aida said yes. Aislan? Okay. Jacqueline? Let me see. Oh, that would be very interesting, Jacqueline. The idea would be to hold a meeting – oh, Jacqueline dropped? Silvia, I believe Jacqueline dropped.

SILVIA VIVANCO: Yes, I believe she has dropped. Maybe let's see if we can dial out to her again.

SERGIO SALINAS PORTO: Yes, great. At least so that she can join us for the last minutes of the call. Jacqueline, regarding your proposal, are you thinking about a joint call with people from the ccNSO within this group in June, or are you thinking about that within LACRALO? Maybe I didn't understand correctly. Do you mean to have a conference call with the ccNSO or enumerate the issues we see within the ccNSO to start debating them?

Oh, great. If that is the case, the discussion will take place within our working group.

Before June, we should enumerate that so that before our meeting in London, we make some progress. It will be good to present, maybe in our GA, the highlights or an update of the progress of this working group, in terms of policies within LACRALO. I think this is a good initiative.

Do you think the group you will be leading will take care of this, or should we all take care of this? That's my question.

Jacqueline is typing. Let's wait a little bit. Okay. She is replying. Her reply is that she thinks it can be divided. I think that with Aislan, in our subgroup we can prepare a situation map of the ccTLDs in the region. We can make some comments, and before June – and this is part of the metrics – we can define that map. If Aislan agrees in these remaining

months, we can work on the development of the current status of the ccTLDs.

I have some news. Until March the 5th, domain names were free-of-charge in Argentina, but now, people have to pay a fee for those domain names. Therefore, the renewal of domain names in Argentina today is no longer today free-of-charge. We have to pay about \$20.00 USD for the .org domains and about \$30.00 USD for the .com domains. That is some information about the ccTLD in Argentina.

If you agree, we will start working on that. We are four minutes away of the top of the hour.

AIDA NOBLIA:

If I may, I have a question regarding capacity-building. What is the meaning of capacity-building in this context? Maybe Jacqueline has that a bit clearer, or maybe we can discuss that within the group.

SERGIO SALINAS PORTO:

You have to discuss that within your subgroup. However, I have the following point to make. Today, I spoke about in-reach and outreach. In-reach, that is, capacity-building within LACRALO.

And outreach, let us start seeing how we discuss ccTLD issues in different places within our continent. We have to start multiplying knowledge among Internet end-users. They have to understand what a ccTLD is, what it is used for, and what their rights are regarding a ccTLD. Initially, let us focus on documentation, and then let us focus on

capacity-building, if you agree. Silvia, if we could have these two action items, please, recorded?

On the one hand, studying topics related to the ccNSO. The deadline for that is the month of June. Regarding the subgroup where Aislan and myself will be working, we will start working on a ccTLD map for Latin America and the Caribbean. Let us hope we finish that in June.

My proposal is to have this on record with the corresponding responsibilities allocated. We have to invite Diego and Dev to join either of these subgroups.

Dev will be traveling. He has a 36-hour journey to Singapore. He will stay in Singapore for five days, at least. Then he will have a 36-hour journey back home. We need to understand his situation. Let us not be very demanding on him. He has to represent us in the ALAC meetings. He works very, very hard, and he will be busy in these coming days. I understand that he will be reading the wiki and he will be taking all this into account.

We have reached exactly the top of the hour, 24:00 UTC. Before bringing the meeting to a close, let me say that we have worked indeed a lot during this call. I'm very, very pleased, and I hope you are as pleased as I am. Please get in touch. I will get in touch with Aislan and Aida will get in touch with Jacqueline.

AIDA NOBLIA:

I have just sent Jacqueline my contact details, Skype and e-mail.

SERGIO SALINAS PORTO: Perfect. Let's hope we will be working together. Aislan, I will be writing to you tomorrow. If I may ask staff to prepare our internal mailing list, thank you – if that could be done, Silvia?

SILVIA VIVANCO: Yes, of course. I will take down the action item, the mailing list, and I will circulate the agreement in English and Spanish. All the decisions made today, I will circulate them among the members of the group.

The next call will take place surely in April, after the meeting in Singapore. If you could, please send me an e-mail about the most-suitable date for that meeting.

SERGIO SALINAS PORTO: Silvia, I know that the first week after the meeting is not feasible, because you need to rest, so I will focus on the second week after the Singapore meeting.

SILVIA VIVANCO: Yes. I suggest the week of April 7th when everybody's back home.

SERGIO SALINAS PORTO: Okay. We will have our mailing list.

I would like to thank our interpreter. Sabrina, today, has had a bit of a challenge, but I really appreciate her work, her job. I appreciate the staff work, of course – Gisella, Silvia, very warm regards. We will be in touch shortly.

It is my birthday on April the 8th, so if we hold a meeting, please remember the birthday present.

SILVIA VIVANCO:

Oh, then it will be perfect for us to hold a call.

Thank you. Thank you very much. You've done a great job. Thank you.
