DEV ANAND TEELUCKSINGH:

Hello Susie? You can start the roll call.

SUSIE JOHNSON:

Thank you. Good afternoon. Welcome to the LACRALO trip CROPP proposal call, this Monday April 14th at 22:00 UTC. Participants on the call are, on the English channel, Dev Anand Teelucksingh. On the Spanish channel, we have Alberto Soto, Leon Felipe Sanchez, Sylvia Herlein.

Staff are Susie Johnson and Silvia Vivanco. The interpreters are Veronica and Sabrina. Please remember to speak – to announce your name prior to speaking so that the recording can have the appropriate information, also speak slowly. Back to you Dev.

DEV ANAND TEELUCKSINGH:

Thank you Susie. This is Dev Anand speaking. Thanks again, thanks for all of you for attending, especially those who are just finishing one call and starting another call. Just to go through the action items. We had a meeting on April the 9th. I'm just going through the action items here. Staff are to obtain the document with the per diem per country.

I think this is a request by Jose Arce. Well, maybe somebody from staff can respond. Was this document located? I'm seeing Silvia typing. Okay.

SILVIA VIVANCO:

This is Silvia Vivanco speaking. I need the interpreters to speak up.

Note: The following is the output resulting from transcribing an audio file into a word/text document. DEV ANAND TEELUCKSINGH:

This is Dev Anand speaking. I hope the interpreters are hearing me properly. One of the action items was from the April 9th meeting was, staff to obtain the document with the per diem per country. I believe this is a request from Jose Arce. So has the document been located? Thank you.

SILVIA VIVANCO:

This is Silvia Vivanco from staff. I requested this document to constituency travel. Unfortunately, I haven't received a reply yet. Jose is also trying to locate this document. And today, we have reiterated this request, and so has Fatima. So, excuse me. And we have two people that are no longer members of this group, that is Jose and Fatima.

But we're still focusing on locating this document. Thank you.

DEV ANAND TEELUCKSINGH:

Thank you Silvia. This is Dev speaking. So, we'll leave that action item for now. The second action item, Alberto Soto to hand the list of persons who received the capacity building sessions in the Dominican Republic and Haiti. I note that Alberto has sent the documents, in an email, and we'll discuss this later in the call. So we can mark that action done.

And then the third action item, Gisella to organize for the next call, which we are now doing, so that's done. Okay. So, the item on the next topic is, the review of the event in Haiti and the review of the event in

the Dominican Republic. So, Alberto did send the email and I'll post the link here to the documents, what Alberto posted. Alberto, do you have any further feedback or updates you want to make to this document?

ALBERTO SOTO:

This is Alberto Soto for the record. No, no. What you have posted is enough. I believe that people in both countries are working, so as to reach out to more organizations. I have been in touch with them, and clearly, you know, attendance is in person. However, maybe we may have some organizations in the interior of the country that can participate remotely.

They can participate online, or using Adobe Connect if we get that soon, or using Skype rather too. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. Well this is Dev. I mean, potentially... I should say, potentially, if you have Internet access, an Adobe Connect room could be made available, which is the LACRALO ALS room, could be made available for this. But, very well. Does anybody have any comments on what Alberto has posted?

SILVIA VIVANCO:

This is Silvia Vivanco speaking. A brief comment. Let us use the wiki to post documents for the sake of transparency, because sometimes we use Google Docs, or we use other tools. So when we have finalized a document and we want to share it with other people, please let us post it on the wiki. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. This is Dev. I understand that. I guess my thinking was, giving our [secret] conversations regarding the topic on the last one, I was thinking that perhaps we kept it to this group just to make sure that, well, we could discuss this more – we can discuss this more and then we post something that we all agree on.

But, certainly we can put this proposal, what Alberto has added to this. And I think Alberto did post it to all of the persons in the group, because this is something that I was requesting regarding details. Does anybody have any comments? Because I have some comments to make, but I want to give the floor to anybody who has any questions or comments.

ALBERTO SOTO:

This is Alberto Soto speaking. Yes. I posted this material. I promised that I was going to do that, and it will before in order to set up a small working group, and have this presentation ready for a certain date that I don't remember. I think it should be the last day of this month, or the first day of the next day. To have this document ready, finalized, and reviewed by all the regions. That's it. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. Thank you Alberto. Okay. So this is Dev. Well then, just to look at some comments, Alberto, regarding the schedule. So for the events in Haiti, I see that the first day of the event was confirmed, and the second day to have a second event, to be possibly [?]. Is it that for the second day, it's going to be repeating the same topics over? That's my question.

Similarly, for the Dominican Republic, you have on the timeline, the first day an event in [?] Santo Domingo, and then on the second day an event in [?] apartment 2478 in Santo Domingo. So, my question is, is the event going to be... Are these repeatable sessions? Is that...? So Alberto, please go ahead.

ALBERTO SOTO:

Alberto Soto speaking. Yes, Dev. In Santo Domingo, in particular, there are at least three organizations, and if we had more organizations, they would be attending these three events. It's three different locations. One of them is sponsoring the event, providing the facilities and different elements, and all of the NGOs that today are three or four, will attend. And maybe by the time of the event, we will have more NGOs.

Then we have an university, and I insist, the presentation is exactly the same. The audience or the public will be made up of university students. And in the third case, most likely taking place in another location, in a private institute, in a college institute, focused on university or college students.

So, so far we have two that have fully confirmed their participation in the Dominican Republic, and one that has fully confirmed participation in Haiti. So we can bring this to a close with two participating in the Dominican Republic, and one in Haiti. And I can let them know that most likely the event will take place, and we will have two in one location and one in another location.

I'm open to your comments and feedback. Thank you.

DEV ANAND TEELUCKSINGH:

Thank you Alberto. This is Dev. And a quick follow up question regarding that. You said two events happening in the same location, and then on happening in another location. So is it that the first day, well, can you then update the timeline...? Well, update the timeline to ensure that it is mentioned? And I guess, once you put it up on the wiki, we can do so.

Secondly, regarding Haiti, just to confirm. For Haiti, you won't need three days in Haiti, you will only need two days in Haiti, because there is only two events. Is that correct, Alberto? And these details are important... Sorry, just to confirm. These details are important because we need to go to, be part of the CROPP proposal and therefore to constituency travel, once approved, if approved, by the VPs and so forth.

So I just want to confirm. For Haiti then, there is only going to be two days of events.

ALBERTO SOTO:

Alberto Soto speaking. Dev, let us do the following. In order to bring this to a close, we do not need to change anything in the schedule that I sent. We just need to assign a date once we reached a decision. So we will have, two events in the Dominican Republic, one to be held in an official institution, that is a sponsoring institution, and the other event held at a university.

If need be, if we need a higher turnout, because we are still two months away from these events, we will do the following. We will have people go to one of these two events in the Dominican Republic. Then as regards Haiti, we will have one event in one location, and if somebody can participate there, that person will have to attend that event on that single day. I hope I have made myself clear now. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. This is Dev. Alberto, perhaps you misunderstand me. I'm only trying to work out the durations here, because the timings have to be put in exactly on – in the CROPP proposal. So my question is, given that it's... So first of all, the intent is... I just want to confirm.

So it's two events in Haiti, possibly three events in Dominican Republic. The agenda for all of these are the same, perhaps just different language versions of documents presented. So what I'm trying to now get at is, well, the next part of the agenda, which is the proper approach to it. How are we going to approach [?] going to approach these two sessions?

So right now, the proposal was the persons to fly to the Dominican Republic, then fly from the Dominican Republic to Haiti and back to the Dominican Republic, and then return home. Another approach is, have one flight person go to the Dominican Republic, and return home, and one person fly from — to Haiti and then return home. So which approach is, do you think is the best approach? And I really want to get some feedback from the other persons here.

ALBERTO SOTO:

Alberto Soto speaking. I think the best approach is to have one person and one person... Really, the best thing for me to do is to have two people sent to one place and two people sent to the other place. If that is not possible, then we fly one person to the Dominican Republic and back home, and one person to Haiti and then back home.

We have consulted Sébastien and we have no issue in the first date of June, so we might count on him for the one and only presentation to be made or delivered in Haiti. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. So this is Dev. Good thing [?] no issue with Sébastien. I see Silvia's hand is raised. Go ahead.

SILVIA VIVANCO:

This is Silvia speaking. Thank you Dev. This is Silvia for the record. I have a question regarding the last comment. It is my understanding, and based on our prior meeting, we were going to send two people to each place in order to setup a theme, and also to mix up or integrate people that are not so experienced.

In LACRALO, we have other people that are more seasoned within LACRALO. And Sébastien, I mean, I was able to get in touch with him, and he is available from May 28th to June the 2nd in order to travel to Haiti, and also to travel to the Dominican Republic. However, I want to remind you that if we're going to send Sébastien only to Haiti, because he speaks French, well, let us remember that this is LACRALO outreach.

So I believe it is appropriate to send a person from the region, not only Sébastien, and it is my understanding, on the basis of our prior meeting, that we were going to send two people or three, at the most. That is, a team of three people. Maybe somebody can go there and come back, but we thought about having two people per event all of the time, and always having someone from LACRALO. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. Thank you Silvia. But to be quite honest, the thing is, is that it has changed a lot. The last proposal, before I sent in these calls, was that there was going to be one person going to each of the countries. Now, regarding your suggestion, although I've not seen Sébastien's response regarding this, so this is news to me and I guess this changes things.

If Sébastien Bachollet is able to go to Haiti and to the Dominican Republic, to do the meetings, I think that will be, well, I would say a great [?]. My concern then is, why do we need someone ALAC, RALO person to attend? Given that, because... You see, to me, these sessions are going to be a straight presentation type topic. They're not going to be very, how should I put it?

There are not like a public event, where one person does [?], the other person walks around the conference and gives out brochures and so forth. So my question is, why do you think we need... And keep in mind, we only have five travelers. We only have five travel slots. We can't, you know...

So when you say send three to this one and three to that one, we don't have that allocation. I see now Alberto Soto, go ahead, and then Silvia. Alberto first, go ahead.

ALBERTO SOTO:

This is Alberto speaking. Okay, Dev, the project at the end of the day entails one trip according to your latest suggestion, a week ago. So, this is what your request is actually...

DEV ANAND TEELUCKSINGH:

No.

ALBERTO SOTO:

...then we had the possibility of sending two people to each country, to each place. But the truth is that, in this presentation, we – excuse me. I don't know how to put it. We are including the IANA transition, we are including the migration of all of these topics. And I spoke about this with Rodrigo de la Parra, and he thought this was a good idea.

So we need to send someone that is truly knowledgeable of these topics. And also, this presentation, this event, will be open to the general public, not only to NGOs, so anyone can attend. Of course, prevalence, or priority, will be given to NGOs that at a later stage can become certified ALSs. So that doesn't mean that the general public is going to be left out.

So our proposal has to be to represent all of the Internet users. If we restrict this to the possible ALSs that may join us, then we will be, not

wasting money, but we will not be using money to, you know, in the best possible way. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. Thank you Alberto. Silvia, please go ahead.

SILVIA VIVANCO:

Silvia for the record. Thank you Dev. Okay, I agree with Alberto. We need to address these two topics. We need to teach about ICANN, but that money being proposed or being given for the program, should also be used to achieve our main goal, and this is to achieve at least one ALS, or to get one ALS in each of the countries.

So we need to deliver brochures about LACRALO, and it would be great the results of this trip, the results – it would be a great result if we can have ALSs presenting, or submitting, their application. One from the Dominican Republic and Haiti. So [CROSSTALK], for example, Sébastien, and I would say that he did confirm that he would be available to travel to these two countries between May 28th and June the 2nd.

So he can attend those – these two events. But I insist, it would be great to have Sébastien, but someone also from LACRALO, perhaps Alberto Soto as the new chair of the region. But I think that someone from LACRALO must attend. And if we have the possibility of sending five travelers, okay let's send three or four travelers, but not only two, because the only one who would speak French is Sébastien. Thank you.

DEV ANAND TEELUCKSINGH:

Okay. This is Dev. I still I have a little concern with the numbers, in terms of who goes to where. Because if Sébastien is going to go to Haiti, well, which ever event goes first. Dominican Republic and then Haiti, and not to the other country, great. I'm just wondering the numbers needed to go to each country then.

But I see Alberto, your hand is raised, but I really want to get some feedback from the other persons who are listening in. Humberto? What are your thoughts?

ALBERTO SOTO:

Alberto Soto speaking. I would suggest that for Haiti, we confirm Sébastien, because he is willing to go so let's make the most of his participation. And I would suggest our sending him. And Dev, and when it comes to Dev's trip, well it would be cheaper than, for example, my travelling there.

If they would like to go, or both of them would like to go to the Dominican Republic, that would be okay. The two of them may go to the Dominican Republic, or then we can send a third person, for example Silvia, travelling to Dominican Republic. And then we have three people, only three people travelling to the Dominican Republic.

And I say Silvia because she was considered the first instance to travel. So Dev, you have the floor, go ahead please.

DEV ANAND TEELUCKSINGH:

Okay. This is Dev. Thanks Alberto for that. So, just to clarify, so Haiti, Sébastien and myself, and then for the Dominica Republic Sébastien and

myself or Sébastien and Silvia. Thanks to Silvia for also summarizing. Yes. Well, first of all, I have to say that I might have to decline to go to Haiti, because I know I just don't have the time right then.

There is also another event that I've been made aware of. Been made aware of in [?]. There is also a possibility of that event we can also do for CROPP. But I want to ask questions from Leon Sanchez. Can you take the floor and just give me – if you have any questions or comments about this?

Okay I'm not hearing anything from Leon, so I assume...

LEON FELIPE SANCHEZ:

Leon Sanchez speaking.

DEV ANAND TEELUCKSINGH:

Okay. Go ahead.

LEON FELIPE SANCHEZ:

This is Leon for the record. I think the way is being structured is correct. As you were saying, we need to address these two possibilities or these two events, and I agree with that.

DEV ANAND TEELUCKSINGH:

Okay. Well, this is Dev. Thank you Leon. Humberto, do you have any comments? Like I said, I want to make sure everybody is thinking about this. So if you have any comments, Humberto Carrasco? You can say

something, you can take the floor. Okay, not hearing anything from Humberto. This is Dev again.

Okay. Well then, this is Dev. Well, given that it will be Sébastien going to both of these locations, Sébastien Bachollet, to both of these locations, Dominican Republic and Haiti... Silvia, would you be willing to go to both of those countries? And then we'll be using two of the CROPP's trip allocations.

SYLVIA HERLEIN:

This is Sylvia Herlein. Yes, I am willing to go to both countries. It would be an honor and my pleasure, and a huge responsibility because I do not speak French, but I could humbly help and assist Sébastien there. Yes, of course, I would like to go.

DEV ANAND TEELUCKSINGH:

Okay. All right. Okay. So then in that case, what would happen... This is Dev. So then what will happen then Sylvia, the proposal will be then structured as, you flying from Argentina to the Dominican Republic, and then a second proposal from Dominican Republic to Haiti and then back to the Dominican Republic, and then using the first proposal to return home.

Is that understood? And does everybody agree with that? Sylvia is from Brazil, thanks. Alberto, I see your hand raised. Go ahead.

ALBERTO SOTO:

Alberto Soto speaking. Yes, I do agree with that, Dev. You know, my first concern is always economy, and of course, if I have to travel, I will travel but it's not my intention to travel. However, I would like to

remind all of us that we have five travel slots, that is to say five people can travel, and we need to use this because the budget will end in June.

And I don't understand this economy issue, but the budget will close in June. So if we need any other people to travel, well I don't see any problem in that. That's all.

DEV ANAND TEELUCKSINGH:

This is Dev. And indeed, there is a need for second traveler to go with Silvia to, in Haiti and Dominican Republic certainly. But I will take... But my concern is, is that all the money that would be spent. Because first of all, ICANN is to be spending money for Sébastien to fly to those countries. That's one.

Okay. The second thing would be the travelers from LACRALO to be go there and back. If two persons are needed, fine. And I'm sure that the CROPP review team will accept two travelers, but I mean, I think having three or four travelers [?] will not be feasible. And there is a link here to another event that would be sent to CROPP consideration.

So that was just sent to me today. And I think this is another possibility for CROPP, because it's a public event and so forth. Perhaps, Carlton, my dear, good candidate, because he was thinking of attending as a speaker, if he got funding. So he seems to be a prime candidate to go now. Sorry, this is something that is an ICT event in [?]. You know.

So meeting myself, but I'm not really 100% sure. So, if there is a second person that should go to the Dominican Republic and Haiti, yes. I

understand what you mean Sylvia. Then you can be candidate for that person.

So my question is, is there any need for a second person to go? To attend the Dominican Republic in addition to, well, Sylvia and, well, Sébastien Bachollet?

ALBERTO SOTO:

This is Alberto Soto speaking. No there is no need for that. When I mentioned a third person, was because Sébastien and Sylvia will go to Haiti. Sébastien would go back to his home, and Sylvia and the other person would meet in San Domingo, but Dev, if you believe that this is not feasible, okay, let's leave it as it is.

Let's take two people, Sébastien and Sylvia, travelling to Haiti, Santo Domingo, and we'll finish the discussion here, and there is no problem with that. My question now is the following. This event in [?], are they going to deliver or a presentation similar to the one we are delivering in LACRALO? Thank you.

DEV ANAND TEELUCKSINGH:

This is Dev. Well, it's a two day event on the 5th and 6th of June 2014. And there is a call for speakers. If you go to the website, if you look, there is a call for speakers. So given that, I believe, it's going to be a variety of people and ICT attending not only from [?] but from other parts of Latin American and the Caribbean.

We can probably then request to do a presentation there during that two day summit. And, well, after the event, go along the floor of the

summit and give out brochures and so forth and things like that. If you look, there is a map of the venue showing where booths are, desks are going to be located, and so forth.

You know. So. I think this sounds very promising, to be quite honest. And this is something that CROPP is made for. Does that answer your question Alberto regarding the [?] meeting? I think we have to move very quickly on this. So because it's literally next month.

ALBERTO SOTO:

Alberto Soto speaking. Yes, Dev. Dev, this is Alberto Soto speaking. But taking into account the date of the event, is that really [?]...

DEV ANAND TEELUCKSINGH:

Yes it is. This is Dev. Because the event has to be the end of... The trips have to be before the end of June. So June, which is June, is it 30th or 31st? June 30th. So travel has to finish before June 30th. So the answer is yes. This is... It's an eligible event of the CROPP.

ALBERTO SOTO:

This is Alberto Soto again, Dev. Who will introduce, or who will introduce [?] trip? Or who will present [Carlton's?] trip and proposal on this trip?

DEV ANAND TEELUCKSINGH:

This is Dev. I'm not sure what you mean by present Carlton's trip. In any case, for all of the CROPP events, all of the travel you will have to

give a travel assessment. Giving some details as to what they did, and to report back on... So, in terms of presentation, there would be Carlton, if he was to go.

Okay? Does that answer your question Alberto? This is Dev.

ALBERTO SOTO: Alberto Soto speaking. Sorry Dev. My question is, I've proposed the

travels to Haiti and Dominican Republic. Now my question, who

proposes Carlton's trip to [?]? That is my question.

DEV ANAND TEELUCKSINGH: This is Dev. I have not, it has not been formally presented. It's just

been pointed out to me. So I'm sharing it will all of you. So it's not

been filed or anything of that sort. But, I think this is actually a very

good event.

ALBERTO SOTO: Okay. No problem.

DEV ANAND TEELUCKSINGH: I just got this email about this today.

ALBERTO SOTO: So I am not the one proposing the trip for Carlton. That was my

question.

DEV ANAND TEELUCKSINGH:

Okay. I guess I will. All right, so now I understand what you mean now. This is Dev. I can do then do the proposal and then file it to the CROPP review team. And then I'll cc you Alberto and Humberto, to make sure you see the details. Is that okay?

ALBERTO SOTO:

Alberto Soto speaking. Okay, that will be great. And I think that would be, this would be great for Carlton as well. And I am really satisfied with the people travelling to the three locations. So thank you very much.

DEV ANAND TEELUCKSINGH:

Okay. Thank you. Well in that case, I think now we need to now [?] concern, Alberto. What needs to happen now is we need to finalize the actual dates for the event in Haiti, and then confirm it. If Sébastien is truly willing to go to these locations, I guess it will depend on him, as to when he will be able to arrive in either of those countries. So Alberto, also [?], so they'll send you — will be the person to go to Haiti and Dominican Republic.

You really need to coordinate exactly as to what would be the exact date, will be travelling. That needs to be put on the top form. Okay? But I think well, we need to fill that out. I see [?] in the chat, Sébastien can come from May 20th to June 2nd. So...

ALBERTO SOTO:

This is Alberto Soto speaking. I would like to ask Sylvia and Sébastien, Sylvia if she could coordinate with Sébastien so that they can set the date and send that information to Dev.

DEV ANAND TEELUCKSINGH:

Yes. And also to Alberto. This is Dev speaking. Because the organizations in those countries can be, well, can then finalize the meetings and confirm their venues, and so forth. Okay? Because we need to put the exact dates. Because we can't, once we submit the dates, and constituency travel is just going to take your date and [?] for you.

So we can change them afterwards, or at least not without expense. So we need to coordinate that. Okay? So, Sylvia? And I'm referring to Sylvia [?] [laughter].

SYLVIA HERLEIN:

Sylvia speaking. Thank you very much Dev. Today I spoke to Sébastien, and he confirmed that he could attend to both countries, and the dates could be from May 28th to June 2nd. I told him that today we were meeting, and I would give him a brief summary of the results of this meeting.

And I told him that I needed a date, he told me this, but tomorrow I may tell you that, or I tell him that the group has accepted his attending or his traveling to the countries. And he told me, as I said before, that he would be available to travel from May the 28th to June the 2nd. Thank you very much.

DEV ANAND TEELUCKSINGH:

Okay. But this is Dev speaking. Because you also need to set which country you're going to go to first. So whether Sébastien is going to

Haiti first or to the Dominican Republic first. That's why you need to confirm which, the sequence and the dates as to which country you're going to go to first. Because then that affects your CROPP proposal, as to which country you're going to go to first. Okay?

So just to coordinate that and keep me in the loop. And Alberto in the loop. And also so you can get this proposal filed. Alberto, your hand is raised. Go ahead.

ALBERTO SOTO:

Alberto Soto speaking. Sylvia, please, we need to set a date taking into account the timeframe provided by Sébastien, taking into account a two day stay in Santo Domingo and one day in Port au Prince. So that you can give that information to Dev.

SYLVIA HERLEIN:

This is Sylvia Herlein speaking. That's correct. I will do that. For me, as well as for Sébastien, it will make no difference in terms of which country we should attend first. We need to speak or talk to the staff constituency and see if there is any advantage in travelling to one country, or the other first, in terms of cost. Perhaps the staff can, the people in the constituency travel would advise us regarding to which country we should attend first.

But I don't think there would be any problem with the order of the country.

DEV ANAND TEELUCKSINGH:

Okay. Well, it's just a concern which one it is. This is Dev. Because again, we can't change the proposal. Okay? And indeed, routing of the trip affects the price. So, okay? So, you really need to decide which one is the first country and which one is the second one. Okay? So let's... So Sylvia, keep me in the loop regarding that. I will try to start the proposal working on this event in the [?], and I'll cc both Alberto and Humberto on that. Okay?

Okay. Great. So now I think that we can conclude this meeting, if there is no further questions. And of course, this means that, assuming that it's only one or two persons in [?] and the one person going to Haiti and the Dominican Republic, that means that we have two more possible slots for us. So if there is any other events in the Latin American and the Caribbean region, that we could attend to, especially in those countries that don't have ALSs, well keep — do another look around and see if there is such an event.

Some sort of public IC event so we can then file that too. Okay? Okay. I'm sorry, Alberto, you have your hand raised?

ALBERTO SOTO:

Dev, thank you very much. Sylvia, the cost of the air ticket is different in the cost is \$300. So in order to avoid any delay, in order to give account to the timeframe set by Sébastien, please choose one country, that would be the first country, and the other country would be the second country.

There is no difference in terms of ticket – air ticket that would make any difference in the cost, so that we can close this proposal by now.

Perhaps in fact, what I meant before was there are 200 or 300 kilometers, not dollars, kilometers between one capital city and the other.

SYLVIA HERLEIN:

Sylvia Herlein speaking. Okay. So we would have to define that. I think it would be interesting to go first to Haiti because it is only one day, and then to go to the Dominican Republic. Thank you.

ALBERTO SOTO:

Alberto Soto speaking. Okay. That's perfect.

DEV ANAND TEELUCKSINGH:

Yes. But you need to settle on whichever country first. Okay. So I'll look for that email Sylvia and Alberto. Okay. All right. With that, if there are no other questions or comments, I think we can close the meeting. Going once, going twice, going thrice. Okay. Thank you all for attending. This call is now adjourned and thanks so much to the interpreters and to staff. This call is adjourned.
