
#### Two Views on ICANN

A. ICANN is a private sector led multistakeholder volunteer organization which has a staff that assists the community, of which it is part, with making policy and is responsible for implementation and enforcement of that policy.

B. ICANN is a public non profit corporation whose staff is not only responsible for running the organization with a postive cash flow, but must also manage a large noisy community with strong opinions.

A large part of ICANN activity must cope with this tussle. ICANN has work to get done and the staff is charged with getting work done. But the community must determine how it is done and is repsonsible for <u>all</u> ICANN's policies.

#### Transition of Stewardship of IANA Functions

In response to the NTIA announcement and request, ICANN, at the ICANN
49 Meeting in Singapore on 24 March, launched a multistakeholderdesigned process to gather the community's views and proposals to address
how the mechanisms for the transition of NTIA's stewardship of the IANA
functions should occur.

#### Enhancing ICANN Accountability

This discussion will look at how ICANN remains accountable in the absence
of its historical contractual relationship to the U.S. Government and the
perceived backstop with regard to ICANN's organization-wide accountability
provided by that role. While closely related to the ongoing discussions
around the IANA Stewardship Transition, this is a separate process.










## Problem Statement

- Each Supporting Organization (SO) does its own thing
- Each Advisory committee (AC) does its own thing.
- While internally consistent, the output of the various process is not compatible.
- Board gets
  - Recommendation from the SO that is should accept
  - · Advice from each of several AC that it should heed
    - If they are incompatible
      - Board make top down decision, or
      - The process dead ends
      - In either case it is a poor outcome

  - SSAC
  - RSSAC

#### Develop other means of early Engagement

- Joint effort between GNSO and GAC to develop methods of early engagement.
- Specific steps to be taken by GNSO whenever an SSAC report released.
- Joint working groups currently a joint effort to develop a start process for creating joint working groups.

## **Problem Statement**

## Implementation often seems to ignore Policy What can we do?

The Working Group is tasked to provide the GNSO Council with a set of recommendations on:

- A set of principles that would underpin any GNSO policy and implementation related discussions, taking into account existing GNSO Operating Procedures.
- A process for developing gTLD policy, perhaps in the form of "Policy Guidance", including criteria for when it would be appropriate to use such a process (for developing policy other than "Consensus Policy") instead of a GNSO Policy Development Process;
- A framework for implementation related discussions associated with GNSO Policy Recommendations;
- Criteria to be used to determine when an action should be addressed by a policy process and when it should be considered implementation, and;
- Further guidance on how GNSO Implementation Review Teams, as defined in the PDP Manual, are expected to function and operate.

Policy & Implementation

- Stakeholder
- Policy, Policy Development, GNSO Policy, Policy Advice
- Consensus, GNSO consensus Policy
- Implement, Implementation, Implementation review team
- Principle, Multistakeholder model, ICANN multistakeholder model

#### Working Principles such as

- Multistakeholderism (m17m): Policy at ICANN comes from the community in a bottom-up manner and must adhere to standards of development.
- Implementation and policy are rarely if ever completely separate, there needs to be a way for policy to check implementation.
- But the amount of time it take to do policy should not stall operations.
