attend BFA so Kuek took his place instead. Read more here




20th Anniversary of the Internet in the Philippines

ICANN 49th Public Meeting in Singapore

On 23 - 27 March, for the first time since the ICANN APAC Hub was set up, we played host to one of ICANN's public meetings - ICANN49. Singapore has been a historic venue for past ICANN meetings: the very first ICANN public meeting was held in Singapore in March 1999; in June 2011 at ICANN41, the new gTLD programme was approved by the Board; and this year, ICANN49 marked the first platform for public discussion on the latest NTIA announcement of its intention to transition its stewardship of the IANA Functions.

We took the opportunity to organise a pre-meeting conference for local SMEs. We also partnered NetMission and launched the pilot NextGen@ICANN programme.

New gTLD Trademark Rights Protection

Much work has been done by Dennis Cai, Secretary-General of ADNDRC to share and educate the communities on the new gTLD programme, the ICANN Uniform Rapid Suspension System (URS) and the Online Dispute Resolution (ODR) for URS.
