Event Highlights

ICANN50: London

APAC Engagement Update – Both Savé and Kuek shared their updates on APAC engagement with the regional community on 25 Jun. Over 40 participants attended and provided healthy exchange on topics like getting more involved, youth engagement and policy development processes. Details and the slides can be found on here.

Oceania: ICANN-Oceania Stakeholder Engagement Strategy Working Group Written by Savé Vocea

The ICANN-Oceania Stakeholder Engagement Strategy Working Group met on 19 May for 2 days in Nadi, Fiji. Members got together to deliberate and agree on activities to table to ICANN and potential partners in order to broaden the region's stakeholder engagement in ICANN and the Internet Ecosystem. A list of actions, timelines, potential partners and actors and measures were also discussed to fit under the 4 themes:

- DNS Security and Stability
- The Domain Name Industry
- Expansion of the Internet
- Internet Governance

The Working Group also shared its update at the APAC Engagement Update Session during ICANN 50.



On 22 June, ICANN's Fadi Chehadé and Cao Shumin, President of CATR, signed a Memorandum of Understanding to forge closer collaboration on engagement efforts in China. Under the agreement, both parties will work together to improve communication with Chinese communities, align academic and public research in IP address and domain name areas and exchange opinions on Internet governance. CATR will also help to promote participation from the Chinese community in ICANN activities like ICANN Public Meeting. The MoU was signed at ICANN 50 meeting in London.



Becoming a new gTLD registry, what's next?

On 12 June, we kicked off the first Asia Pacific webinar, as part of our promise to serve the local community in their time zone. The webinar aimed to help registries and new gTLD applicants to understand how they get from signing the Registry Agreement to general registration.

Krista Papac (Director, Registry Services) delivered the presentation with Han Chuan Lee (Registry Services Sr. Manager) as moderator and Jia-Rong Low (Head, Strategy and Initiatives) as host. Response was very positive with 42 participants and there was a healthy exchange of Q&As. Bangladesh: BDNOG – Bangladesh Network Operators Group Written by Champika Wijayatunga

Kuek and I represented ICANN in the first Bangladesh NOG (bdNOG1) conference and APNIC Regional Meeting (ARM) held in Dhaka, Bangladesh during 19-24 May. Participants represented network operators, government institutions, enterprises, academics, various local associations.

The event started with a 3-day Network Security Workshop in which I was an instructor. Following the workshops, the bdNOG conference and ARM were held and inaugurated by two key ministers of the Government of Bangladesh, namely HE Hasanul Haq Inu, Minister of Information and HE Junaid Ahmed Palak, Minister of Post, Telecommunications and Information Technology.

Kuek was a keynote speaker, together with Paul Wilson, Director General of APNIC. Kuek highlighted the multi-stakeholder model and the need for the Bangladesh community's participation in the process. He was also part of the Internet Governance panel that was held as part of the APNIC Regional Meeting. We also held meetings with various stakeholders during the visit and

discussed future participation and support in the future.



Indonesia: IDNOG - Indonesia Network Operators Group Written by Champika Wijayatunga



The Indonesian network operations community held their first operators group meeting, IDNOG, in Jakarta on 24 June. I attended the conference and provided an update on ICANN's Identifier Systems Security Stability and Resiliency (ISSSR). The conference attracted over 150 participants from various industry segments that included ISPs, network operators, enterprises, government, academia etc. The IDNOG committee greatly appreciated ICANN's support towards Indonesian network operations community and they plan to have the next IDNOG event in mid 2015.



China: Hostingcon China Written by Song Zheng

I received an invitation from the organisers to attend Hostingcon China held in Shanghai on 22 May. It is an industry tradeshow for Domain Names, International Data Centres, Web Hosting and Cloud Business. Participating registries included Verisign, Radix, Dot Asia, Brandma, the Public Interest Registry, Dot CO and Neustar. I gave a presentation to the audience of over a hundred people, focusing on the introduction of ICANN and the New gTLD Program. Even though many have not have heard of ICANN before, about a dozen stayed behind to find out more about new gTLDs and application of IP Addresses. Overall, the reception was quite positive. I look forward to doing more of such outreach in the future.



China: International Workshop on Information and Cyber Security Written by Song Zheng

Kuek and I attended the International Workshop on Information and Cyber Security in Beijing on 5 - 6 June. This one and a half day workshop was co-hosted by China's Foreign Ministry and the United Nations Regional Center for Peace and Disarmament in Asia Pacific.

Kuek was invited to give a speech as a panelist in the session, "Formulation of International Rules and Norms in Cyberspace". He introduced ICANN's unique function in keeping one unified, secure, stable and interoperable Internet. He went on to describe how ICANN has been successfully coordinating policies in domain name and IP address areas using the multi-stakeholder model, which can further evolve and be used to resolve other Internet Governance issues. Kuek also answered questions related to ICANN / IANA functions stewardship transition and participated in discussions throughout the workshop.

Overall, ICANN's participation in this workshop and our constant engagement with the Chinese officials, signaled that our relationship with China's Foreign Ministry is steadily moving forward. It is an indication and recognition of the hard work we've been putting in and definitely a step in the right direction.



Hong Kong & Singapore: ICANN at Regional Platforms to Promote Rights Protection Mechanisms Written by Kuek Yu Chuang

ICANN has been working hard to promote awareness of rights protection mechanisms in the region. The idea here is to work with friends in the region to widen our audience pool.

In May, ICANN was invited by the **Asia Domain Name Dispute Resolution Centre** to provide more information about trademark rights protection in Hong Kong. This was alongside the Hong Kong INTA meetings where ICANN was also a speaker. At the INTA session, there was an active interest in ICANN's future in relation to the IANA functions stewardship transition.

In June, ICANN partnered with the Intellectual Property of Singapore (IPOS) to present at the World Intellectual Property Organization (WIPO) Summer School. There was a lot of interest in trademark issues in the domain name world, especially in the

On 30 May, KISA and ICANN jointly organised a roadshow at the KISA Academy in Seoul. 44 attendees attended, mostly from the local Registrar community.

Presentations on ICANN and the Internet Ecosystem as well as new gTLD updates were shared. There was much interest in the new gTLD contracting process and even technical requirements. All in all, ICANN's presence in Seoul was well received with positive feedback.

We are in discussion with KISA to plan more such roadshows to share and educate the registrars on other relevant topics. Watch this space!



Mongolia: APT Cybersecurity Forum Written by Low Jiarong

At the Asia Pacific Telecommunity (APT) Secretariat's invitation, I attended the 5th APT Cybersecurity Forum (APT CSF), hosted by Mongolia from 26-28 May, to highlight a key pillar of ICANN's work in maintaining a Secure, Stable and Resilient Internet. The APT Cybersecurity Forum has been a good platform which ICANN Asia Pacific Hub has engaged in. The APT CSF helped us to strengthen our relationship with the region's country CERTs (Computer Emergency Response Teams), as well as the region's policy makers and regulators. This was Mongolia's first hosting of the APT CSF, and we congratulate the Mongolian Information



Pacific: Girls and Women in ICT for the Pacific Written by Savé Vocea

Organised by Pasifika Nexus, the inaugural Girls and Women in ICT for the Pacific took place on 23 May at Suva, Fiji with an attendance of close to 200 students from 8 schools in Suva as well as other members of the public. The ICT4W Digital Alliance, a formal network with which to leverage development of women in ICT, was launched that day.

As I was invited to give a keynote address at the event, I took the opportunity to introduce ICANN to the students and also highlighted recent topics such as the status updates of the New gTLD Program as well as the NTIA-IANA stewardship process that is underway.

We are starting a regular column to provide some useful reminders/tips that will benefit contracted parties.


General Tips for Contracted Parties

- 1. Whitelist emails from ICANN.org.
- 2. Do **check if your mail servers are blocking emails f**rom ICANN Contractual Compliance. For example, if you are using Google email servers, note that they may block emails from ICANN Compliance. Google blocks emails containing questionable domain names in the subject line and body of emails.
- 3. Reply to Compliance notices **ASAP**. Do not wait till you receive a response from the registrant or resolve the issue. Let Compliance know what you are doing.
- 4. **Do not change the subject line** in any way when responding to compliance notices. For example, your system may add your own ticket number.
- 5. Please make sure attachments are less than 4MB.
