Australia Internet Governance Forum & Australia Network Operators Group

This year's Australian Internet Governance Forum was held in Melbourne, Australia from 26-27 August. The event is now in its 3rd year and ably supported by auDA. It attracted a good mix of stakeholders from the Australian government, civil society, academics, businesses and end users to discuss relevant topics of interest around governance of and on the Internet.

Lively and useful panel discussions kicked off the sessions and offered Q&As and opportunities for further comments from participants. The multistakeholder format of participation helped to continue discussions around metadata, privacy and access to rural communities.

Some ICANN issues were also raised and I updated the forum on the IANA function stewardship transition and also around ICANN Accountability. The Australian government GAC representatives also shared how they have engaged in various ICT regional and global fora (including ICANN) and emphasised their support for the multistakeholder model of Internet governance and for bodies like ICANN.

PITA Next Generation Networks Forum

Earlier in October, I also participated in the PITA Next Generation Networks Forum that was held in Suva and held bilaterals with participating Pacific Islands telcos/ISPs and ccTLD operators present. Discussions focused on supporting DNS resiliency for networks in the Pacific promoting L-root anycast and also opportunities for DNSSEC deployment. A number of country reps also took the opportunity to discuss and find out more about ccTLD management practices and IANA processes and support in capacity building.

ICANN51: Los Angeles - Homecoming

ICANN 51 was special as it felt like homecoming to arguably the birthplace of the Internet, and of course, to the backyard of the ICANN HQ. And when our Board Chair Steve Crocker recounted the days when it all started, it brought back a sense of nostalgia, lending a very personal flavor to the opening of ICANN 51.

The highlight however, has got to be the first ever attendance by a US Secretary of Commerce to an ICANN meeting. And along with that, the unequivocal message she conveyed: *Support for ICANN and the preservation of a free and open Internet*.





This set the tone for the days ahead as community members debated on the dual tracks of enhancing ICANN's accountability, and on the mechanism for the transition of IANA functions' stewardship. Multistakeholder engagement was in full motion, as shown by the active participation from remote hubs in other US regions, Africa and Europe.

The rising number of such next generation participants and the ever growing fellowship program are testaments themselves to the success of our efforts to draw more fresh blood into the system. I was glad to be able to personally engage these newcomers and share my ICANN experience from the APAC perspective. We also exchanged notes on how we (ICANN) can better reach out to the young, the disinterested and the underserved.

In the Spotlight

Chinese Generation Panel - An interview with Wang Wei

On 24 September, ICANN announced that the Chinese Community has stepped forward to form the Generation Panel to develop a proposal for Chinese (Han) script for the root zone Label Generation Ruleset (LGR). We caught up with Wang Wei, Chair of the Chinese Generation Panel at ICANN 51 in Los Angeles.



Q: Why is there a need to form Generation Panels?

A: When Internationalised Domain Names (IDNs) top-level domains (TLDs) were first launched in different scripts, it was for IDN country code TLDs (eg ".中国" for China).

Under the new generic top-level domain (gTLD) program, IDN gTLDs can now be added to the root zone, further opening up the Internet to allow representation of top level domain names in many languages and scripts, in addition to those using the letters in ASCII in Latin script. This has brought forth two different challenges.

Firstly, the same script can be used by different languages. This can become confusing when IDN gTLDs are introduced, as there may be language level differences that are not accommodated in the root zone, as it is more focused at the script level. For example the Chinese (Han) script is used in the Chinese, Japanese and Korean languages. It is therefore important to coordinate among the Chinese, Japanese and Korean communities to set the generation rules.

In addition, even within Chinese language communities, there exists both traditional Chinese script and simplified Chinese script. Therefore a TLD label may be considered exchangeable with another TLD by the end user (eg ".手机" and ".手機"). These cases or scenarios need to be identified.

The Label Generation Rules for Chinese (Han) script will help to address these challenges for the root zone.

Q: What made you take up this challenge?

A: I'm an engineer and I like to solve problems. It gives me a feeling of achievement when I can solve an issue.

Q: What are the biggest challenges that you and your panel are facing?

A: The biggest challenge is the different views towards variants by the communities. For the Chinese community, we have reached a consensus about variants in simplified and traditional Chinese scripts and can provide guidance on how to reconcile them.

The Japanese community uses Kanji, which is based on the Chinese (Han) script but the same character may have a different meaning in the Japanese language. So they may use the same Unicode code point differently. And they may not have variants.

The Korean community has a slightly more complicated consideration. Chinese (Han) script is not allowed in second-level domains under .kr and .한국 in Korea. In addition, in 2011, the Korean government stipulated that only Hangul or Korean alphabet could be accepted in official documents

Q: How long do you think it is going to take to develop the Chinese script label generation rules?

A: We hope to complete the report on Chinese characters and variants by the end of this year. However, the synchronisation between the Chinese, Japanese and Korean communities will require more time to reach consensus. Even though our coordination work may be easier compared to Arabic script, we will still require patience, hard work and lots of devotion.

Did you know, that one of the most common mis-perception is that ICANN "controls" the Internet? In reality, ICANN's role can be summarized as:

- Operating the Internet's Domain Name System (DNS)
- Co-ordinating the allocation and assignment of the Internet's unique identifiers
- Accrediting generic top-level-domain name registrars
- Facilitating the voice of volunteers worldwide who are dedicated to keeping the Internet secure, stable and interoperable.

Here are 5 of the most commonly asked questions that we receive:

Question	Answer		
Can I register domain names through ICANN?	No, ICANN is not a domain name registrar and you cannot register domain names through ICANN. You can register domain names through companies known as "registrars". You can find a list of these companies here. Be sure to read these guides first.		
Is ICANN responsible for accrediting domain name registrars for generic top level domain names?	Yes ICANN is responsible for accrediting gTLD domain name registrars. If your business entity is interested to become a registrar, you must sign an accreditation agreement with ICANN. Refer here on how to become a registrar and here for a sample of the agreement.		
Who manages the country code Top Level Domains (ccTLDs)?	ccTLDs are managed by locally appointed registry operators as they correspond to a country, territory or geographic location. They are not accredited by ICANN and are held accountable by local government and Internet community under local laws. Refer here for a list of ccTLDs and their designated managers.		
Does ICANN issue domain name certificates?	No, ICANN does not issue certificates to registrants and does not collect fees from registrants directly either. Read here on what to do if you receive emails from companies trying to sell you ICANN Domain Name Certificates. Read here if you receive emails not from your reseller or registrar and asking for payment to renew your domain name.		
How do I update my contact information/ Whois record?	ICANN does not maintain Whois data. To update your contact information in the Whois database, you need to contact your registrar (or reseller). Read here for some FAQs. Find out who is your registrar here.
