
Q1 How familiar are you with the following existing mechanisms?



I suggest a home page quick link directly to "Main Policy Activities" which seems rather buried under a second link. The Main Policy summaries surprisingly (IDNs, WHOIS) make no reference to the GAC: I suggest highlighting upfront those policy activities which require liaison with and significant inputs from the GAC and expected potential degree of interest - e.g. GAC should be aware / discussion with GAC expected / requires GAC public policy input. The GAC website should mirror this description of cross-community policy interest and in turn provide links to the GNSO summaries.
