Stephanie Perrin: The problem with ICANN's pdp process is that, particularly on the more controversial issues, the outputs can be dynamic. If we only do a HRIA at the beginning, on the issues report (and I agree we have to do one there) we will miss the more fine grained issues and impacts that arise later. The issues report RIA or HRIA would be a useful guidance document for the PDP, but a more

detailed on needs to accompany the draft report when it goes for public comment. The final version accompanying the final report would serve as guidance for the GNSO and Board.
