Robin Gross:Cockroaches seemed to call for that one recommendation.

Robin Gross: There was nothing "bottom up" about the Westlake Report.

Bill Drake:I'm sure they had this in mind from the beginning of the process

Robin Gross: No doubt, it is the recommendation staff hired Westlake to deliver, circumventing the bottom-up process.

Sam Lanfranco: I agree that we should hit the report on process. The comments and revisions in the Gomes text seem more about the content and too little about the overall flawed approach. I would prefer us to object to the flaws in the process, and not allow them to move us to content issues.

Robin Gross:staff refused to say how much Westlake is being paid for its recommendations. So much for transparency.

Avri Doria:Constituency voting is not a baby, it was the idea that wass discarded in the last review.

Stephanie Perrin:23 is out of scope Klaus

Amr Elsadr: @Stephanie: Is it?

Bill Drake: discussion is fine by me

Stephanie Perrin: Is it structural? I think so.

Bill Drake: the arrogance of these consultants inserting themselves into such things is not ok

Rudi Vansnick:@Stephanie: maybe clearely not only looking into NCSG but also other C's expressed this ?!

Robin Gross: No current or former NCUC Chair or EC members were interviewed, yet they focus on NCUC.

Bill Drake: they had absolutely no idea what they were doing Stephanie Perrin: I do not propose to ventilate all our concerns about this report.... I wrote a ten pager myself on it. But this insertion of a key structural recommendation without going to public consultation is a procedural transgression that must be called out.

Robin Gross:it was a willfull blindless on the part of Westlake, which is why it is hard to believe this was an earnest job by professionals.
