Avri Doria:in 2006 getting this far was an achievement. But it badly needs to be fixed.

Sam Lanfranco npoc/csih:Experiencing lightening storm...may lose contact

Marilia Maciel:Not giving registrars a way to trigger the process when they find a conflict on the ground is ridiculous: the fact that the privacy of individuals is being disrespected does not matter. It only matters in a national authority actually threatens litigation. So the focus of this policy is protecting ICANN, not the individual.

Avri Doria:back then we had absolutely nothing to say about implementation. now the council does .

David Cake:we should look at ways to reopen this policy. we can't vote against it or change it this time.

Maryam Bakoshi 2:welcome Nadira & GZ Kabir

Marilia Maciel:An additional trigger, yes, if I understand. The previous ones continue to exist too.

Amr Elsadr:@Stephanie: Them caving sounds very familiar.

Marilia Maciel:That's a good idea, Stephanie. We should talk to them.

Stephanie Perrin:Very few DPAs can do that, this was the problem.

Stephanie Perrin:I will shoot them a question or two.

Stephanie Perrin:I would call it a work around Avri....until we change the policy

Amr Elsadr:@Stephanie: Do I understand this correctly: that the scope of the IAG was limited to reviewing the trigger, not the entire policy?

Stephanie Perrin:Exactly Smr

Amr Elsadr:@Avri: Agree.

Marilia Maciel:Pretty much, Avri. However I think I was the only one who said to be uncertain about the vote, maybe?

Joy Liddicoat:while it has been a while since I have commented, on the issue of national data protection officers and Whois, fwiw in New Zealand where I work for the national data authority, we have made submissions to the C tod which is reveiwing .nz Whois policy

Avri Doria:is this an instance where an yes vote with a comment on why this is just a baby step and more needs to be done, is warranted?

Amr Elsadr:@Avri: Agree again.

Amr Elsadr:Vote + a comment may be good way to go on this.

Joy Liddicoat:apparently about 5% of cctlds have specific privacy proxy policies / protections- I do see scope for wider ICANN community support for this suggested review you are referring to

Marilia Maciel:Stephanie, the new trigger requires ICANN to seek advice from the national GAC member where the law is put into question. What is the weight of this member's opinion?

Joy Liddicoat:I agree Stephanie

Amr Elsadr:My understanding of the GAC input on requests for waivers to whois policies in this report, is that their input

is solicited, but carries very little weight.

Stephanie Perrin:I was planning to ask registrars if they have seen any sign of progress re the GAC input....

Avri Doria:i am not sure i understand that consensus point. do they have support for approval with mention of the need for further work?

Avri Doria:i hope that is what it meant.

Marilia Maciel:Avri, you mean the whois motion or the present one Amr is speaking about?

Stephanie Perrin:my question as well....

Amr Elsadr:SCI recommendations require full consensus of the committee members, and that was achieved. Thought I'd add that.

Amr Elsadr:Didn't the letter also include something about urgent issues that must be addressed in the event that another round proceeds prior to the conclusion of the PDP?

Stephanie Perrin:It is the consumer trust group that I am worried about, in terms of introducing content regulation....

Amr Elsadr:Looking for a copy of hte letter, but can't find it right now. Anybody have a url?

Marilia Maciel:The one provided in the council agenda is not working. I am looking for the same, Amr
