matthew shears:yes
Bill Drake:since I haven't been in this group could you briefly outline the ALAC issues later?
Milton:i will try to do that Bill
Milton:....and if Avri and I can reach consensus, anyone can!!!
matthew shears:!
Amr Elsadr:@Bill: ALAC is pro the ICANN only option at the end of the document.
Bill Drake:ah right
Amr Elsadr:So is the ccNSO.
Maryam Bakoshi:Akinremi Peter Taiwo has joined the meeting
matthew shears: yes ccnso and alac are the ICANN only suporters
Akinremi Peter Taiwo:Good day all.
Amr Elsadr:Hi Akinremi. Thanks for joining the call.
Bill Drake:greetings
Akinremi Peter Taiwo:Good to see you Amr.
Amr Elsadr:I think the registries were saying that there should be even representation between gTLD registries and ccTLD registries.
Bill Drake:sometimes we like experts, sometimes we don't it seems
Bill Drake:this would be in the "consumer's interest"
Bill Drake:guess nobody in ALAC has heard of contestable markets
Milton:I would support that
Akinremi Peter Taiwo:I would like to ask, what happen to IANA Staff after transition to ICANN
Maryam Bakoshi:Marilia Maciel, has joined the meeting

Milton:ability of CSC to give direct input to MRT? Isn't it supposed to do that already?

matthew shears:i think so

Milton:yes

Amr Elsadr:@Milton: Is that question directed at me?

matthew shears:milton agree - not resolver - but forwarding to independent appeals entity

Amr Elsadr:OK. That makes sense.

Milton:ICG is funded by ICANN

Milton:In case I forget, someone remind me to bring up the Jurisdiction Issue (scream of horror)

Milton:(screams)

matthew shears:I guess anyone can query any policy implementation if it goes straight to the appeals panel - really do need some filter to assess the validity of it I think otherwise the process will become politicized

Milton:agree Matt

Amr Elsadr:@Matt: You mean the MRT act as the filter?

matthew shears:i guess

matthew shears:dont see how else could be

Amr Elsadr:Couldn't the GNSO council serve as a filter? The council can determine if the implementation of a policy in question is something that belongs within the GNSO policy context or not, couldn't it?

Amr Elsadr:That's kind of why I am suggesting a direct link between the GNSO and the MRT, as opposed to GNSO representation on the CSC.

Akinremi Peter Taiwo:I think so

matthew shears:on jurisdiction - what if the contractor is based in France? Don't we have to separate the jurisdiction by ICANN and IANA operator?

Bill Drake:not sure that's true

Bill Drake:Swiss law is supposed to make forming all kinds of associations quite easy, that's why Markus did the IGF support association here

Milton:Wake up, Rafik

rafik:I am here

Akinremi Peter Taiwo:hmmmm

matthew shears:don't we want to ensure independence of MRT from ICANN structures?

Milton:Fik, we want to know the next step for approving the comments

Amr Elsadr:@Matt: a mechanism for the GNSO to communicate with the MRT doesn't really affect its independence, does it? Is there something I'm missing?

matthew shears:not sure Amr - just wondering

Milton:Bill, about the Geneva corp, I think the problem is one of legal liability

Maryam Bakoshi:Rafik is having mic issues

Maryam Bakoshi:He will try speaking again

Amr Elsadr:You're all stuck with me!! :D

Milton:I believe that several people have been given the pen on those comment

matthew shears:do we agree or need to revisit the composition of the MRT - this is big issue on the lists

Bill Drake:liability and formation a bit diff, I've heard nothing about the former

Robin Gross:is anyone else's audio out?

Robin Gross:I don't hear anything

Milton:I can hear

matthew shears:no audio is ok

Amr Elsadr:I suspect the composition of the MRT is going to be an ongoing discussion. I'm fine with what we're proposing for now.

Bill Drake:more than accountability
Akinremi Peter Taiwo:Avri thanks for your time

Amr Elsadr:Sent my apologies about the GAC GNSO meeting today.
matthew shears:not for me
Robin Gross:what is the GAC GNSO mtg?
Amr Elsadr:Agree with Milton. I'm ready to approve them now.

Robin Gross:yes, let's approve and move forward asap
Akinremi Peter Taiwo:agree
Amr Elsadr:@Robin: the GAC/GNSO consultative group - early engagement of GAC in the GNSO PDP.
