Amr Elsadr: I was never very happy about the idea of the community vetoing the budget.

Romina Florencia Cabrera: I read all the recommendations and I found a very interesting discussion, the link between human rights and business. As for the fiduciary responsibilidad ICANN GAC function and role of our group, who should have more space in the Icann, and voice.

Romina Florencia Cabrera: Structurally very democratic thoughts about how this group operates, standing respect and equal members, in a healthy debate.

Compliance department and have had some good wins in that area

Amr Elsadr:@James: Are you saying you are in favour of the community being able to veto the IANA budget?

James Gannon: No strongly against it.

Amr Elsadr: Ah. Cool. :)

James Gannon: I have proposed an alternative in my comments

James Gannon:But I do believe that the community and the IANA customers have a role in the budget that needs to be expanded, but I belive that should happen at PTI level and that the IANA budget should be the opposite of vetoable it should be unrejectable by the parent company of PTI (i.e ICANN)

Amr Elsadr:@James: Would need to consider that more attentively, but it sounds logical, but would also depend on what the "role" is.

Romina Florencia Cabrera: Romina Cabrera, Academia, Argentina, Pregunta: What is the geopolitical vision of ICANN regarding the development of China, and developed their business, but also their political surveillance of the population?

Romina Florencia Cabrera: and changes the world map of Internet governance policy?

James Gannon:Romina: The report addresses the geopolitical role of China via its role in the GAC, including the work of Stress Test 18 and Core Value 11 in order to minatin the GACs role without expansion of its ability to produce non-consensus advice for the board to examine
