Sam Lanfranco: As a "very long journey" it needs rolling monitoring and evaluation, to learn as we go.

Farzaneh Badii:yes James Gannon:Yes Stephanie Perrin:yes

Amr Elsadr 2:@Pranesh: I always thought it was a given that contracted parties belong on the contracted party house side of the GNSO. :)

Bill Drake:academics are individuals. Individuals can join NCUC, NCSG, and At Large

Pranesh Prakash: There are *groups* like CORE which is a group of registrars and not a registrar itself.

James Gannon:Stakeholders can be engaged without attending meetings, getting involved in PDPs is one huge area

Amr Elsadr 2:..., and the DNA, which is a group of registries, but not a registry itself. If Core is a business association like the DNA, then it is not elligible to join NCSG.

Rafik:@pranesh being a non-rpofit is not enoguh

Bill Drake:sorry boss

Farzaneh Badii: Is Klaus back?

Klaus Stoll:No, sorry I can not speak

Pranesh Prakash:Rafik: I agree. But it might deserve being stated in the second para.

Bill Drake: I would think you could talk to ALAC and say hey do you think this text could use a tweak for our purposes

Bill Drake:oh, like the ITU academic program

Amr Elsadr:@JJ: Yes..., at least as far as NCSG is concerned, business associations cannot join as per our charter.

Adam Peake: We have said that associations and similar should represent non-commercial interests - I believe similar words are in the NCSG's documents

Sam Lanfranco: Coming from the academic and research institute community (for 50 years) I would push that community for "green paper" food-for-thought inputs and call less for a physical presence at meetings.

Rudi Vansnick:i suppose this proposal is not yet a decision taken by ICANN Farzaneh Badii:can I see the last slide?

Bill Drake:interesting...my mailer has started dumping messages from my account into the junk folder. is it trying to tell me something?

Rudi Vansnick:we need more time to go through this with all our members before deciding on what our community requires

Jahangir Hossain:agree with Rudi and sam

Sam Lanfranco: The not-for-profit and civil society constituency is the most underrepresented constituency within the ICANN multistakeholder model. Part of the reason for that is the fact that not-for profits and civil society constituencies are impacted by Internet policy, but Internet policy is not central to their own mission and work. We have to meet them where they are, not ask them to meet us where we are.

Rudi Vansnick:as said we need more time as the sldies were just presented today

Farzaneh Badii:Well, this doc has been available for months, we need to comment on it and move forward

Jean-Jacques Sahel 2:@Sam 'We have to meet them where they are' - agreed

Bill Drake:woo hoo travel funds for all?
