Amal Al-saqqaf: Maybe some would prefer if all the questionnaires are collected in one WS2 questionnaire with parts related to each subgroup

Renata Aquino Ribeiro: Amal that is a good idea. Push forward nice questions w/ tough questions

avri doria: i would prefer that too. but don't think they can pull it off.

Julf Helsingius (NCPH NCA): Did it suddenly go quiet?
