Ayden Férdeline: This will sound like a criticism, and I suppose it is, but it is a constructive one. If there is a desire for this website to be useful to the average registrant, and not just domain investors and others who already know what rights and responsibilities they have, that website is not useful. It is a collection of bullet points in no real order. Look at the website of any regulator, say, the UK's Office of the Information Commissioner. They sort their educational material in a logical order.

Ayden Férdeline: Have any focus groups been done with registrants in order to understand how they interact with that page?

Ayden Férdeline: How much does ICANN spend developing educational materials for registrants? Or how much is it seeking to spend over the coming year?

Ayden Férdeline: understanding this is a work in progress

stephanie perrin: Do you do compliance audits of registrars/resellers to see if they are meeting their communications obligations to registrants?

stephanie perrin: I know mine don't and they are leaders in the community....

stephanie perrin: The bar must be low...

stephanie perrin: Well perhaps we should have a wee look at those audits and see if we can make suggestions...

Zakir: +1

stephanie perrin: COnsumer protection law varies by district, not nation....it seems to me that businesses (especially resellers and bundled orgs) should be required to have links to local consumer protection laws.

stephanie perrin: It is one of our core competencies, so a good job for us....

Zakir: exactly.

stephanie perrin: you might want to include language rights...

stephanie perrin: does a UDRP have to be filed in a local language?

stephanie perrin: I don't see Kathy Kleiman on this call....we may want to ask her for some advice on what needs to be up there on this matter.

stephanie perrin: I will put this on the agenda for NCSG meeting under our broad discussion topic....I think we could collect more info on what we see as key needs

stephanie perrin: in many countries, particularly developing countries, there are no local accredited registrars.

remmy.nweke: Good day everyone

Zakir: yes. we say this in the regional DNS studies. see for example the middle east and africa
