REQUEST DESCRIPTION

1. Activity: Please describe your proposed activity in detail

ALAC proposes to organize, in close cooperation with the GSE team, a pilot activity of capacity building for the At-Large community in an underserved region. This pilot program will not only be a training program, but also an engagement activity with the local ccTLD community to create a real synergy for a better interaction at the local level. Such an activity will initiate better coordination at the global level. Making use of the experience of the GSE staff in promoting the DNS industry in underserved regions, the pilot program will establish strong links between the local At-Large community with the DNS local community for further engagement and cooperation. This pilot operation would be implemented in one of the most underserved regions of At-Large, for example an African sub-region, Pacific small islands, Caribbean, etc. The activity would include At-Large Capacity Building Members as well as relevant GSE staff.
