Olivier: Many events in the IG calendar, what should we prioritize?

Nigel: WSIS track goes until December and we can give input (CSTD process – *see table used by Nigel during the call: [http://www.icannlac.org/files/key-global-internet-activities-2015\\_v2.pdf](http://www.icannlac.org/files/key-global-internet-activities-2015_v2.pdf)*)

Rafik: categorize the events by where we can provide our comments, and then prepare a timeline to know how much time we have.

Nigel: Document for CSTD will be available in the next couple of weeks and we can circulate it and seek comments from the working group.

Olivier: are there any deadlines?

Nigel: When the document appears on the appropriate website, we can circulate it. In terms of a timeline, this will probably happen by mid-April and we expect to file an answer by the end of April.

Difficult to determine next steps, 2 or 3 more stages where we will have documents designed by the CSTD where we will be able to give our view (not until July).

Nigel: WSIS Forum is hosted by ITU with others (UNESCO, UNCTAD and other agencies).

ICANN is a partner of this event. We have the opportunity to hold a workshop “ICANN Contribution to implementation of WSIS Action Lines; including the introduction of International Domain Names”

Olivier: Is there input needed for Phase V- Final Brief (24 April)?

Nigel: It's past the submission deadline to organize workshops and so on, but that Phase is basically about the program.

Olivier: Seeing the agenda, many topics appear to be outside our remit.

Nigel: we didn't start to plan the session yet but we can plan it with the group, or plan it and invite speakers from the group. It's in your hands.

The event is in May so if we want to change the title for example, we have to tell the ITU next week. But in terms of planning, we have time, it's our session and we can do what we want with it.
