Meeting Notes

The GP agreed to organize code points in Appendix C as follows to improve usability:

- The entry for Latin Small Letter Ae should come after all of the entries for Letter A,
- The entry for Latin Small Letter Eth should come after all of the entries for Letter D.
- The entries for Latin Small Letter Open E should follow all of the entries for Letter E.
- The entries for Latin Small Letter Open O should follow all of the entries for Letter O.
- The entry for Ligature Oe should follow the entries for Open O.

The GP discussed three small letter code points which their upper cases are homoglyph:

U+00F0 ð LATIN SMALL LETTER ETH U+00D0 Ð LATIN CAPITAL LETTER ETH

U+0111 đ LATIN SMALL LETTER D WITH STROKE

U+0110 D LATIN CAPITAL LETTER D WITH STROKE

U+0256 d LATIN SMALL LETTER D WITH TAIL

U+0189 Đ LATIN CAPITAL LETTER AFRICAN D

The GP discussed and agreed that these were not qualified as variant code points, similar to confusable issue of LATIN CAPITAL LETTER I and the LATIN SMALL LETTER L. The GP agreed to include the discussion for this issue in the Appendix E- Confusable.

It was pointed out that the cross-script sections in the Appendix E already include some of these issues. The additional text and additional case will be added for the with-in script cases. Mats volunteered to draft the text for GP's consideration. Bill volunteered to review if they are more cases within Latin script with this issue.

It was shared that the Appendix E - Confusable will be updated with the GP's rating 4 out of 7 where the data is available. This would apply to the within-script section. This data could be useful for reviewers during the public comment.

The test labels where discussed that as there was no mandatory file format, the GP agreed to generate the test labels with the optimum permutation of the code points.
