The At-Large Advisory Committee (ALAC) submitted (2) policy statements:

Comment: ALAC Statement on Registry Agreement Renewals .org, .biz and .info

The ALAC generally refrained from commenting on these prior proposed Registry Agreement renewals, with the exception of the proposed renewal of the .NET Registry Agreement in 2017. The ALAC in general favors standardizing Registry Agreements as this allows for transparency and predictability, as well as ease of review and compliance monitoring of one standard contract (with necessary but controlled variations through Addendums) instead of managing many disparate/varying contracts. Being supportive of this approach, the ALAC has not objected to the base Registry Agreement, or to its use in prior renewals.

In respect of the intent to standardize the said 3 proposed Registry Agreement renewals (.org, .biz, .info), the ALAC welcomes the following proposals:

- (i) inclusion of Public Interest Commitments (per Specification 11),
- (ii) inclusion of Minimum requirements for Rights Protection Mechanisms (per Specification 7),
- (iii) adoption of the Registry Code of Conduct (per Specification 9), and
- (iv) amendment of the relevant section in Specification 5 to govern the allocation of two-character labels at the second level to avoid confusion with corresponding country codes.

The ALAC also noted there are differences in opinion within At-Large regarding the omission and quantum of price caps.

Advice (sent to ICANN Board): GNSO Expedited Policy Development Process (EPDP) on the Temporary Specification for gTLD Registration Data Policy Recommendations for ICANN Board Consideration

The ALAC provided advice to the ICANN Board, noting significant concern related to three aspects of the EPDP Report. Specifically, the ALAC is concerned not only with the outcomes, but with the process that was followed to address the issues. All three impact the ability to access registration data and the completeness of that data, specifically: "to identify the appropriate balance for a path forward to ensure compliance with the GDPR while maintaining the existing WHOIS system to the greatest extent possible". The ALAC advises the ICANN Board to:

- Request that the issue of Thick WHOIS be discussed during the EPDP Phase 2 in light of the new legal opinion;
- Request that the issue of geographic differentiation be re-opened during the EPDP Phase 2 in light of the new legal opinion and the lack of considering the competing needs of privacy vs the benefits of non-redaction on cyber-security activities and that the ensuing discussion factor in the needs of those using the data for cyber-security and other legitimate purposes;
- Request that the issue of legal/natural differentiation be discussed during the EPDP Phase 2
 explicitly considering the competing needs of those using the data for cybersecurity and other
 legitimate purposes;
- Initiate independent studies related to the implementation of geographic and legal/natural
 differentiation as well as the impact of the Temporary Specification implementation on cybersecurity, or request that the EPDP Phase 2 commission such studies. If the latter, the Board
 should ensure adequate funding for such work.

CROP Selection Committee Call for Volunteers

NARALO has three CROP trips per year. The FY20 Crop trips start on July 1, 2019 to June 31, 2020 and the process that NARALO has created and is in the process of refinement. The three trips for NARALO this year were all in the winter/spring of 2019 and most of the CROP trips will occur later in the FY 20 budget period. Important to note that we need to give substantial time to permit ICANN staff to book the flights and hotel for the travelers so the selection committee convenes well in advance to the CROP trip (10 weeks).

In an effort to be more transparent we are calling out to community members to volunteer for the selection committee. Since its an adhoc committee, it will serve to review all the applications and propose the top two candidates (the second name as an alternative).

RALOs had their requests for RALO discretionary funding approved and At-Large had the request for up to 10 hours monthly of RTT services.

ALAC Update: ICANN64 Report



Marita Moll (Telecommunities Canada) is the NARALO appointee to the At Large Advisory Committee (ALAC). She gives us an update on this month's ALAC activities.

As usual, At-Large has been busy dealing with many different agendas. From the recommendations and changes required by the At-large Review to the agenda and activities for ICANN65 in Marrakesh,

our able chair, Maureen Hilyard, with the assistance of staff, keeps the ship on course. The group organizing the Montreal At-large Summit (Atlas III) is in full swing. Webinars and mandatory preparation courses, are already underway for potential delegates.

After considerable discussion in Kobe and in the policy (CPWG) working group, the majority (10/15) of At-Large members voted to submit *Advice to the Board* on various issues related to the Expedited Policy Development Process (EPDP) which is working to ensure that domain registration data is not in violation of the General Data Protection Regulation (GDPR) now in effect in the European Union. Also on the EPDP, ALAC and GAC released a joint statement in Kobe highlighting various concerns. Both of these statements can be accessed from the At-large policy <u>summary page</u>.

At-Large Liaison

I have taken on the role of At-large liaison to the ICANN strategic plan project. As part of a new series called NARALO INSIGHTS, I participated in an impromptu discussion with Brian Cute, coordinator of the process as it relates to the multistakeholder system. Lots of work to do still between now and the upcoming policy meeting in Marrakesh.

ICANN: North America Stakeholder Engagement Team Update



ICANN's Chris Mondini, Vice President, Global Business Engagement, heads up the Global Stakeholder Engagement (GSE) North America team.

We are in the ICANN64 read-out season and have already presented highlights of the Kobe meeting via webinar to Puerto Rican stakeholders, with trips to Ottawa and New York planned in the days ahead. We are always happy to present highlights of the ICANN meetings to groups of 10 or more, wherever you may gather across North America, and will make ourselves available, even if by webinar, to facilitate or lead a discussion on current topics at ICANN, so please keep those invitations coming.

In recent weeks the engagement team at ICANN Org has been brainstorming with community-facing colleagues on how to make engagement more efficient and effective. Much has changed since the Global Stakeholder Engagement team was established in 2013, and we want to be sure we are taking advantage of the best technology, the enthusiasm of the ICANN community, and the latest best-practices in outreach and community building. We started by looking at other global organizations and their approaches, then we conducted interviews, both internal and external, on the objectives and methods of engagement. While ICANN is clearly a world class organization in many respects, we nevertheless identified areas for improvement. We decided to focus on: surveys and feedback gathering, mentorship programs, and large format meetings (outside the three regular public meetings). We are in the process of gathering information and will be seeking community input on these topics soon.

Academic Relations

Improving Engagement

In other news, we have been working with a number of universities to determine how best to engage. We are frequently asked to contribute course content or deliver lectures, while, at the same time, we are eager for students to consider a period of involvement in the work of ICANN as part of their personal training and development. We have encountered more than one institution expressing interest in semester or year-long programs granting academic credit for ICANN participation, but have been challenged in determining how best to deploy talented students in a way that furthers the work of ICANN, for example in policy development. That said, we are in the process of formalizing academic content for universities and welcome invitations. If you know of schools where curriculum materials, a full course, or a single lecture on ICANN topics, would be welcome, please be sure to let us know. NET Inclusion 2019: CROP TRIP Report



At <u>NET Inclusion 2019</u>, 369 total registrants this year. Video recordings of all plenaries and the breakout sessions on the Livestream stage are available on the Net Inclusion 2019 page.

The fourth Annual National Digital Inclusion Alliance (better known as Net Inclusion) was held April 1 - 3 in Charlotte, North Carolina with an attendance of individuals from 32 states in the USA, and representation from Canada, Washington, DC and for the first time from Puerto Rico and Belgium. The NDIA is an alliance among leaders of local government, community organizations, public libraries, housing authorities and other institutions committed to reducing digital disparities among its community members. To improve the daily lives of all community members, the organization calls for widespread and actionable digital inclusion public policies that reflect what experience has taught.

I had the opportunity to engage with technical and professional organizations with complete ignorance of ICANN and the work done. Some showed great interest in getting involved as 'individual members' These will need some follow-up which is now ongoing through social media and direct email messages Some representatives of non-profit organizations will seek engaging, as expected, with a special focus in NCUC or NPOC constituencies.

Special outreach was done to native Americans (tribal organizations) in Arizona, Texas, and Kentucky and to organizations that were aligned to the ICANN mission. Including Library systems in underserved regions with a special interest in understanding the multistakeholder model, as an approach to better engage more partners in their decision-making process. However, it was made clear that for their type of organization, timely manner decisions are very important, and the multistakeholder model might not fit all.

As part of my pre-Conference, I participated in a workshop on 'Federal Policy's Impact on Local Digital Inclusion: Current and Potential Agency Policies and Legislation'. This 3-hour workshop covered topics related to dealing with Broadband and the Digital Divide in the context of 1) increasing access, 2) local, state and national government awareness of the lack of broadband in specific communities, 3) how to better train individuals in the importance and usage of broadband, 4) how to become the 'voice' of the under-served and under-represented communities (indigenous and/or native Americans), 4) opportunities through coalitions to increase adoption, among others. I had active participation in this workshop using Puerto Rico's recovery process after the hurricane's Irma and Maria, and the resilient plan to increase engagement and adoption of a secure and renovated Broadband infrastructure.

Lively conversations and a great exchange of information continued during the following days.

As part of the follow-up strategy, invitations to NARALO monthly calls will be sent. This will give interested parties an idea of the issues discussed. Having had a conversation with individuals I have an idea of the content that might be pertinent to them and serve as an engagement tool.

As a new affiliate individual member of NDIA, I will use its communication platform to engage with its members sharing relevant resources from NARALO and ICANN. Some of the participants of the 4th NDIA conference are also volunteers in some SO/AC constituencies and we had a chance to share some ideas.

The fact that I am bilingual gave me an additional advantage since some affiliate members and organizations represent Latinos within their respective communities | *Alfredo Calderon, ISOC Puerto Rico.*

ARIN 43: CROP TRIP Report



From April 7th to 10th, Michael Casadevall, ICANN Fellow attended ARIN 43 as part of a CROP trip to Bridgetown, Barbados on behalf of NARALO. For those unaware, ARIN (American Registry for Internet Numbers) covers distribution and management of IP address space throughout most of the NARALO region. During the conference, Mr. Casadevall advocated for advancement of IPv6 within the NARALO area. He also pushed for greater transparency of IP space holdings via the ARIN WHOIS database and introduced NARALO and ICANN to those new to ARIN.

He also provided practical knowledge regarding IPv6 to new attendees. He hopes to continue this work via ARIN policy discussions, and plans to attend ARIN events that will be hosted in his area in the next few months | *Michael Casadevall, ICANN Fellow and CROP Trip Recipient*

NomCom Update



Leah Symekher (SF Bay ISOC Chapter) is NARALO's appointee to the 2019 ICANN Nominations Committee (NomCom) & Outreach –Sub-Committee Chair. She gives us an update on the latest NomCom activities.

The application period for the open seats on the ICANN Board, PTI Board and Leadership positions closed on March 22, 2019. Immediately after the closing date, ICANN NomCom supporting staff worked diligently to prepare all the applications and the new portal to make the candidate information accessible to the NomCom team for review.

The Assessment Phase

The 2019 NomCom delegates reviewed and discussed each of the 128 applications from March 27 to April 8, 2019 in preparation for the first intersessional. This face to face intersessional meeting took place in Los Angeles from April 10 to April 13, 2019. During this meeting each application was reviewed, discussed and with the NomCom arrived at a list of 58 candidates who will proceed to the second phase of the selection process. All 58 candidates will be contacted by the NomCom to schedule audio interviews that will conclude before May 15, 2019 in preparation for the second


intersessional where candidates will be selected to a shorter list for the final interviews in Marrakesh, ICANN 65.

The ICANN NomCom staff has informed both the candidates who qualified for the second phase of the selection process as well as those who did not make it of their status. The NomCom thanks all the applicants who applied for leadership positions.


Norberto Cruz gave a welcome message to the audience. A vivid exchange of ideas were discussed with the twenty individuals participating, online and onsite.
