The At-Large Advisory Committee (ALAC) ratified 3 Policy Advice Statements in September:

[Recommendations for Managing IDN Variant Top-Level Domains](#)

The ALAC believes the main challenge while integrating IDN variant top-level domains is to balance positive user experience while ensuring the security, stability and manageability of the DNS. The ALAC provided advice on (4) questions posed by ICANN regarding the issue, and in general believes strict adherence to the Root Zone LGRs are the most appropriate way of arriving at IDN variant labels.

[IPC/BC Accreditation & Access Model for Non-Public Data v1.7](#) Note: Not a formal ICANN Public Comment.

The ALAC understands that tiered access is the most probable solution to ensuring compliance with the General Data Protection Regulation (GDPR), yet it has serious concerns as to the structure of this proposed model. The ALAC recommends a three-dimensional access model of accreditation: 1) identity of the petitioner; 2) determining the petitioner's purpose; and 3) requesting information on how they will use that data. The ALAC feels these considerations towards the access model will propel the ICANN community further towards a reliable and trusted domain name system (DNS).

[Draft ICANN Africa Strategic Plan 2016-2020 Version 3.0](#)

The ALAC recommended (1) an increased number of African ICANN staff to be seriously considered in the Draft Africa Strategic Plan; (2) involving more African participation in strategy planning and implementation; (3) local capacity building; (4) increased representation of African stakeholders in the SOs and ACs in addition to the ALAC and GAC. The ALAC also noted criteria for implementation should be further developed, and offered collaboration with the African community in At-Large.

Upcoming KSK Rollover

As the ICANN Organization prepares, for the first time ever, to change the cryptographic keys that help protect the Internet's Domain Name System (DNS), the organization has published a guide to let people know what to expect.

The changing of the keys, known as the "Root Key Signing Key (KSK) Rollover", is currently scheduled for 11 October 2018. The new ICANN guide is intended for those with all levels of technical expertise. It will help everyone prepare for the rollover by detailing what to expect. It is part of the ICANN Organization's ongoing efforts to raise awareness of the rollover and will also afford details about the rollover process.

Those who will find the guide most useful are operators of validating resolvers seeking clear direction on what to look for once the rollover occurs; non-technical journalists, bloggers and others who intend to write about the rollover before, during, and after the event will also benefit. Additionally, the document can be of value researchers who will be monitoring the DNS for indications of resolver failure after the rollover occurs.

While ICANN org expects user impact from the root KSK rollover [to be minimal](#), a small percentage of Internet users are expected to see problems in resolving domain names, which in lay terms means they will have problems reaching their online destination. There are currently a small number of Domain Name System Security Extensions (DNSSEC) validating recursive resolvers that are misconfigured, and some of the users relying upon these resolvers may experience problems. This document describes which users are most likely to see problems, and among those - what types of issues they will face at various times.

To summarize:

Those who will not be affected:

- Users who rely on a resolver that has the new KSK
- Users who rely on a resolver that does not perform DNSSEC validation

Those who will be affected, and how:

- If all of a users' resolvers do not have the new KSK in their trust anchor configuration, the user will start seeing name resolution failures (typically "server failure" or SERVFAIL errors) at some point within 48 hours of the rollover.

NOTE: It is impossible to predict when the operators of affected resolvers will notice that validation is failing for them.

Data analysis suggests that more than 99% of users whose resolvers are validating will be unaffected by the KSK rollover. Users who use at least one resolver that is ready for the rollover will see no change in their use of the DNS or the Internet in general after the rollover. (The same is true for users whose resolvers do not perform DNSSEC validation at all. Current estimates are that about two-thirds of users are behind resolvers that do not yet perform DNSSEC validation.)

Lastly, while the rollover is currently planned to take place on 11 October 2018, this date is pending ratification by the ICANN Board.

NARALO ALS Spotlight: Telecommunities Canada (TC)



Telecommunities Canada (TC) was formed at a meeting in Ottawa, Canada in the summer of 1994. What began as a group of Free-Nets has evolved into a loose alliance of community networks and other organizations as well as individuals acting together as a community of practice for sharing

and advocating the experience of community online. TC is a registered non-profit community organization whose mandate is:

- To ensure that all Canadians are able to participate in community-based communications and electronic information services by promoting and supporting local community network initiatives.
- To represent and promote the Canadian community networking movement at the national and international level.

At the national level, TC has intervened in many legislative and regulatory initiatives over the years -- sometimes submitting comments, sometimes supporting member initiatives, always supporting positions derived from end user needs and perspectives.

On the international front, TC representatives helped establish NARALO which was the last of five global regions to form, thus completing ICANN's intended international infrastructure for an At Large Advisory Committee (ALAC). NARALO officially became part of ICANN at a signing ceremony in San Juan Puerto Rico on June 28, 2007. Former TC Board member, Darlene Thompson was a member of the NARALO Secretariat. Then TC President, Gareth Shearman, held one of the two formal NARALO positions on ALAC. Current TC president, Marita Moll, will take on this responsibility in the upcoming meeting in Barcelona.

TC has also intervened in American Registry for Internet Numbers (ARIN) policy development process regarding the introduction of IPv6 and the impact of this process on community networks, recently contributing to a definition of community networks at ARIN.

In our statement, "[Beyond the Information Society](#)" presented at a 2005 civil society conference seeking Canadian input for WSIS II, TC argued for a world which enables communities to access and use the resources they need, including electronic resources, to improve their condition and position in a globalized context. This includes sustained financial and program resources that support community-based digital initiatives. In a very short period new technologies have changed how we work and how we play. Unfortunately, policy and practice have not always moved in lock step. We continue to seek opportunities to help reconnect the two.

The Implications of Digitizing Government Services without Universal Access

The National Digital Inclusion Alliance has just released a story revealing that [according to the Henry J Kaiser Family Foundation](#), as of August 2018, 11 states have applied for federal approval to implement work requirements for Medicaid beneficiaries.

Proposals from four of these states, Kentucky, Arkansas, Indiana, and New Hampshire have been approved and are in various stages of implementation. Arkansas and Kentucky's plans are in the most advanced stages, and both officially include a requirement that work or community engagement hours, such as volunteer service, must be reported online. It seems likely that other states will follow this example in an attempt to modernize Medicaid determination processes.

However, in all four of the states with approved work requirements, at least one in five households do not have access to home internet service.
