**Greetings everyone and happy holidays!**

**This year we welcomed three new individual members and two At-Large Structures (ALS) to NARALO, making our family a total of 47.**

**The NARALO Educational Group, led by Alfredo Calderón, kept us informed and up to date on the following issues: Net Neutrality, Typo Squatting, Accreditation & Access Model for Non-Public Data, Universal Acceptance, Highlights of ICANN63, New gTLD Subsequent Procedures PDP, and work related to the At-Large Review Implementation.**

**On average, 40% of members attended our monthly call.**

**In July, NARALO submitted a comment with full consensus to the ICANN Fellowship Program (IFP) Consultation Process, emphasizing the need for active outreach to global indigenous communities.**

**We continue to publish the NARALO newsletter. I want to welcome Susannah Gray, from ISOC San Francisco as our new editor for 2019.**

**The First North America School of Internet Governance (NASIG) was held in Puerto Rico from 7-9 March, three days before the ICANN61 Meeting. NASIG was an in-depth capacity building event that focused on teaching the development and application of shared principles, norms, rules, policies, decision-making processes and organizations that shape the evolution and utilization of the Internet. Additionally, NASIG sought to empower the next generation of Internet leaders. A total of 51 people (including staff, faculty and students) participated in the event. NARALO celebrated its [11 year anniversary during ICANN61](#). The original ICANN MOU was signed in San Juan, Puerto Rico 11 years ago.

This year we incorporated, for the first time, a standing agenda item for the North America Global Stakeholder Engagement (GSE) office to keep us all abreast of the developments happening on that front. Our three CROP trips are being scheduled for Spring 2019 with NTC 19, Digital Inclusion Conference and the ARIN meeting.

We said farewell to Alan Greenberg as our ALAC Chair and Member representative for several years. We are glad he will continue to contribute as an Individual Member.

In 2019, we will have elections again, this time for Secretary (2 years), NomCom Representative (1 year) and ALAC Member (2 years). I would like to invite anyone interested to apply for any of these positions.

Also, we expect to see the final results of the Expedited Policy Development Process (EPDP) on the Temporary Specification sometime in May. Alan is one of the two ALAC Members representing the ALAC in the EPDP working group.

ATLAS III and the First North American Internet Governance Forum (NAIGF) is coming to our region around the time of the ICANN66 Meeting in Montreal, in October 2019. These are going to be VERY busy days, but worth it - so be on the lookout for our January 2019 Newsletter for more information on how to apply to these events and more.

Overall, I think 2018 was an exciting year and I expect 2019 to be even better.

The At-Large Advisory Committee (ALAC) submitted 6 policy comments in December:

**[Initial Report of the Expedited Policy Development Process \(EPDP\) on the Temporary Specification for gTLD Registration Data Team](#)**

*The ALAC submitted a Word Doc form mirroring the new Google Form requested by the EPDP Team for collection of this public comment. In its statement, the ALAC provided its answers on the questions posed by the EPDP Team. In particular, the ALAC made recommendations on additional purposes for processing registration data, including the Accuracy Reporting System (ARS) and research and threats analysis/prevention from the Office of the Chief Technology Officer (OCTO). Regarding data elements, the ALAC noted Registrant provided data must not be unilaterally removed without due consultation with the data provider, and the registrant must declare whether it is a natural or legal person. The ALAC noted the technical contact fields must be mandatory, and the Organization field should not be redacted. The ALAC also noted in its conclusion the SSAC revised version of SAC101, a paper previously supported by ALAC, drawing particular attention to the statement, "RDDS access must comply with the law, but access should not be less timely, more restricted and less public than law requires."*

**[Supplemental Initial Report on the New gTLD Subsequent Procedures Policy Development Process \(Overarching Issues & Work Tracks 1-4\)](#)**

*The ALAC put on record their responses, suggestions and in some cases, advocacy, to the preliminary recommendations, options and questions in the Report. In particular, the ALAC strongly opposes the retention of the regular highest-bid auction process which was used in the 2012 round ("regular auctions") as the mechanism of last resort for resolution of contention sets within the Program, proposing instead that the ICANN Community explore the introduction of a multiplier-enhanced Vickrey auction. The ALAC also notably does not support a total ban of all forms of private resolutions, but we is strongly in favor of disallowing forms of private resolutions, detailed in the ALAC statement.*

## **[Proposed Consensus Policy on Protections for Certain Red Cross and Red Crescent Names in All Generic Top-Level Domains](#)**

*The ALAC continues to take the position that as a humanitarian organization, and one that has been regularly the target of those seeking to fraudulently attract donations, the Red Cross should be afforded the courtesy of having its various identifiers protected at the second level in gTLD domain names. The ALAC cited its June 2018 statement of support for the Initial Report on the Protections for Certain Red Cross Names in all gTLDs - Policy Amendment Process, and affirmed support for the Reconvened WG's recommendations on proposed amendments.*

## **[Initial Report of the New gTLD Auction Proceeds Cross-Community Working Group](#)**

*The ALAC have been following this issue closely, and discussed the issues internally prior to the issuance of the Initial Report. The ALAC discussed each of these mechanisms among the participants and members of the working group, and in their statement commented on Recommendations 1-10, noting it believes strongly that At-Large Structures (ALSes) and Individual members should be able to apply for funds; the proceeds from past auctions were intended for use in capacity building activities enhancing the mission of ICANN and consistent with one of its core principles for an "open and interoperable Internet", for the benefit of the Internet community.*

## **[Competition, Consumer Trust, and Consumer Choice Review Team \(CCT\) Final Report & Recommendations](#)**

*As the principal voice of Internet end users within the ICANN community, the ALAC were interested in the findings and recommendations from the CCT Review, particularly in the areas of Choice and Trust. The ALAC is supportive of all of the recommendations in the Report, including the new ones relating to DNS abuse in New gTLDs. The ALAC reiterated they do not share a sense of urgency when it comes to subsequent procedures, but instead believe the community should address all of the deficiencies in the 2012 program before accepting additional applications. The ALAC commented on additional sections of the Report and Recommendations, including Recommendations 1, 8-10, 11-13, 14-25, 29-31, 32, 33 and 34-35.*

## **[Draft Final Report of The Second Security and Stability Advisory Committee Review \(SSAC2\)](#)**

*The ALAC is in support of the SSAC's continued role in the ICANN community as an Advisory Committee. It commented specifically on Recommendations 1-5, 8, 10, 12, 14, 16-17, 21-22, 24 and 25 in the Report, noting that the SSAC should, in addition to revising its advice to the Board, also simultaneously attempt to write advice in such a way that non-technical experts in the ICANN community more easily understand them.*

In addition, the "**[Follow-Up to the Joint Statement by ALAC and GAC: Enabling Inclusive, Informed and Meaningful Participation at ICANN](#)**", was submitted by Maureen Hilyard, ALAC Chair as ALAC advice to the ICANN Board.

## ALAC News

ICANN functions in a global context and the pressures of the Christmas season, although they heavily affect the NARALO part of the ecosystem, are not felt by all. So, despite a brief closure of ICANN headquarters over Christmas, the work continues at a rapid clip.

The first few days of January saw ALAC finalizing and voting on comments to two major policy processes. The ALAC ratified comments on the Initial Report of the Expedited Policy Development Process (EPDP) on the Temporary Specification for gTLD Registration Data Team - a very intensive and time sensitive process designed to bring existing WHOIS obligations in line with requirements of the European Union's General

Data Protection Regulation (GDPR) - and the Supplemental Initial Report on the New gTLD Subsequent Procedures Policy Development Process (Overarching Issues & Work Tracks1-4) - which focused on potential changes to the processes, particularly regarding auctions and other dispute resolution forms, which would govern any further round of a new gTLD program. As with all such work, the comments submitted seek to present the Internet end user perspective in these debates.

With ICANN64 in Kobe now coming into focus, ALAC leadership is designing a program that would highlight the work ALAC members are immersed in -- both on the policy and outreach side. Meanwhile, requests for comment on a number of interesting issues have arrived in our mailboxes. One of these concerns the draft ICANN Strategic Plan for 2021-2025. One of the five strategic objectives is to "improve the effectiveness of ICANN's multistakeholder model of governance." This is a must-read for all At-Large members, and it will certainly be a key topic for discussion over the next few months.

Since its kickoff during ICANN63, the [2019 NomCom](#) has been working within established subcommittees and with ICANN staff to implement processes and solutions to support the recruitment, assessment, selection and reporting phases of our work.

We are currently in the recruitment phase where we are focused on candidate outreach in search of qualified candidates to fill 3 Board seats and 7 other leadership positions on the ICANN Board. The candidate application period is scheduled to begin in mid-January 2019 and to end in March 2019. The job descriptions and criteria will soon be posted on the [NomCom website](#).
