We are fast approaching the next ICANN meeting which will be held in the NARALO region in Montréal, Canada. This meeting is considered to be the ICANN Annual General Meeting (AGM).

It will also be the meeting where some people leave their leadership positions and new ones move in. I'd like to thank those who are departing for their hard work and support and welcome the incoming representatives to their positions.

The At-Large organization continues its ATLAS III preparation (more on this in our next edition). Also, Glenn has been very busy coordinating the 2nd North American School of Internet Governance (NASIG 2019), a world class event happening Oct 31 - Nov 1 just before the start of the ICANN meeting. ATLAS III

ATLAS III will take place 4-7 November 2019 during ICANN66 in Montreal. There will be a series of ATLAS III plenaries followed by break out sessions. All ATLAS III will be asked to participate in the EPDP Phase 2 Plenary and the GAC meeting with the Board as learning exercises. ATLAS III

We only have days to go to ATLAS III and yet it only seems like yesterday that we were putting forward a proposal to the Board for some funding. It has been nearly 18 months since we began planning for this event and it is now finally in our sights. Those who are traveling to Montreal are going to find themselves engaged in an important policy issue and being involved in the sort of discussions that many of us in At-Large are engaged in within the the At-Large Consolidated Policy Working Group (CPWG) as well as mainly GNSO Cross-Community Working Groups (CCWGs).

The program has been coordinated so that participants are engaged in Plenary sessions and also in different breakout groups depending on the activity. We are having a working lunch which is being sponsored by the Internet Society, and at that meeting we will be discussing the complexities relating to Regulation of the Internet, and how that will impact Internet end users. We are very lucky to have a generous sponsor who will be providing a networking cocktail event, so that people can meet others from the wider community as well as to have some social time with their At-Large colleagues and RALO leaders.

Below is draft text from our ATLAS III Communications Strategy to remind travellers and others as to what we aim to achieve from the ATLAS III event.

The purpose of the ATLAS III event:

ATLAS III is an assembly of future At-Large Ambassadors, focused on developing and nurturing
their abilities to become thought leaders and change agents who will implement what has
resulted from the At-Large Review Process, namely, more effective participation of At-Large
members in the policy advice process.

Rationale:

 Change is inevitable and ongoing.. ATLAS III Ambassadors, as change agents and thought leaders, must be prepared to help At-Large and its members to adapt to future social, environmental, technological etc changes which will impact ICANN and At-Large.


Objectives:

At all times I found him either a worthy debate opponent or a skilled partner in advocacy, combined with a calm and upbeat tone so rarely found in these corridors.

ALAC Member Update



Marita Moll (Telecommunities Canada) is the NARALO appointee to the At-Large Advisory Committee (ALAC). She gives us an update on this month's ALAC activities.

I am astonished at how quickly time goes. I have almost completed my first year as your NARALO representative. It has been a roller coaster that shows no signs of slowing down. The upcoming ICANN AGM in Montreal will be extremely busy. Some of our members have organized North American School of Governance (NASIG) at the front end. An intensive leadership development session (ATLAS III) will be consuming some of the meeting proper. At Large volunteers are working overtime to fulfill their commitment to bring more end users on board and expand the reach of ICANN's multistakeholder system.

I am currently working on two major projects. For the last year, ICANN constituencies have been asked to identify the issues that need to be addressed in evolving the multistakeholder model. The issues identified are: prioritization of the work; precision in scoping the work; efficient use of resources; roles & responsibilities; a holistic view of ICANN; representativeness + Inclusiveness; culture, trust, and silos; Complexity; and Consensus. We are now looking for ways of addressing these issues and determining where the responsibility lies for doing that.

The other interesting item in my current policy calendar concerns the public interest commitments (PICs) offered to the community by Amazon.org in return for having been awarded the .amazon top level domain. The community is asked to comment on whether or not these PICs are appropriate. You can read the text of the Board decision and the resulting PICs here. At Large is still developing its response which is due Oct. 14.

ICANN: North America Stakeholder Engagement Team Update

Fall is here, and we are rapidly approaching ICANN66 in Montréal. I look forward to welcoming many of you to the beautiful city, and I hope that those of you who can't make it in person will follow online. I would like to take this opportunity to update you all on some of the activities going on leading up to ICANN66, as well as other engagements in the region.

Pre-ICANN66 Event

On 7 October, ICANN is organizing a "pre-ICANN66" event in Montreal to engage local stakeholders and get them excited to follow and participate in ICANN66. The event will be held at McGill University and will feature a small panel of subject matter experts, many of whom you are familiar with, discussing the latest happenings in the ICANN community and what to expect at the meeting. The event will be followed by a small reception at a different location. More details will be shared as they develop.

ICANN66 Preview Week

Second, on 14 October there will be a webinar as part of ICANN 66 "Preview Week". "Global Stakeholder Engagement (GSE): What To Expect at ICANN66 - a Newcomer-Friendly Guide", will cover the basics of ICANN, the community, structures, and topics to be covered at the meeting, as well as other topics that would be of interest to newcomers. University Tour

Finally, as part of the global academic engagement strategy at ICANN, GSE team members frequently speak to students and faculty at regional universities. Over the past several years, we have met with classes, student groups, and professors to connect them with what is happening at ICANN. These visits have resulted in an increase in the number of fellows and NextGen participants in the region. To that end, Joe Catapano, Manager for Stakeholder Engagement in the region, will be making two visits in November to further our engagement goals. He will be at Southern Methodist University in Dallas, TX on 13 November, and at Arizona State University in Phoenix, AZ on 18 November. Both universities will be welcoming Joe back after previous successful visits over the past couple of years.
