So let's just go to Number 2 then. Travel plans I just wanted to make sure that everyone has gotten their papers. Do they have any problems? First of all, for those of you who are traveling are you good Raoul for IGF and LA? Those are the two most pressing I guess.

Raoul Plommer: Yes I am flying there and back with Tapani and (unintelligible). And so that

is for the IGF. I even have the same hotel as them. And for Puerto Rico I

Poncelet Ileleji:

Yes the American Red Cross were a part of NPOC. And I see no reason what Carlos was saying about (unintelligible) NPOC. The American Red Cross were a part of NPOC.

And I think if the global Red Cross body wants to be part of NPOC they will be part of NPOC if we want them to be part of NPOC.

So the American Red Cross and I think (unintelligible) was still part of NPOC. I am not sure about the American Red Cross they were very active (unintelligible). One of the first precedents of shares NPOC was the American Red Cross. At least it was still involved in the committee (unintelligible) affiliate with them.

Just as it had happened with (unintelligible). So I think if Raoul and yourself want to approach Red Cross (unintelligible) we should remember that if Geneva represents community in Geneva there is nothing wrong in doing this.

I personally suggest that we get a little bit more organized so that we know what we are inviting them to be a part of. And I think we are on our way to do that. So maybe we can follow up with a discussion in January.

And then moved over to (unintelligible) processes that are also within NCSG which are also like the (unintelligible) which Tatiana and Ayden were involved with or worked on the draft. What has happened is that all the things whether it is public comments or contributions (unintelligible).

Likewise (unintelligible). What happened with as (unintelligible) we have to – NPOC has to come in with direct its own direct response to public comments, you know. Maryam Bakoshi: Hi Joan, thank you. This is Maryam Bakoshi for the record. So there are new

members. I think we've got - well there are new members who have applied.

I think we've got four applications but EC is going to review it in January,

some time the middle of January. Those applications will be reviewed.

Thank you.

Joan Kerr: Okay, great. One thing as well, Maryam, Poncelet was saying that we should

start to use on boarding -- which I absolutely agree on -- and I've had a

conversation with Juan and Agustina via Skype and we've agreed to do a little

booklet of -- well that's what I've wanted but we'll see -- and what came back

was Agustina, I said that the on boarding program would take care of all the

printing, but they are not taking care of all the printing.

Is ICANN, can we as NPOC apply to get a little booklet printed for NPOC?

Right now we're just talking about the state of it, not the content. Okay, so

they can. It's up to ten pages -- a small booklet. So that's a yes? Great, I will

get back to them and tell them that we can do that. And I guess it's time sensitive, so it's for - we're targeting to launch it for Puerto Rico, so I will let them know that then. That's great, thank you.

All right, Communication One hasn't joined us. I think he thinks it's 10 o'clock. I have not - so the next one is Olivier. I have not seen any actions on Trello from Olivier, so I will follow up with him. I've (unintelligible) to see if there was any discussions but there wasn't.

All right, so financial update, last time - Maryam, you're going to follow up with Rudi to see what's the issue. I had spoken with Sam and he hasn't heard anything. Have you followed up or heard anything from Rudi?

Maryam Bakoshi: Hi Joan, thank you very much. So yes, I tried to contact Rudi but he's not online and he's not responding. And I didn't want to go through the email (unintelligible) just yet. I just wanted something informal with him just to ask him where we are with things. I think it was Sam who was supposed to send the details back to him.

He hasn't responded yet, so I'm thinking maybe Sam could approach him directly at this point to say, "Okay, I have sent this information to you. I've not heard anything back yet." That's what I, you know, that's the update I have now.

Joan Kerr:

Okay, so for the - when I spoke with Sam he said he's going to try to close this for the February meeting, so by LA he said. So hopefully I'll follow up with him again, because they need to close and have our budget in papers in place in case, you know, this is really dragging on. So all right, I will follow up with that then, just push that as well.

state, they have - I think when - if we can become closer and more

collaborative with NCSG -- it's really NCUC -- when they're doing outreach

like, we still need to compare it with the old document. I don't think we got

any of that done yesterday. So we need to do that by our next meeting.

But we did go through pretty much about little over half the document yesterday, with all the issues that were there and we added some in there already that we used to have in the old document. So I mean, we just need to

plow on and, like, get it done.

Joan Kerr: Great, Raoul. I really think that we're really getting an understanding of how

we will function and I think that's probably the best impact that the charter

will have. And we're talking about how is it going to work? You know, how

will it function? And I think it's very smooth and streamline approaching it,

so for that reason I like it.

Raoul Plommer: It's looking good.

Joan Kerr:

The Web site - yes, yes. And I think you're doing a good job in really checking and making sure everything is aligned. And I think that's - I think it's coming along well.

All right, so if we, you know, if we can launch it in the next three months, I mean, I think that's a pretty good goal, because, I mean, this was left for us to do, you know, and it was supposed to be done a year ago. So we're doing a good job and I think a very - yes, so I'm actually proud of what we're doing.

The Web site, so let's talk a little bit about - if you could put the agenda up a little bit, Maryam, please. Great, thanks. So the Web site -- (Juan's) not here -- I really think that we need to put a section on the Web site for member profile, or active members, and invite the members to put their information in.

Right.

Joan Kerr:

Yes.

Man: Yes, that's a good idea.

Joan Kerr: Yes, well we have to start getting our members involved, and one way is for

them to see - yes. And then this way we can communicate with them, for

example, if we're going to IGF, so I would see Raoul, you as the

representative in that region (unintelligible) that they meet you and you build a relationship. This is what we need to do. So the only way we can do that is if they're involved and they know where we're going to be and how they can

outreach - reach out to us, right?

Man: Right.

Joan Kerr: Yes. So member profiles, I think, is a big - I'm doing my action plan and I'm,

you know, thinking about financial Web site, the policy, how it's all function.

So that would be my big thing for the Web site.

And you were going to, Raoul, you were going to integrate the Trello with the

Web site, right?

Raoul Plommer: Yes, that's still dragging on.

Joan Kerr: Right.

Raoul Plommer: I'll try to get it done before Christmas, but it's just like...

Joan Kerr: No, no, no, don't do that. Yes, don't do that. Let's try to block in the next

three months to get some of this stuff done, okay?

Raoul Plommer: It'll definitely be up by the inter-seasonal. I mean, it's like...

Joan Kerr: Right.

Raoul Plommer: I'd say it's something like a four to eight hour job to do it properly. So it's

not really that long. But it just needs a lot of concentration and sort of - it's

sort of hard thing to get around to.

Joan Kerr: Great. And one of the things that we need to do - go ahead.

Raoul Plommer: For the Web site, I think the best way to do it is sort of make a form for our

members and then they fill that form and that could give us a table where they have these member profiles. So I think that would probably be the best way to

do it. It would be sort of quite automatical. And we shouldn't need to do...

Joan Kerr: Okay.

Raoul Plommer: ...that much copy pasting.

Joan Kerr: Right, okay. So they can upload it. And then what we need to know, if we're

going to do a form, we need to know what their organization, what issues they're addressing so that we can go to them when we have these policy

comments. And, you know, we can directly go to the people who are dealing

with those specific items. You know, that's what I would like to - do you

understand what I mean?

Raoul Plommer: Yes, yes. I mean, it'd be nice to have sort of a list of the resources, of human

resources we have on different issues. Right?

Joan Kerr: All right, yes. All right, so the next one is - oh by the way, I think the Web

site is looking good. We just need to add more content and one of them

would be the profiles. It's very good. The thing that you mentioned was a LinkedIn as well. I think that's...

Raoul Plommer: Oh yes.

Joan Kerr: We've got to start to do the connections, right?

Raoul Plommer: Yes. Yes I did a profile for LinkedIn for NPOC, so that's something that

people can now link themselves to.

Joan Kerr: Great. All right, so I have been looking at the work of - when I say tracking

the work of the EC, the things that we have to get done. So I have been doing

that to make sure - aligning it to the charter, what our responsibilities are. Of

course, it's always the upfront work that's the biggest one that's done. Then

you can just add in our responsibilities and what we're doing. So these are all

things that are taking time, but that's great. I am doing that.

I really think that Trello is not being used properly, so we need to start or add

duties on that.

Raoul Plommer: Yes.

Joan Kerr: So, because it's the easiest thing to do. All right, and I think that - Poncelet,

did you have anything else to say about your policy work? You did already,

but if you have any other comments. Poncelet? He may be on mute, but he's

already given us some comments.

I typically see the reports; it's work that has been done and work to be done.

So that's why they're there twice.

Okay, so Raoul, you're in the RDS working group. Are you able to give us - are you in it, first of all, and can you give us a report?

Raoul Plommer: I am in one of the sub groups, but they haven't convened, apart from one time

since Abu Dhabi.

Joan Kerr: Okay, so just let us know if there's anything that we have to address. And

enhancing accountability, there is a LinkedIn document for comments, but

we're going to look at (Poncelet's) comments as a constituency. And then we

can make our own as individuals, but I just think we're an organization, so

following the organizational theme, that we should have an organizational

response and then people can respond as an individual. So that's sort of the

strategy.

And sorry, somebody want to say something?

Raoul Plommer: No, just I concurred, yes.

Joan Kerr: Yes, great, okay, any other business that we should be addressing at this

moment that we're just not looking at, at all? No? We're doing good so far.

Joan Kerr: Yes, go ahead.

Poncelet Ileleji: Reporting -- I think we have not for event, whether it's (unintelligible) and

stuff like that (unintelligible) to the membership, we should improve on it.

That's what I just wanted to add. Like, so for whether it's the applicant idea

that Olivier went to or the global IGF will be attending with Raoul on this

(unintelligible), what site updates, because our Twitter account has not been

updated, whether we can link it, we can link (unintelligible) Facebook (unintelligible) appears on Twitter so that it won't - if Raoul or (unintelligible).

You have admin rights. You can be able to just be posting stuff on the IGF, on NPOC, Facebook and also shows on Twitter. You know, so I just - those were the two things (unintelligible). Thank you.

Raoul Plommer: Yes, I think that's more...

Joan Kerr: Yes, I absolutely agree, Poncelet.

Raoul Plommer: I think that's thing Juan would do for the communications. I don't think - I'm

not sure if I even have the password for Twitter and Facebook accounts.

Joan Kerr: So that brings up another issue then regarding passwords that we should have

Maryam or staff have, you know, all of those passwords so that it's somewhere other than - and we should make a decision on who has the

(unintelligible) and all that kind of stuff. So we should - I'm going to put that

down on the next agenda.

But going back to (Poncelet's) main point about reporting, absolutely, we should be having reports on the Web site so people know what we're doing. So I'm going to start it out by doing this. I'm going to write a letter to or, you know, whatever, to the member saying, "This is what we're doing. Here are some of the things that we're working on. And this is what your constituency is doing."

And just so that they get a sense - but it will be a generic overall

communicating with the members from the chair, like the letter of the chair or

something like that.

And then, going forward, we need to put the content on the Web site. For

example, I will say, you know, "Olivier went to this event. Raoul went to this

event." And maybe link it to - I won't do it for the first letter, but in

subsequent months, you know, please read and get to know us, sort of thing.

And I think that was - we'll start the process of communicating with our

members of what we're doing, and that they see that we are reporting on

events we have attended.

So for example, when I go to IGF, I will write a report on. So that's an

excellent point. So let's absolutely do that and I will put that on the agenda

every month as well, which I did for Olivier this time. Does that sound like a

plan?

Raoul Plommer: Sounds like a plan.

Joan Kerr:

Great. So we've got a few actions, which is listed on the action items. I'm

going to (unintelligible) with Eduardo -- and I have that down -- talk to Ganga

and Juan about the leadership program, put the EC name. If everybody can

sort of look at the agenda, I'll send the agenda for the LA - for LA and people

can put their names to it.

I will be copying Sam because he is going instead of Poncelet on that email as

well, and try to follow up with Rudi and Sam with this budget, to get that

resolved. But it's kind of out of our hands, so I don't know. And Raoul is to

integrate Trello with NPOC.
