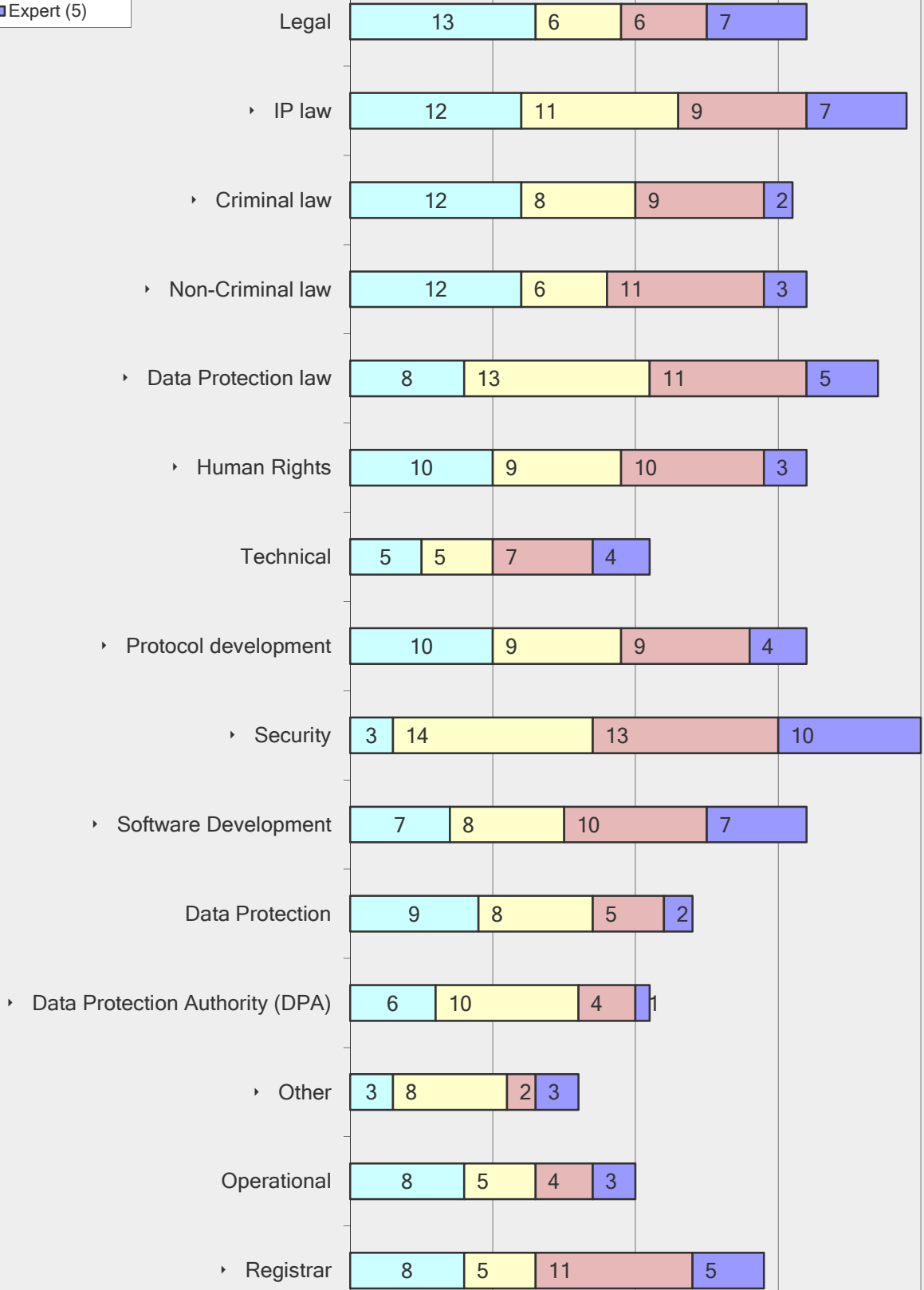

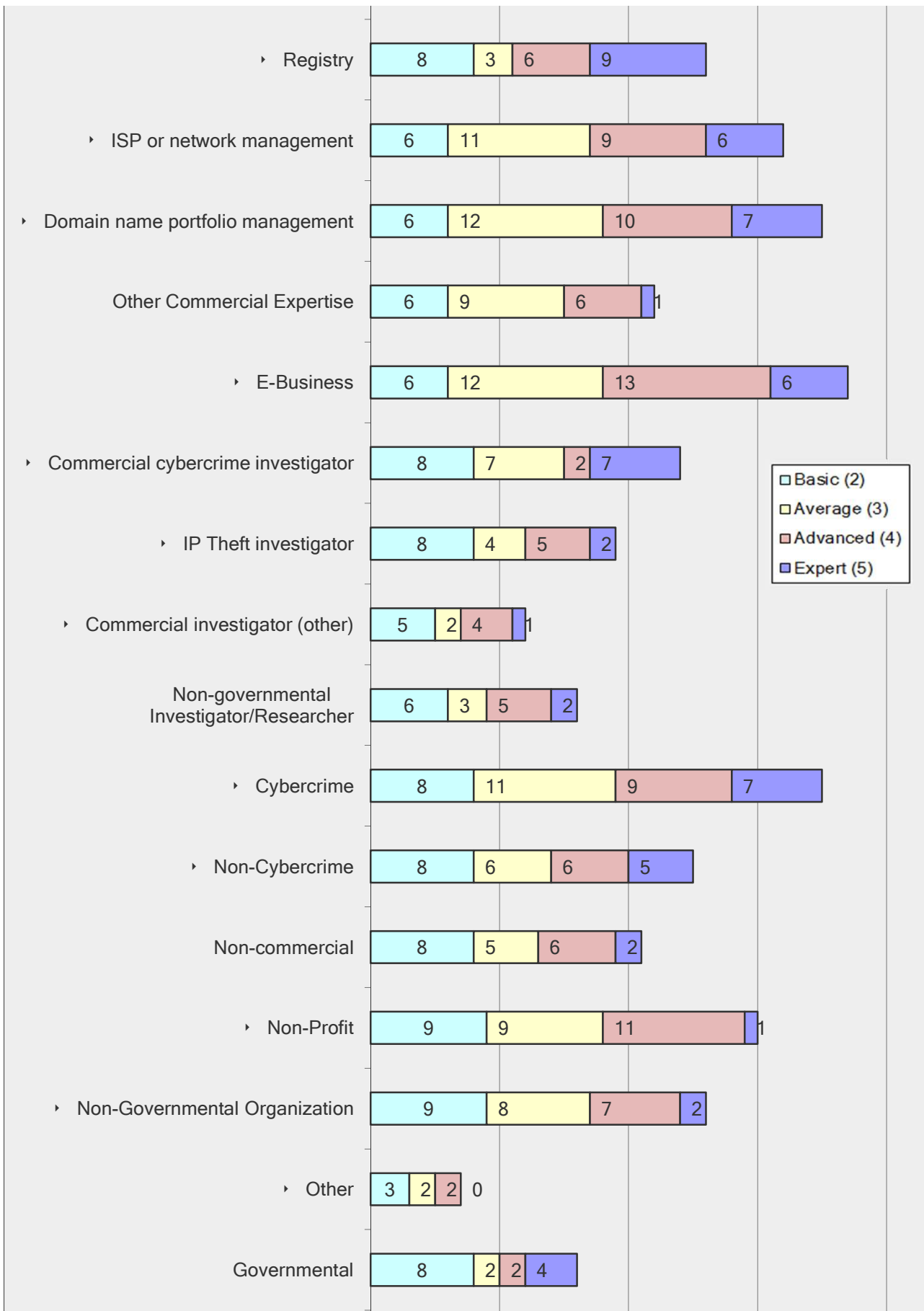

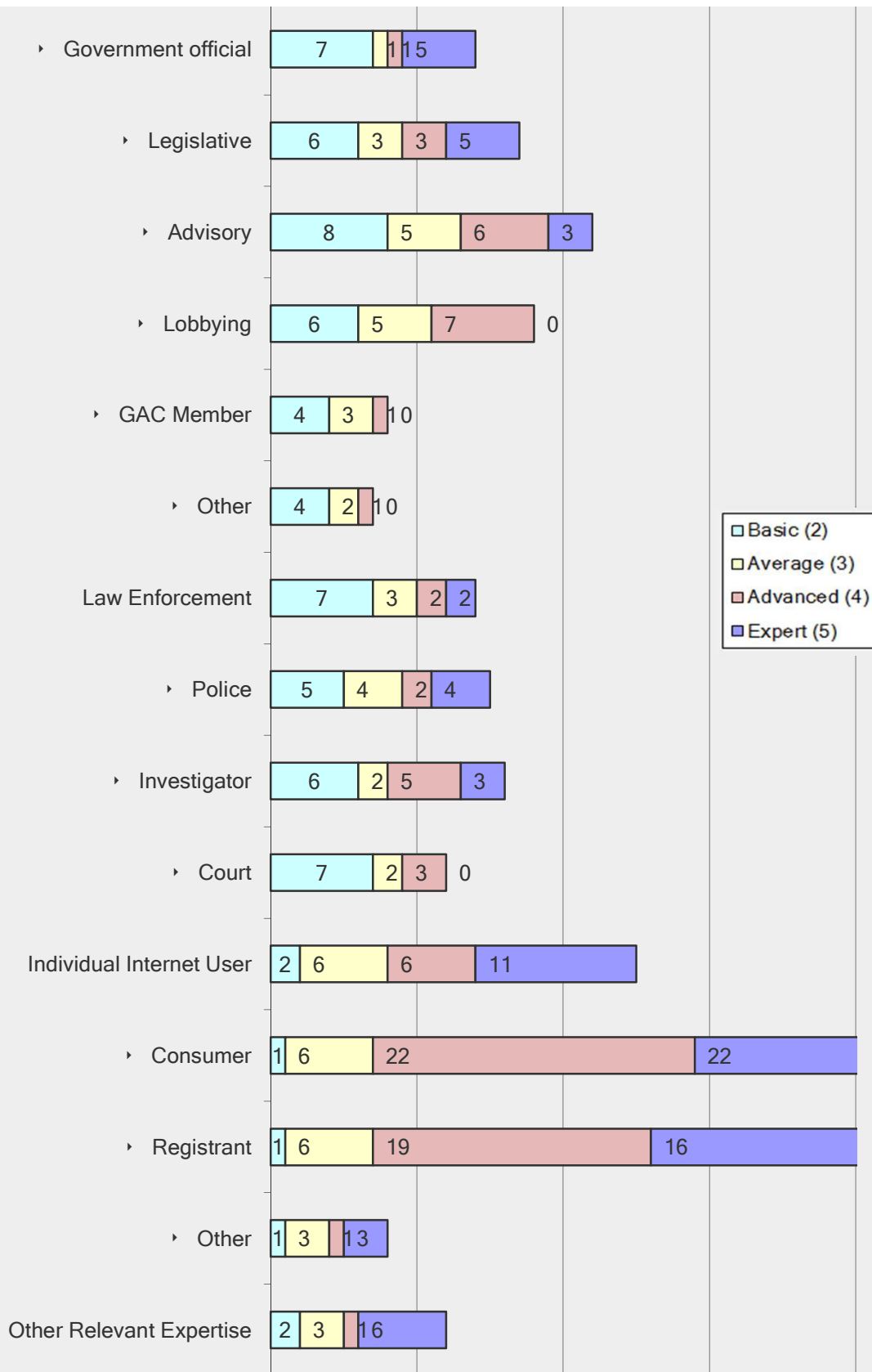
Areas of Expertise relevant to this PDP
