

## New gTLD Program Technical and Financial Clarifying Questions: Links / Available Materials

as of 28 Feb 2018

### Clarifying Questions (CQ) Basis:

Per the Applicant Guidebook: "As part of the evaluation process, evaluators may request clarification or additional information during the Initial Evaluation period. For each application, clarifying questions will be consolidated and sent to the applicant from each of the panels. The applicant will thus have an opportunity to clarify or supplement the application in those areas where a request is made by the evaluators."

Note: The term 'Clarification Questions' and 'Clarifying Questions' are used interchangeably throughout the New gTLD Program. The abbreviation CQ is used to refer to both terms.

### Technical/Operational and Financial Application Questions:

Questions #24 – 44 in the Applicant Guidebook (AGB) were related to Technical & Operational Capability.

- Questions #24 – 30 (a) were 'External'. The applicant responses to these questions were published in an HTML file on the New gTLD Application Status microsite page.
- Questions #30 (b) – 44 were 'Internal'. The response to these questions were assessed as part of the application evaluation, but the answers were not publicly posted.

Questions #45 – 50 in the AGB were related to Financial Capability and were 'Internal', not publicly posted.

### Supplemental Notes on Technical/Operation and Financial Questions:

Supplemental Notes were additional guidance published by ICANN to assist applicants in completing their applications. While they did not directly address Clarifying Questions (CQ), these Supplemental Notes included clarifications on evaluation criteria for some questions in the application. Applicants had access to use these as a resource to help answer the evaluation questions. Supplemental Notes were published online through ICANN's original CRM tool; however, the links to these articles expired along with the license to the CRM. ICANN org is following up internally to have these links re-established.
