



- III. **Topic 35:** Auctions: Mechanism of Last Resort/ Private Resolution of Contention Sets












Governance Model Proposed in RSSAC037








- **RSSAC** (Root Server System Advisory Committee)
 - "Standing" since ICANN establishment
 - advising the ICANN Board and community on matters related to the operation, administration, security, and integrity of the RSS
 - Topics discussed before and during ICANN69
 - Contract framework between each RSO and the overseer
 - How to measure RSS service quality from locations around the world
 - Definition of an rogue RSO
- RSS GWG (Root Server System Governance Working Group)
 - Feb. 2020 Jan. 2022 (planned)
 - core of the community-driven process to develop a governance model for the RSS
 - Topics discussed before and during ICANN69
 - Design of organizational structure to implement RSSAC037 contractor with RSOs, SAPF composition, ...
 - How to fund RSOs (if financial support needed)

Akinori Maemura ICANN Board Member



- A three-week long ICANN Meeting
 - Board Workshop sessions: starting on October 2, ending on
 October 12, Americas(-ish) hours from 2300h to 0400h (UTC+9)
 - Community Days: from October 13 to 15, European Time
 - Plenary Week: from October 19 to 22, European Time
- European business hours not a big problem for APAC region, huge problem for Americas, and longer than the previous two



Decisions

- Two-year Extension of CEO Executive Service Agreement
 - <u>https://www.icann.org/resources/board-material/resolutions-2020-</u> <u>10-07-en#1.a</u>
 - Now expiring in 2024, making Goran's service eight years long
 - Appreciating his service through tough time with IANA Transition, GDPR, and rise of DNS Abuse discussion
 - Expecting a long-term stability, full coverage of FY21-25 Strategic
 Plan amongst many
- CCT-RT Review: Pending Recommendations
 - <u>https://www.icann.org/resources/board-material/resolutions-2020-</u> <u>10-22-en#2.a</u>
 - 17 recommendations pending since March 2019, 11 out of 17 approved now

 - Chris achieved full nine-year service on the Board with countless contributions
