


APAC Space Survey 2017

Survey Objective: To gauge APAC community interests and priorities regarding current ICANN-related policy issues that can be discussed at APAC Space.






Q: Which ICANN community group(s) have you participated in? Select all that apply



- "Discussions usually monopolised by "experts" who have been there so long they are institutionalised. Discussions usually also already in progress and not possible/efficient to contribute."




How can APAC Space be improved?

- Discuss topics more closely related to this region
 - Focus on what is happening in or specifically relevant/unique to APAC region
 - Regional or country level discussion on what is/is not working especially related to Domain Names, IDNs and policy discussions and their impact on the region
 - Should not repeat information about ICANN activities/issues which are available or has been presented elsewhere
- More inclusive engagement and interaction
 - Involve youths, universities, private sectors, etc.
 - More outreach to community at large
 - Create and support community champions in the region
- Sub-regional/national focus
 - Focused capacity building
 - Country host
- Connectivity issues
- Increase depth of the materials




