On behalf of the AFRALO Chair, Seun Ojedeji, kindly find attached the AFRALO/AFRICANN Statement entitled "Status, Impact and Recommendations for Universal Acceptance (UA)in Africa", which was discussed and approved at the ICANN 69 Virtual meeting.
