





Connection of At-Large respondents with RALOs



1) Mission & Purpose

No disagreement on the importance of the mission of At-Large. Needs to be defended

But many questions about the **Mandate & Accountability** of At-Large Leadership

Only **4.3%** of At-Large respondents think that the current population of ALSes really represents end-users




The At-Large Community has evolved: is it still fit for purpose?
