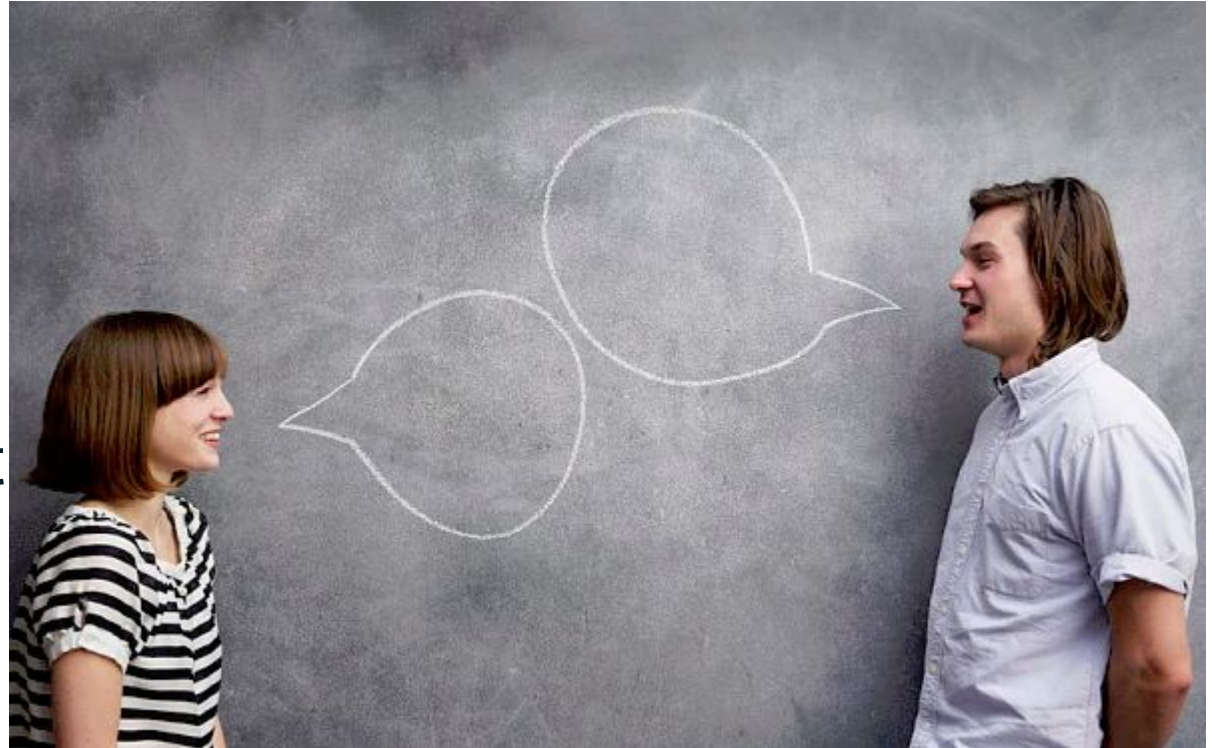

Javier Rúa-Jovet

In May 2013, the Honorable Alejandro García Padilla, Governor of the Commonwealth, named Rúa Chairman of the Telecommunications Regulatory Board of Puerto Rico. On June 27th he was confirmed by the Senate, with tri-partisan support, and initiated his four year term on July 1st, 2013.

Rúa-Jovet presides the Latin American Forum of Telecommunications Regulators (Regulatel) as 2015 Chairman and will continue as Vice Chairman during 2016. Regulatel is comprised of 23 Latin American and 3 European regulators (Spain, Italy and Portugal) as full members.

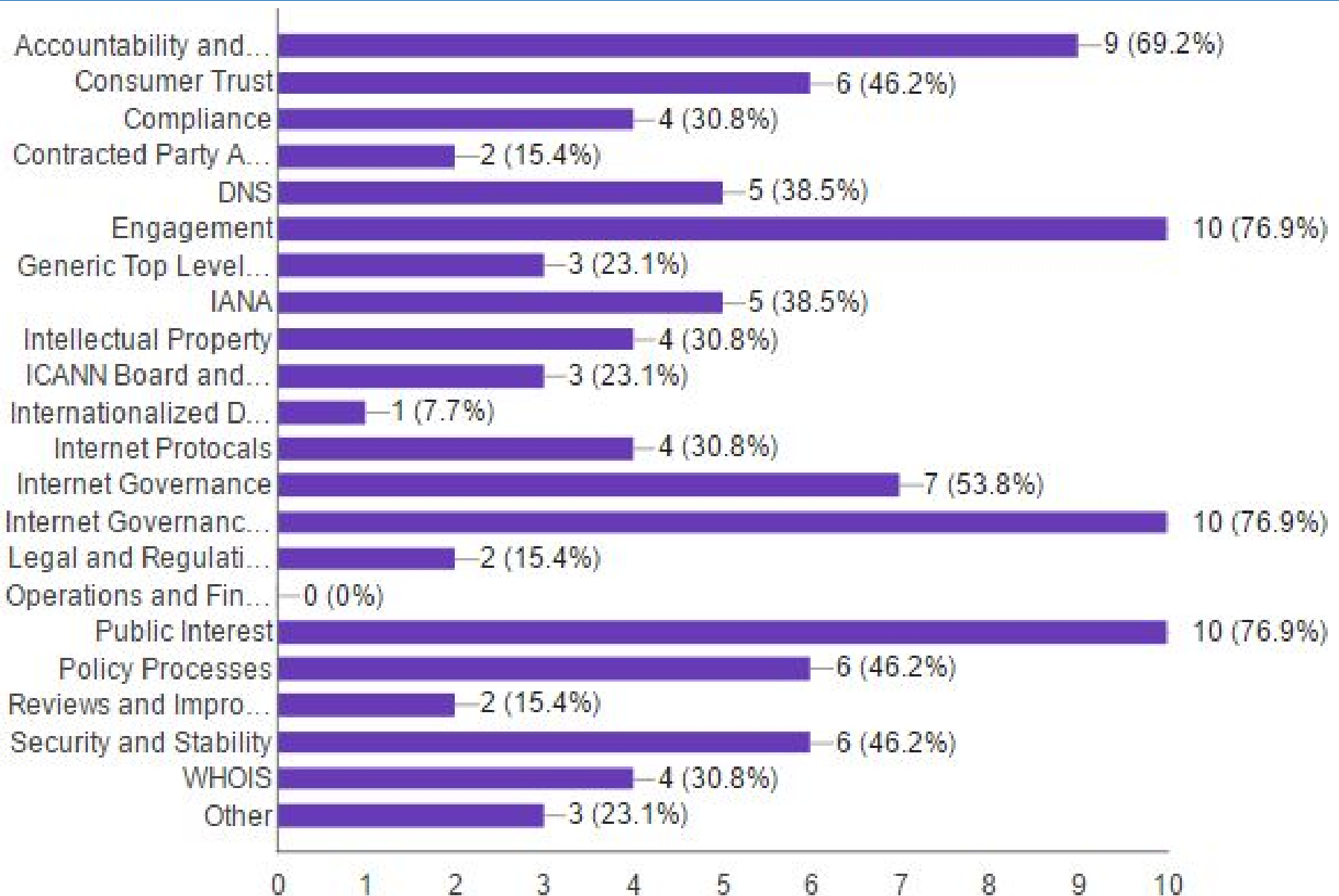

- ◉ ICANN 57 has been moved from PR to India resulting in a major loss in the NARALO Outreach in San Juan which had been spearheaded by Eduardo Diaz and Alfredo Calderon.
 - GSE agreed to sponsor one person from ISOC PR to go to the IGF Mexico- Eduardo Diaz will attend the event
- ◉ NARALO General Assembly will instead coincide with the ARIN33 in New Orleans in April 2017 instead of ICANN 57
 - Outreach to predominantly North American organizations at the ARIN meetings
 - Leverage the MOU with NARALO and ARIN
 - One Cropp Trip to ARIN 30 in Dallas in October where Leah and Alfredo attended

- **The Dot Mobi domain was approved by ICANN on 11 July 2005**
 - DotMobi domain names have been available for registration by the public since 26 September 2006
 - In February 2010, **Afilias** acquired mTLD Top-Level Domain Ltd. (known publicly as "dotMobi")

ALAC Member report-Tim and Garth

- The importance of the ALAC has been augmented by the IANA transition; its place among the constituent groups of ICANN has been established and recognized
- Under the impetus of Garth Bruen the ALAC is pushing for recognition by ICANN that ALAC has the responsibility for consumer protection within ICANN
- ICANN continues to be ambivalent about whether consumer trust and protection fall within its mandate; more work remains to be done.

Reports

- Phase 2 of Captioning Pilot will launch in Jan 2017
 - Have a few technicalities to correct before launching
 - Making sure new Adobe connect is stable and the bugs are worked out
 - Making sure that polling is working correctly for mobile users
 - Will also experiment with web based polling for those who can not see the Adobe Polls and also for those who watch a recording of a session with captioning so we can capture their feedback for our metrics analysis
- Phase 2: English only and for 6 calls

Rules of Procedures

Work in Progress

- Recruited volunteers from many ALSes to join this review process
- Work will begin in December 2016 after the ICANN meeting
 - Work had been delayed since we were waiting for the conclusion of the ALAC ALS Criteria and Evaluation
- Aim is to rewrite the Rules of Procedure so that NARALO's Governance will be more effective
 - Consistent with other RALO ROP
 - Clarify ALS obligations
 - Clarify ALS communication
 - Clarify the decertification process
