Rubens Kuhl:Avri, the possible interaction is that if the policy allows 1-char IDN in some languages, the reserved IDN name list might need to be revised.

Avri Doria: and we can always schedule a joint meeting of two track teams

Rubens Kuhl:We have the benefit at 2016 of having LGR (Label Generation Rules) defined for many languages, something not available in 2007.

Phil Buckingham: Avri, it is doesn't actually specify IDNs reserved names per se - just "review of the composition of the reserved names list"
