Tom Dale (ACIG GAC Secretariat):Diversity is also an issue for CCWG-ACC WS2

Donna Austin, Neustar:I think the IPC comments were addressing consumer trust

Jeff Neuman: Diversity in registrants is but one form of diversity. But diversity in usage by consumers is another.

Michael Flemming:Dotbrand even in itself is not just a one way usage, the use of the TLD itself has a very diverse ecosystem.

Paul McGrady:Diversity needs to be defined in a way that includes new uses other than just more sales of second levels.

Jeff Neuman:@Paul - Agree. Emily, can we reflect that in the notes

Michael Flemming:+1

Emily Barabas: Yes, we will make sure it is captured

Julie Hedlund:@Jeff: I am taking the notes and will include it.

Greg Shatan:I support Paul's comment.

Paul McGrady:+1 Kristina.

Kavouss Arasteh: It would good if we have a non exhaustive list of diversity

Kristina Rosette (Amazon Registry):+1 to Avri (streamlining application process could increase diversity)

Michael Flemming: Should we look at diversity from a Community standpoint, as well?

Jeff Neuman:I think we should collectively offer a definition of diversity in the full group and then farm out certain portions that relate to the Work Tracks

Michael Flemming: Agreed, diversity will extend across all of the individual Work Tracks.

Jeff Neuman:@Kavuouss - I believe that we should offer our own list of diversity factors (and should make that an action item)

Jian Zhang_KNET:@Jeff agree!

Cheryl Langdon-Orr (CLO):Yup

Jeff Neuman:Kavuouss said it better than I did :)

Donna Austin, Neustar: I think I'd just say that I think it largely supports what Kavouss said.

Jeff Neuman: I agrree that the comments that were submitted were pretty clear.

Greg Shatan: you read it well, Avri.

Paul McGrady: Well writtem + late at night for many = a quiet crowd.

Michael Flemming:Yes

Jeff Neuman:yes

Donna Austin, Neustar: Kavouss asks a good question. 1229 registry agreements have been executed to date.

Kavouss Arasteh:wE BADLY HERAING YOU AS THERE IS A SUBSTANTIAL LEVEL OF hum

Julie Hedlund:@Kavouss: Staff are trying to capture the summary in the chat.

Kavouss Arasteh: Thank for clarication Grec and Jeff

Paul McGrady:@Donna, perhaps but contracts aren't the same thing as use. Perhaps .brands would be further along if we didn't have to spend months and months just getting recognized as distinct category via Spec. 13.

Donna Austin, Neustar:@Paul, agreed but it is one measure of where we are in the process.

Michael Flemming: So we have to highly consider "benefits" in the relative aspect of how categorized TLDs use them. Looking at the application process and where we are at in that to start measuring benefit cannot be done equally across the spectrum.

Paul McGrady:@Jeff, how about concrete issues such as if we end up with the scale of applications some have mentioned (10,000?), which will create new pressures on Staff.

Kristina Rosette (Amazon Registry):Not to put words in the IPC's mouth, but were they referring to reasonably foreseeable? Jeff Neuman:@kristina - Probably....but just trying to make sure

Kristina Rosette (Amazon Registry): Would be helpful to get that clarification. Paul? Greg?

Greg Shatan: We should also identify corner cases that weren't anticipated but did occur.

Jeff Neuman: We should highlight all cases we did not anticipate that actually happened...agree

Paul McGrady:e.g. "Surpise! No closed generics after all."

Jeff Neuman:Paul - IMO that was reasonably forseeable :)

Paul McGrady:surprise

Paul McGrady: Exactly.

Jeff Neuman:But spending 1.5 years debating what we would do if someone applied for .murder, .terrorism or .nazi was a little overkill :)

Kavouss Arasteh:if the session is continued, I am disconnected Kristina Rosette (Amazon Registry):I have a vague recollection of the Fast Track ccTLD IDN process not being so fast. Am I remembering correctly?

Jeff Neuman:Pun definately NOT intended Greg Shatan:Oy.
