Steve Coates:Press forward. Can hear you fine.

Paul McGrady:In addition to Appliant Guidebook Terms & Conditions and the Base Registry Agreement, we should also look at all mandatory contracts, e.g. Terms of Service for any mandatory Applicant Portal and Terms of Service for the TMCH (assuming that use of the TMCH remains a requirement in next Round/Window).

Rubens Kuhl:I was on the audio bridge and it dropped. Reconnected now.

Cheryl Langdon-Orr (CLO):yes obviously we need to liase Heather (madm coChair)

Alexander Schubert:doesn't look like there is much "output" from the cwg

Cheryl Langdon-Orr (CLO):Tht certainty makes sense to a *rather biased* me Heather

Heather Forrest:Thanks Cheryl

Cheryl Langdon-Orr (CLO)::-)

Phil Buckingham:good point rubens

Heather Forrest:If we can delay start on geo names until Hyderabad that would be ideal

Cheryl Langdon-Orr (CLO):agreed

Heather Forrest:Paul McGrady's hand is up
Michael Flemming:Yes, we will come to Paul in just one moment
Rubens Kuhl:Michael, one difference is that reserved means "no way one can apply" while IGO / NGO included, at least in 2012-round, a possibility to apply existed but it could be objected (LRO).
Michael Flemming:Sorry for the wait
Heather Forrest:The basis of the decision that Jeff points out (no reservation, per GNSO Reserved Names WG) was the lack of recognition of govt rights in geo names under international law, as concluded by WIPO
Alexander Schubert:I agree with Jeff!
Steve Chan:Perhaps add contractual obligations to the title?
Michael Flemming:That would offer clarity
Steve Coates:Breaking up, can't hear.
Paul McGrady:I can't really understand Jeff.
Alexander Schubert:Geo names (ISO 3166 Alpha 3 and territory names) at top level should be in this group.... where else?
Jeff Neuman 2:Sorry. I am on my cell
Jeff Neuman 2:I will write my explanation
Jeff Neuman 2:It is here because the second level restrictions are contained within the legal base agreement
Jeff Neuman 2:specification 5
Jeff Neuman 2:It made the most sense here
Cheryl Langdon-Orr (CLO):noted
Steve Chan:So yeah, maybe not the terminology specifically, but the current title is perhaps limiting
Cheryl Langdon-Orr (CLO):tend to agree there Steve
Alexander Schubert:grouping maybe in terms of processing here in this group - but there is no connection otherwise
Paul McGrady 2:Maybe "Legal, Contractual, and Regulatory"?
Phil Marano (Mayer Brown):IGO-INGO seems broader than reserved names, since it potentially covers curative rights, yes?
Jeff Neuman 2:I am fine with changing the title of the group to include contractual. That was what was intended anyway
Cheryl Langdon-Orr (CLO):great Jeff maybe "make it so"
Cheryl Langdon-Orr (CLO):*I had to get a Star Trek line in somewhere :-)
Cheryl Langdon-Orr (CLO):Yes Jeff prallell is going to be essential
Paul McGrady:@Jeff, thanks on the name change.
Jeff Neuman 2:@Paul - I hope I have the authority to change the name :)
Paul McGrady:@Jeff, pretty sure only @Avri has that kind of authority... :)
Cheryl Langdon-Orr (CLO):yes
Paul McGrady:This is a great time for North Americans. How do others outside of N.A. feel about the time of the call?
Cheryl Langdon-Orr (CLO):Works for me here in AU
Kristina Rosette (Amazon Registry):Won't the 3:00 UTC slot conflict with the meeting time for the full WG?
Emily Barabas:typically, the full group will meet on Mondays
Kristina Rosette (Amazon Registry):Got it. Thanks.
Emily Barabas:this week was an exception due to the US holiday
Kristina Rosette (Amazon Registry):Rotation is fine with me. Prefer that we avoid having work stream calls conflict with each other and with the full WG.

Alexander Schubert:Agreed

Cheryl Langdon-Orr (CLO):Works for me I hate 1500 UTC

Susan Payne:rotation fine with me

Emily Barabas:With the current suggested rotation, there won't be conflicts between the individual sub teams and the full team meetings

Cheryl Langdon-Orr (CLO):0300 and now is all good , but must avoid conflicts wheer possible

Rubens Kuhl:2000 UTC works fine in Latin America as well.

Cheryl Langdon-Orr (CLO):W hve found 1800 - 2200 UTC has a good ability for mny regions to work with in the past

Jeff Neuman 2:Allsorry I was off Adobe before, but when we said we are dealing with the "Base Agreement", I think we aredealing now only with the concept of whether to have 1 agreement to fit all, or whether we as a group support the notion of potentially having separate agreements for separate categories
