Those TLDs have DNS security and stability issues that are specific to telecom operators particularly IDN telecom Strings as well as IDN in general.

DNS security issues related to telecom operators and IDN stability and security issues in general need to be considered carefully in the SSR2 review team's work and with my experience I believe I can make key contributions particularly when I have worked with policy teams in the past.
