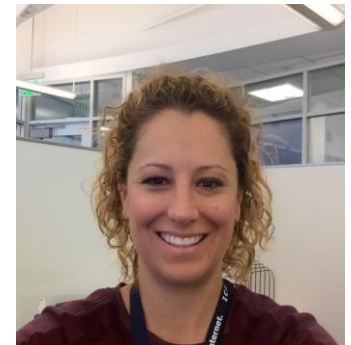

Planning Process Overview

- ICANN's objectives are described in its Strategic Plan for July 2015 – June 2020
- Work is identified and described in an accompanying Five-Year Operating Plan, which is reviewed and updated each year
- A fiscal year Operating Plan and Budget is developed each year
- Achievement and progress reporting happens throughout each year: using ICANN meetings, webinars, dashboards, and the portfolio management system

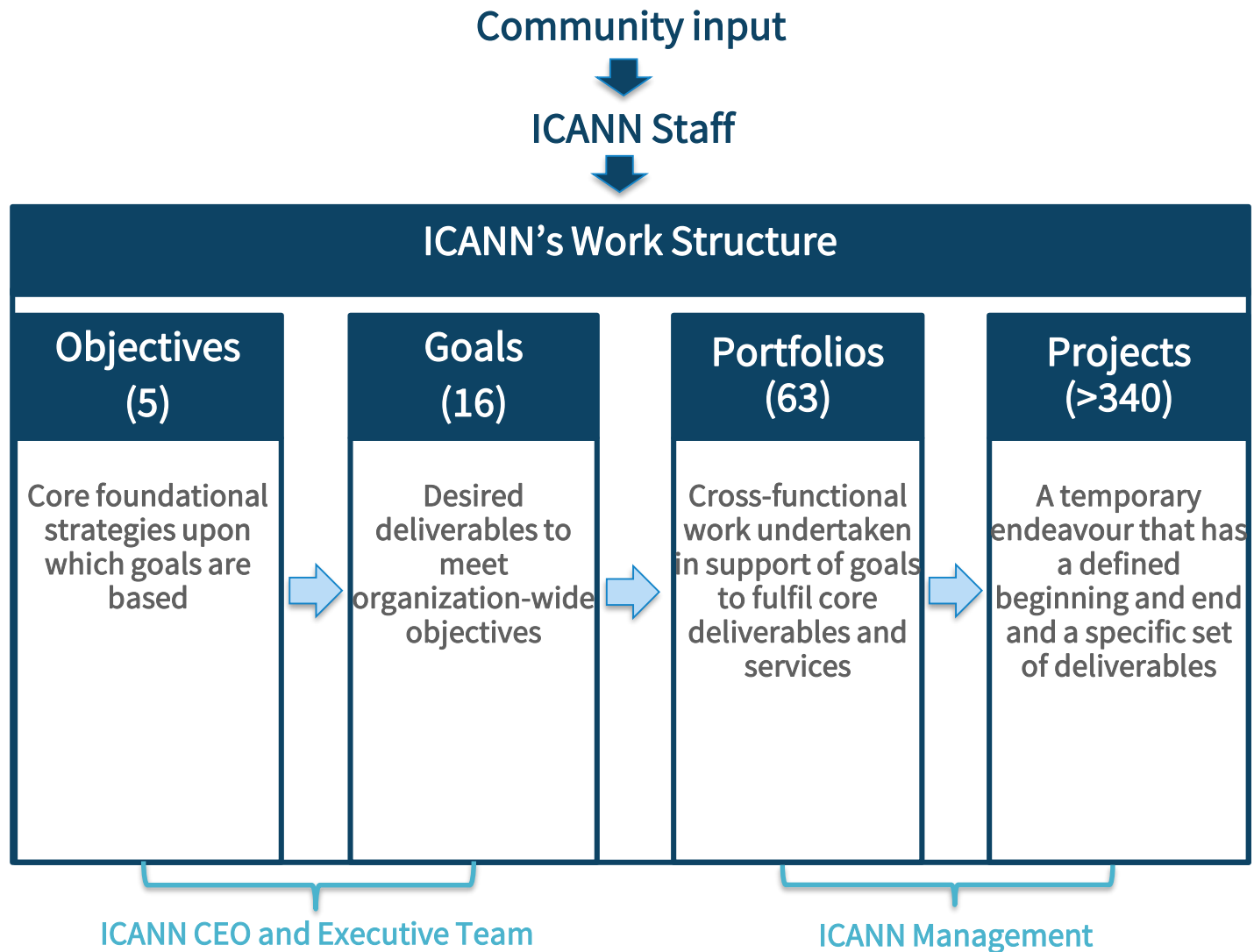
Planning Process



Document Overview

- ⊙ ICANN consults the community on its its draft plans every year. The five main documents published are:
 - ⊙ Five-Year Operating Plan update
 - ⊙ Fiscal-Year Operating Plan and Budget
 - ⊙ Budget Breakdown by Portfolio
 - ⊙ Budget Breakdown by Project
 - ⊙ “Top-15” Projects

Lessons Learned from FY17 Process

Strengths

- ⊙ Draft plans published earlier
- ⊙ Improved document quality
- ⊙ Longer, 54-day Public Comment period
- ⊙ More interaction with the community and process for answering clarifying questions
- ⊙ “Top 15” projects published
- ⊙ Improved Report on Public Comments

Areas for Improvement

- ⊙ Advanced scheduling for community webinars and calls
- ⊙ Community would like more detail in portfolio descriptions
- ⊙ Provide documents with several different level of detail
- ⊙ Formalize process for answering clarifying questions
- ⊙ Define a process to communicate important projects
- ⊙ Involve a wider group of participants in the process

New Features in the Process

- ⦿ CWG recommended that “PTI should submit a budget to ICANN at least nine months in advance of the fiscal year to ensure the stability of the IANA services. It is the view of the CWG-Stewardship that the IANA budget should be approved by the ICANN Board in a much earlier timeframe than the overall ICANN budget.”
- ⦿ “Caretaker Budget” for both PTI and ICANN to be developed for ICANN’s FY18 budget

Relationship of ICANN and PTI

- ⦿ PTI is a wholly-owned affiliate of ICANN incorporated in August 2016
- ⦿ PTI is a nonprofit public benefit corporation
- ⦿ PTI will provide the IANA Services when the NTIA contract expires
- ⦿ ICANN is responsible for providing the resources to support PTI's operations
- ⦿ ICANN's planning process includes a separate sub-process for the PTI Operating Plan and Budget

ICANN today announced that the incorporation documents for the "Post-Transition IANA" organization have been filed and received by the California Secretary of State under the name Public Technical Identifiers (which will now be referred to as PTI). With this filing and receipt, PTI is now formed as a nonprofit public benefit corporation and controlled affiliate of ICANN.



- ⦿ We started ICANN's FY18 planning by beginning development of the PTI Operating Plan and Budget
- ⦿ The PTI FY18 Operating Plan and Budget draft will be ready by 30 September 2016, 9 months before the start of the fiscal year (1 July 2017)

Planning Needs: Community Input

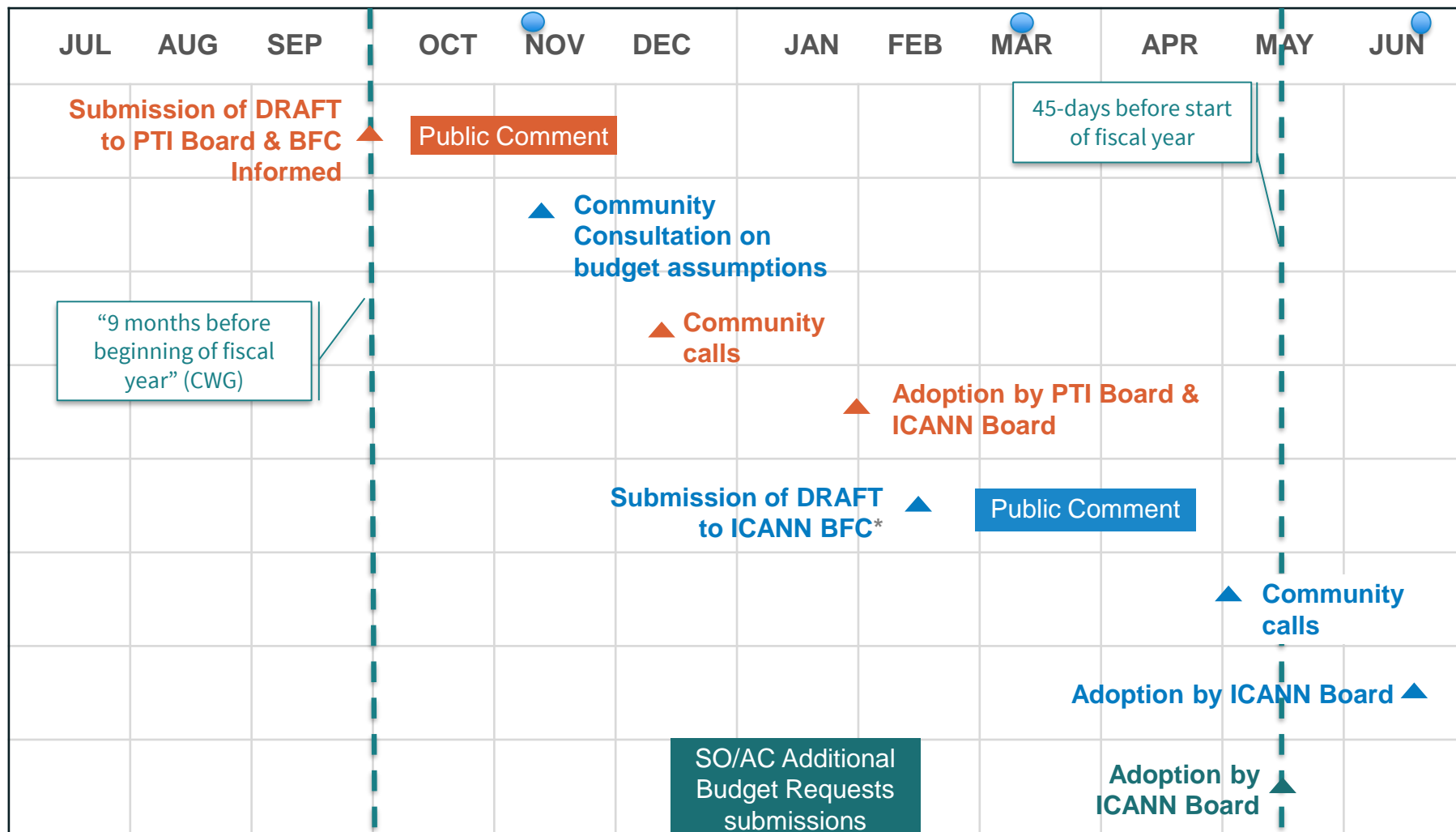
- ⦿ We will use ICANN's Public Comment process to engage with the multistakeholder community during the development of all FY18 Operating Plans and Budgets
- ⦿ This includes:
 - ⦿ Engage on the planning process and calendar (this webinar)
 - ⦿ Post drafts for Public Comment
 - ⦿ Engage with the multistakeholder community at both ICANN meetings
 - ⦿ Hold calls with the community after comments are submitted to better understand them
 - ⦿ Publish a Report on Public Comments, responding to the detailed comments anticipated
