Stephanie Perrin: (11:36) Both Data protection law and copyright law are impacted by cases, we need the important cases flagged for both as Erika has noted.

Marc Trachtenberg: (11:37) These cases are specific to the law of a particular country. I personallly don't think that the contemplated resource should reach that level

Tapani Tarvainen: (11:40) There are not all that many radically different data protection regimes. In particular EU data protection cases are relevant to the entire EU, and de facto also to a number of other countries that've followed EU lead there.

Stephanie Perrin: (11:53) The issue that Phil just raised strikes me as a very undesireable precedent.

Greg Shatan: (12:01) ICANN Expected Standards of Behavior, Bullet Point 7: Work to build consensus with other stakeholders in order to find solutions to the issues that fall within the areas of ICANN's responsibility. The ICANN model is based on a bottom-up, consensus driven approach to policy development. Those who take part in the ICANN process must take responsibility for ensuring the success of the model by trying to build consensus with other participants.

Ozan Sahin: (12:04) Klaus is on the mic now

Stephanie Perrin: (12:10) Klaus just said he did not know, up until 10 minutes ago, what he was doing here. I actually think this discussion on the need for IP training was a productive use of people's time, so I am curious as to why he said that. I don't think most of the folks around the table could pass a multiple choice quiz on IP law at beginners level, ditto for DP law, so if folks don;t think we have a problem, I would like someone to explain how we get people to contribute usefully to PDP discussions if they walk in tabula rasa. This is a hard problem, we need to tackle it, yes we need balanced teaching materials, but it strikes to the heart of the efficacy of the MS model. We cannot be the blind leading the blind.
