Poncelet Ileleji: Concurred Tapani

Farzaneh Badii: Hi, please consider our day jobs as well. I can't take so much time off and travel so many times.

Tapani Tarvainen: +1 Klaus. There'll never be really enough time, unlikely to be more at any other time...

Chris Wilson: Can I ask for all: Why such strong preference for doing the intersessional early in the year?

Klaus Stoll: Please consider also that there are a number of others IG meetings in Mai/June like WSIS

Farzaneh Badii: I agree Chris. what's the rush

Tapani Tarvainen: Early in the year would be useful for newly-elected ECs to meet physically for the first time before meeting A.

Chris Wilson: Thanks, for feedback Ed

Tapani Tarvainen: For visa concerns, the longer time between main meetings before and after the better

Farzaneh Badii: Actually Tapani new EC members need to get familiar with their tasks a bit and then attend intersessional. it will be a better meeting as well if they know what they are doing on EC.

Tony Holmes: either side of copenhagen would be impossible for isps

Edward Morris: Good point Tapani

Tony Holmes: February appears to offer the least number of clashes with othe Int Gov, RIR and IETF etc

Edward Morris: Agreed Tony

Farzaneh Badii: trade off in my favor would be good :)))

Farzaneh Badii: what I said was a joke Rob, you don't have to read it!:)

RobH: Sorry Farzaneh! :-)

Klaus Stoll: How can we come to a decission here. Looks like we are going in circles

Greg Shatan: Spiral up, I hope...

Poncelet Ileleji: Agreed @Rafik same applies to me

Poncelet Ileleji: I suppose Iceland is part of SChegen right

Tapani Tarvainen: Iceland is part of Schengen

Tapani Tarvainen: and as I said, in many places Denmark embassy handles also Iceland visas, so it might be possible to apply for both at the same time

Greg Shatan: in Barcelona.

Edward Morris: Feb. 13 has my support

Rafik: abu dhabi?

Greg Shatan: Companion tickets for Valentine's Day?

Chris Wilson: When is the Board meeting this year?

Tony Holmes: when we get to location we need to consider staff availability

Tony Holmes: 6 weeks is ample time for prep

Tapani Tarvainen: +1 Tony. If there's more time ppl won't start preparing earlier anyway

Edward Morris: Agree with Tony

Greg Shatan: It depends what we mean by "prep." If we're just setting an agenda, 6 is fine.

Greg Shatan: But if we want to lay some real groundwork, it's not enough.

Tony Holmes: agree a longer term plan makes a lot of sense but we need all to buy-in to future meetings to do that from comments made, i don't think we have that?

Rafik: yes 6 weeks in abstract looks fine, in practice not :)

Edward Morris: One proposal will be to tack our meeting on either side of the GDD toperhaps allow for interaction with the CPH for a day or so.

Edward Morris: Thanks Rob
