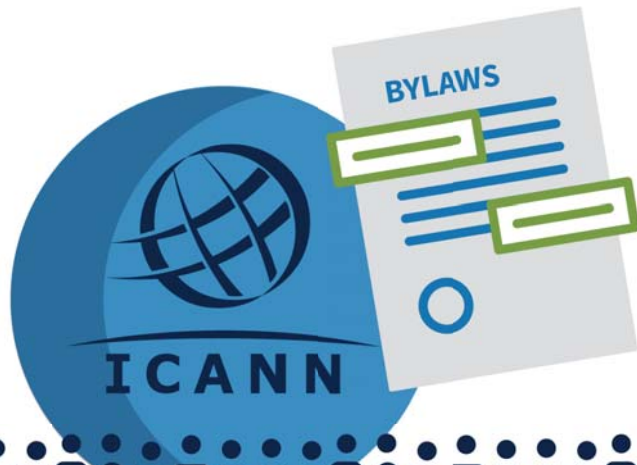

**1 IMPLEMENTATION**  
How well has ICANN implemented the prior Review's recommendations?

**2 COMPLIANCE**  
Is WHOIS contact information accurate?

**3 CONFLICTS**  
How can ICANN address data protection and privacy in a directory service?

# Focus of the RDS/WHOIS Review



Understand current RDS/WHOIS Policy



Scrutinize WHOIS data collection



Identify Gaps

- ICANN's management of WHOIS
- Contract enforcement



Recommend Improvements

- Improving the current RDS/WHOIS



Examine Past Reviews

- Were the previous recommendations implemented?
- Did this make things better?

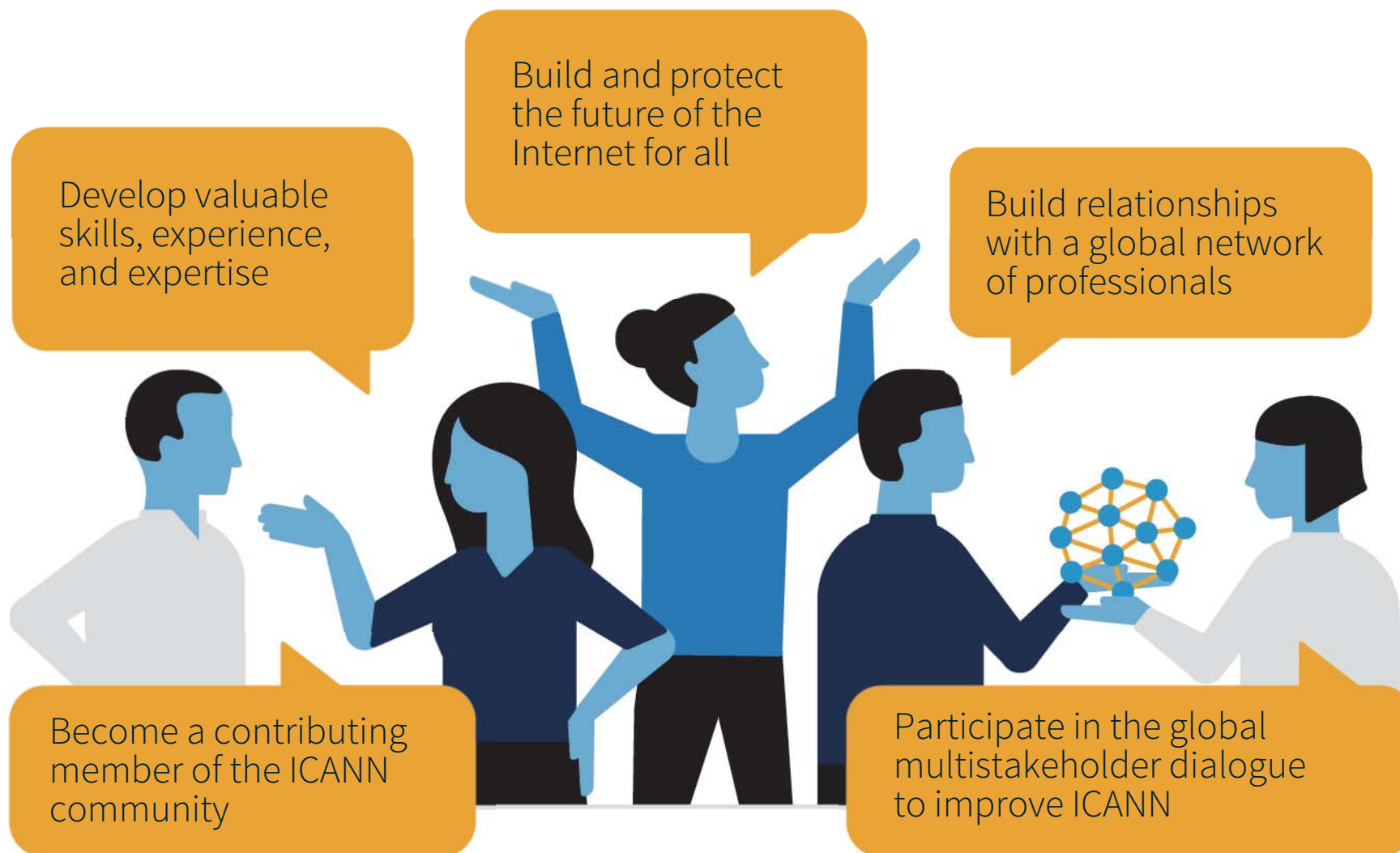

# What Are Review Team Member Responsibilities?

1

## Plan Review

Develop scope, key questions, and project plan



2

## Execute Review

Conduct research, develop fact-based findings, and prepare draft report



3

## Gather Feedback

Seek public feedback and consult subject matter experts



4

## Prepare Report

Finalize reports with recommendations to achieve measurable outcomes



5

## Deliver Final Report

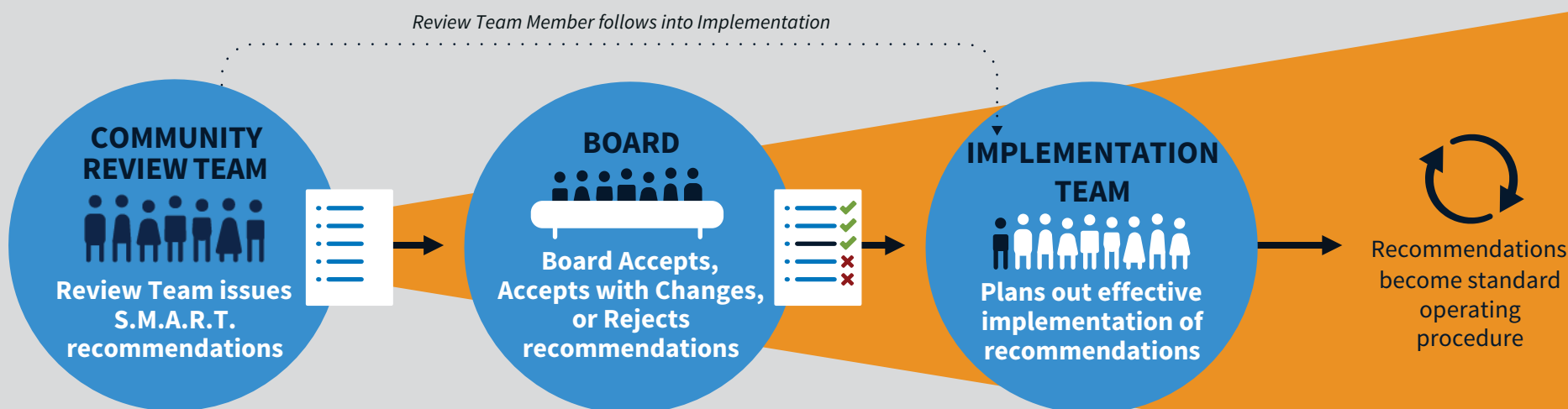
Provide recommendations for Board consideration

# Your Individual Commitment and Responsibility



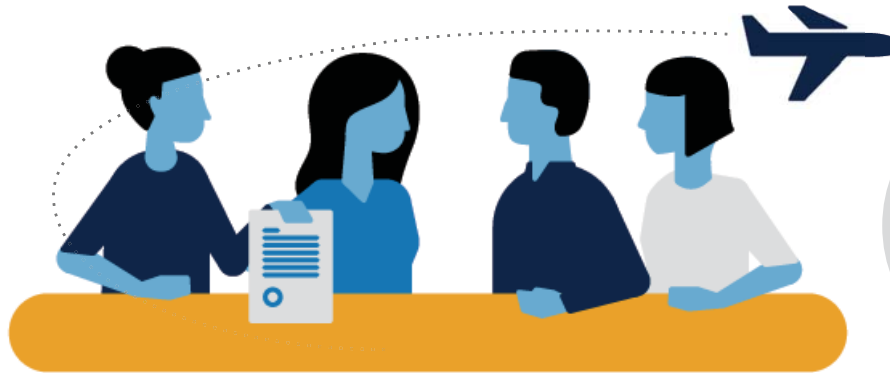
Each team member has an individual responsibility for an effective Review

Note: this timeline may shorten to six months if the scope of the RDS review is limited



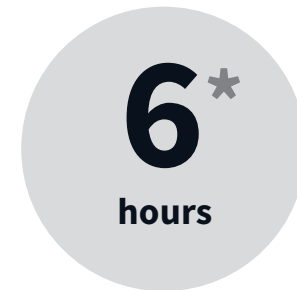
Weekly 2- to 3-hour conference calls

Plus additional conference calls as needed



Several face-to-face team meetings

Travel support is available to team members



Total time requirement per week

# General Knowledge & Skills Needed



- Commitment and time to participate
- Team spirit, consensus-seeking attitude
- Willingness to learn
- Readiness to contribute
- Objectivity—put aside personal opinions
- Analytical skills
- Capacity to draw fact-based conclusions
- Good communication skills using multiple methods and tools



# Specific Knowledge & Expertise Needed



- Prior member of the 1<sup>st</sup> WHOIS Review Team or was an active contributor to its work
- Prior member of the Expert Working Group on gTLD Directory Services
- Operation of the Domain Name System (DNS)
- WHOIS registrant data collection, compliance, directory services (RDDS) management
- Translation and Transliteration of WHOIS Contact Information
- ICANN Procedure for Handling WHOIS Conflicts with Privacy Law
- Understanding of malware and abuse vectors and mitigations, including cybercrime
- WHOIS Data Retention Waiver Process

# RDS/WHOIS Review Dates and Deadlines

# Selection of the RDS/WHOIS Review Team

SO/AC Leadership will select representatives for the Registration Directory Service Review Team according to expertise and diversity (gender and geographic).



- 1 ICANN issues the call for volunteers
- 2 Interested candidates apply
- 3 ICANN forwards applications to relevant SO/ACs
- 4 SO/ACs use their own process, aided by scorecard and relevant selection criteria; provide a list of no more than 7 candidates to SO/AC Chairs
- 5 SO/AC Chairs select up to 21 candidates and publish list
