Carlton Samuels: (08:25) Then add a qunatifification number, I suggest a range, because we decided we wiull be fact based!

Jordyn A Buchanan: (08:26) Yes, Carlton--I'll try to extrapolate from the TMCH study.

Waudo: (08:30) could we have some standardization regarding to whom the recommendations are addressed? e.g. ICANN community appears not targetted enough to me

Jonathan Zuck: (08:30) subsequent procedures wg, perhaps Waudo?

Waudo: (08:30) Ok. Just seen down its actually to the PDP - sorry

Jamie Hedlund: (08:31) Apologies for the delayed response on Drew's paper. There's one sentence and associated fn that I don't think is accurate: "However, ICANN compliance does not monitor registry procedures for handling complaints." Contractual Compliance responds to complaints but it also takes proactive measures to ensure compliance with the agreements' obligations. While we do not have real-time monitoring of compliance with these obligations, we do more than just wait for complaints. Recommend deleting this sentence and associated fn. Thanks.

Jonathan Zuck: (08:34) Thanks Jamie. Drew said he was going to provide more context or specificity for this assertion so let's make sure THAT conversation happens.

Kaili Kan: (08:34) David's voice is faint and choppy

Carlton Samuels: (08:35) Yes, difficult to hear David

Laureen: (08:35) @Jaime and Drew re: DNS Abuse paper: Rather than deleting, I recommend briefly providing the further context identified by Jamie.

Jonathan Zuck: (08:35) Duplication expressed as a percentage of portfolio somehow?

David Taylor: (08:36) apologies for my faint and choppy voice.

Kaili Kan: (08:38) @Jordyn Please stop at where you want us to read. Thank you.

Jonathan Zuck: (08:38) I agree with that. Sorry to be lazy. I guess my laziness is a bit interim waiting on the report

Jordyn A Buchanan: (08:39) Jonathan, I don't think this characterization is going to get easier by waiting.

Jordyn A Buchanan: (08:40) We have a pretty good set of facts here, we're struggling to figure out how to characterize them and I'm not sure new data is going to significantly inform the discussion.

Jonathan Zuck: (08:40) Perhaps soething like "While defensive registration remains a problem, faced particularly by those with larger portfolios, it does appear as though the incidence of defensive registration is not as significant as orginally feared."

Jordyn A Buchanan: (08:41) Jonathan, I don't mind that language but then we need a reference to the original fears probably.

Jonathan Zuck: (08:41) true

Jonathan Zuck: (08:42) the "more data" is about distribution of costs rather than really being new data on defensive registrations. I don't mind chracterizing the data on defensive registrations if we provide the context that the money might be going elsewhere

Carlton Samuels: (08:43) @Jonathan: +1. I could go with this appraoch. it frames the issue with the facts and leave it for analysis

Carlton Samuels: (08:45) @Jonathan: I love that phrase "the distribution of defensive costs"!

Carlton Samuels: (08:46) Work that in the discussion please Jordyn

Jonathan Zuck: (08:48) agree

Carlton Samuels: (08:48) @Jordyn: Aye with making all the known costs visible, again for establishing an framework for ongoing analysis

Jamie Hedlund: (08:50) @Laureen: what do you mean by the statement that ICANN does not monitor registry procedures for handling complaints? On its face, it is simply not true.

Jonathan Zuck: (08:54) Jordyn, I believe Sony testified a pretty large number for future costs Laureen: (08:54) @ Jamie and Drew: We should have an off-line discussion to clarify this issue.

Carlton Samuels: (08:56) This from a request to ICANN Comppliance "ICANN Contractual Compliance enforces compliance with Specifications 11 and 12, where applicable and also enforces compliance of registry operator's RRAs when it is presented with an RRA. Please note that the registry operators are not required to provide ICANN with the RRA unless it is requested in connection with a complaince review or audit, or the registry operator has requested approval of a RRA amendment. For example, ROs must also comply with Section 2.18 of the Registry Agreement, requiring registrant consent for a registrar's collection and use of Personal Data, as well as the RO's protection of such data."

Jamie Hedlund: (09:03) Thanks, Carlton. Audits are one means of monitoring registry compliance with contractual obligations.

Carlton Samuels: (09:04) Some of us fought hard for a specific remedy in policy for so-called local marks because we thought the costs to them might be onerous. We got the TMCH which offers much more than traditional appraach to IP law. But it largely left 'local marks' out in the cold

Jamie Hedlund: (09:04) So the statement that Compliance does not monitor is not correct.
