How to complete your application:

- 1. This application form is divided in 4 main sections:
 - Applicant Information

 - Skills
 - Motivation for serving on the Review Team
- 2. All sections of each form need to be filled in by the applicant. If given criteria (e.g. expertise) does not apply to the applicant, (s)he will leave the box empty.
- 3. Once the applicant has completed the form, (s)he will save it on his or her computer/tablet/smartphone.
- 4. The applicant will create a new email message addressed to reviews@icann.org, attach the form which (s)he previously saved and submit their application for consideration.
- 5. The applicant shall submit his or her application before **2 June 2017**, **23:59 UTC**.

In this time whilst developing a number of key skill sets and leadership qualities in general, I was part of the State and then later National team of Staff Officers who trained, certified and recertified skill sets, ran Non Commissioned Officer and Officer Schools and managed deployments of our uniformed volunteers both lay and professional (Medical Doctors, Nurses, Paramedics, Advanced trained First Responders etc.,) I was also in charge of the design and development of not only unique bespoke training materials and methods as a part of these roles, but my primary purpose and projects was in the field of performance standards development, performance measurements, assessments and audits. As well as the development and deployment of process and continuous quality improvement programs.

As a passionate believer in the importance of assessment, review, reconsider and reengineering cycles as a foundation for successful and robust individual and organisational ongoing growth and development.
