How to complete your application:

- 1. This application form is divided in 4 main sections:
 - Applicant Information
 - Expertise
 - Skills
 - Motivation for serving on the Review Team
- 2. All sections of each form need to be filled in by the applicant. If given criteria (e.g. expertise) does not apply to the applicant, (s)he will leave the box empty.
- 3. Once the applicant has completed the form, (s)he will save it on his or her computer/tablet/smartphone.
- 4. The applicant will create a new email message addressed to reviews@icann.org, attach the form which (s)he previously saved and submit their application for consideration.
- 5. The applicant shall submit his or her application before **2 June 2017**, **23:59 UTC**.
