#### REQUEST DESCRIPTION

#### 1. Activity: Please describe your proposed activity in detail

For many years the SSAC has produced and provided a workshop on security and stability issues at the Internet Governance Forum (IGF) based on an SSAC work product such as report or advisory. Each year the SSAC asked for funding for an SSAC member to travel to the IGF to support this workshop. However, for FY18, the SSAC is taking a different approach: 1) SSAC will select a high interest topic based on an SSAC work product; 2) SSAC will identify an outreach venue (that might not be include the IGF) for which the topic will be of high interest to that community; 3) SSAC will propose a presentation of the selected topic to the venue. In this special budget request the SSAC is requesting that ICANN should cover the travel and related expenses for one person from the SSAC to produce and present at the venue, which will be identified early in calendar year 2017. Assistance is requested from Finance to identify the budget estimate.
